4. Project/Program Description

Protection of critical assets. The wastewater plant facilities had severe flooding due to Hurricane Ian and the rise of the Peace River. Funds are needed to seek contractual preliminary engineering design services to analyze the elements and components needed for a protective berm/wall to prevent water infiltrating into the wastewater facilities. Army Corp. conducted an on-site evaluation and determined constructing a protective wall around the plant is the appropriate course of action.

a. What specific purpose or goal will be achieved by the funds requested?



Goal is completion of the preliminary engineering design that would allow the protection wall/berm project to move forward with the construction process based on the on-site evaluation conducted by U.S. Army Corps of Engineers post Hurricane Ian. This is the initial step in protecting life, health and safety, and critical assets that serve the City of Bartow, the City of Eagle Lake and Polk County with wastewater services.

b. What activities and services will be provided to meet the intended purpose of these funds?

Seek contractual engineering services to study and analyze protection of the wastewater plant facility from flooding during storm events through the City's procurement process.

c. What direct services will be provided to citizens by the appropriation project?

Protection and prevention of flooding of the wastewater plant facility keeps pollutants from infiltrating to the surface and ground waters and the environment, which protects life, health, safety of the community, citizens, County and State government operations, homes and property throughout the community.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is the City of Bartow, which serves as the County seat for Regional, Federal and State offices, agencies, properties and buildings, which are tax exempt creating a reduction of revenue that is needed to adequately serve its citizenry; and surrounding communities - Clear Springs Developments, the City of Eagle lake, and the Polk State College Advanced Technology Center Campus. More than 19,477 individuals to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protection of life, health and safety and of essential critical assets of wastewater plant facilities from flooding improves and protects the general public from harm by preventing sewage infiltrating into dwellings, the surface, groundwater, the environment and the Peace River Estuary.
