#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

KKI programs are designed to effectively address the specific psychosocial, academic, cultural, and emotional needs of our Haitian American community here in South Florida. Our goals are to develop strength, courage, confidence, communication skills, and decrease self harming behaviors through our youth counseling and drug awareness program.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

KKI often conducts activities where families and youths can feel comfortable opening up to someone about daily struggles, adjusting to the community, language barrier, and even mental health awareness. We often provide essentials to families in need, promote emotional health, increase positive factors and decrease risk taking behaviors by educating them in domestic violence, juvenile delinquency, and youth drug awareness.

#### c. What direct services will be provided to citizens by the appropriation project?

Some of our direct services include life coaching and family counselors that provide emotional health and youth drug awareness, as well as juvenile delinquency assistance.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by this project are less fortunate Haitian American families, and challenged youths. An estimate of eight hundred families and youth are expected to be served with the funding provided to us, as we have previously assisted a great deal of families in the past. Programs that include trauma based interventions have demonstrated much success with teens. The study of adverse childhood experiences and their negative repercussions on adult health outcomes is well documented. Trauma from a Child's Household Environment can be caused by: racial isolation; substance abuse; parental separation or divorce; single parent household; hence, our targets.

#### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

1. Decrease in negative behaviors and increase in positive behaviors and decisioning, as measured by school, parents and self report on the non-clinical pre/post screening assessment tools.

2. Diverting youth from the Criminal Justice System, as measured by The Protective Factors Survey, a self-administered pre/post evaluation tool. The instrument measures protective factors in five areas: (1) family functioning/resiliency; (2) social emotional support; (3) concrete support; (4) nurturing and attachment; and (5) knowledge of parenting/child development.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If the program is not implemented, Kreole Kamp Inc will refund the monies allocated.
