4. Project/Program Description

To improve response times for emergency rescue calls in South Tampa, Tampa Fire Rescue would like to add an additional rescue unit that will operate out of Station #19 in Port Tampa City. Station #19 is a dedicated Marine Station which responds to emergency calls including water rescue in the Tampa Bay area. Recent population growth in the area has resulted in an increase in emergency calls for the area South of Gandy, and the geographic distance makes it difficult to route units from other stations in a timely manner if calls are received at the same time. Funding for this unit will cover costs related to outfitting a specialized rescue transport vehicle with lifesaving equipment including water rescue dive equipment, marine technology, advance life support equipment, power load stretcher, tow technology for personal rescue watercraft, and the unit will be staffed by two to three certified paramedics. The paramedics will be trained in dive and water-related injuries.

The goal of this expenditure is to reduce emergency response times in South Tampa.

b. What activities and services will be provided to meet the intended purpose of these funds?

Response to emergency calls requiring paramedics, including water rescues. Paramedics will be trained in dive and water-related injuries.

c. What direct services will be provided to citizens by the appropriation project?

Lifesaving emergency response.

d. Who is the target population served by this project? How many individuals are expected to be served?

This response team will primarily serve the 33611 and 33616 zip codes, with a population of 48,426 individuals. The marine unit will launch out of Port Tampa City and will serve boaters on Tampa Bay.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Tampa Fire Rescue measures the response time between all calls and when responders arrive on the scene, which helps identify where additional resources should be located. The expected outcome is an improved response time for all calls in this geographic region.
