**Veterans' Long Term Care Facilities Admissions;** Revising eligibility for residency in the Veteran's Domiciliary Home of Florida to include specified individuals; revising the definition of “resident”; revising the admission eligibility for veterans' nursing homes to include specified individuals, etc. Effective Date: 07/01/2024

**Disclosure of Grand Jury Testimony;** Revising the list of persons prohibited from disclosing the testimony of a witness examined before, or the evidence received by, a grand jury; creating an exception for a request by the media or an interested person to the prohibited publishing, broadcasting, disclosing, divulging, or communicating of any testimony of a witness examined before the grand jury, or the content, gist, or import thereof; providing criminal penalties, etc. Effective Date: 07/01/2024

**Equitable Distribution of Marital Assets and Liabilities;** Requiring a court to consider certain factors when determining if extraordinary circumstances exist; prohibiting certain interspousal gifts unless certain requirements are met; providing that certain actions do not change whether certain real property is marital property; providing that business interest in a closely held business is a marital asset, etc. Effective Date: 07/01/2024
