### SB 480 (SO) by Senator DiCeglie—

**Renewable Natural Gas;** Authorizing a public utility to recover prudently incurred renewable natural gas infrastructure project costs through an appropriate Florida Public Service Commission cost-recovery mechanism; specifying eligible renewable natural gas infrastructure projects; revising the required contents of a basin management action plan for an Outstanding Florida Spring to include identification of certain water quality improvement projects; encouraging counties and municipalities to develop regional solutions to certain energy issues; authorizing the farm-to-fuel initiative to address the production and capture of renewable natural gas, etc. Effective Date: 07/01/2024

**Offenses Involving Children;** Increasing the maximum age of a child victim of specified acts whose out-of-court statements may be admissible in certain circumstances; providing that a first offense of specified sex trafficking offenses involving minors requires designation of the defendant as a sexual predator, etc. Effective Date: 07/01/2024

### SB 174 (SO) by Senator Burgess and others—

**Veterans' Long Term Care Facilities Admissions;** Revising eligibility for residency in the Veteran's Domiciliary Home of Florida to include specified individuals; revising the definition of “resident”; revising the admission eligibility for veterans' nursing homes to include specified individuals, etc. Effective Date: 07/01/2024

**Disclosure of Grand Jury Testimony;** Revising the list of persons prohibited from disclosing the testimony of a witness examined before, or the evidence received by, a grand jury; creating an exception for a request by the media or an interested person to the prohibited publishing, broadcasting, disclosing, divulging, or communicating of any testimony of a witness examined before the grand jury, or the content, gist, or import thereof; providing criminal penalties, etc. Effective Date: 07/01/2024

### SB 534 (SO) by Senator Grall—

**Equitable Distribution of Marital Assets and Liabilities;** Requiring a court to consider certain factors when determining if extraordinary circumstances exist; prohibiting certain interspousal gifts unless certain requirements are met; providing that certain actions do not change whether certain real property is marital property; providing that business interest in a closely held business is a marital asset, etc. Effective Date: 07/01/2024

### CS/CS/SB 988 (SO) by the Committees on Rules, Banking and Insurance and Senator Martin—

**Public Records/My Safe Florida Home Program;** Providing an exemption from public records requirements for certain information contained in applications and home inspection reports submitted by applicants to the Department of Financial Services as a part of the My Safe Florida Home Program; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: Upon becoming a law

### CS/CS/SB 1136 (SO) by the Committees on Rules, Community Affairs and Senator Trumbull—

**Regulation of Water Resources;** Revising the qualification requirements a person must meet in order to take the water well contractor license examination; authorizing certain authorities who have been delegated enforcement powers by water management districts to apply disciplinary guidelines adopted by the districts; prohibiting a person or business entity from advertising water well drilling or construction services in specified circumstances; providing that the Department of Environmental Protection's variance review and advisory committee is not responsible for reviewing water well permitting, etc. Effective Date: 07/01/2024

**CS/SB 554 (SO) by the Committee on Rules, Senator Bradley and others—**

**Hot Car Death Prevention;** Citing this act as "Ariya's Act"; designating the month of April as "Hot Car Death Prevention Month"; providing that certain agencies and local governments are encouraged to sponsor events for a specified purpose, etc. Effective Date: Upon becoming a law

**SB 648 (SO) by Senator DiCeglie—**

**License or Permit to Operate a Vehicle for Hire;** Providing that a person who holds a license or permit issued by a county or municipality to operate a vehicle for hire may operate a vehicle for hire in any other county or municipality without being subject to certain requirements or fees under certain circumstances; providing an exception for transportation services to and from an airport; defining the term "airport", etc. Effective Date: 07/01/2024

**SB 832 (SO) by Senator Calatayud—**

**Employment of Individuals with Disabilities;** Requiring the collection and sharing of data between multiple agencies for the interagency cooperative agreement under the Employment First Act; requiring the Office of Reimagining Education and Career Help to issue an annual statewide report by a specified date each year, etc. Effective Date: 07/01/2024

**CS/SB 580 (SO) by the Committee on Judiciary, Senator Yarborough and others—**

**Safe Exchange of Minor Children;** Citing this act as the "Cassie Carli Law"; providing requirements for a parenting plan relating to the exchange of a child; requiring the court to order the parties in a parenting plan to exchange their child at a neutral safe exchange location or at a location authorized by a supervised visitation program under certain circumstances; requiring sheriffs to designate certain areas as neutral safe exchange locations; providing immunity from civil liability, etc. Effective Date: 07/01/2024

**CS/CS/SB 632 (SO) by the Committee on Fiscal Policy, the Appropriations Committee on Agriculture, Environment, and General Government, Senator Simon and others—**

**Taking of Bears;** Citing this act as the "Self Defense Act"; providing for the taking of bears without certain penalties under specified conditions; requiring the disposal of such bears by the Fish and Wildlife Conservation Commission; prohibiting certain possession, sale, and disposal of such bears or their parts, etc. Effective Date: 07/01/2024

*Reported favorably by the Committee on Environment and Natural Resources; reported favorably as a committee substitute by the Appropriations Committee on Agriculture, Environment, and General Government; and reported favorably as a committee substitute by the Committee on Fiscal Policy*

---

**CS/SB 7044 (SO) by the Committees on Rules, and Regulated Industries (Gruters)—**

**Homeowners' Associations;** Providing requirements for certain community association managers and community association management firms; prohibiting the Regulatory Council of Community Association Managers from requiring more than a specified number of hours of continuing education annually for license renewal; requiring an association to maintain certain documents for a specified timeframe; prohibiting an association and its officers, directors, employees, and agents from using a debit card issued in the name of the association; providing criminal penalties for certain violations related to fraudulent voting activity related to association elections, etc. Effective Date: 07/01/2024

**CS/SB 1142 (SO) by the Committee on Fiscal Policy and Senator Hooper—**

**Occupational Licensing;** Requiring the Construction Industry Licensing Board within the Department of Business and Professional Regulation to issue registrations to eligible persons under certain circumstances; providing that the board is responsible for disciplining such licensees; providing for the fees for the issuance of the registrations and renewal registrations; requiring the department to provide specified license, renewal, and cancellation notices, etc. Effective Date: 07/01/2024

**Social Media Use for Minors;** Requires social media platforms to prohibit minors from creating new accounts, terminate accounts & provide additional options for termination of such accounts, use reasonable age verification methods to verify ages of account holders, & disclose specified policies & provide specified resources, measures, & disclaimers; authorizes DLA to bring actions for violations under Florida Deceptive & Unfair Trade Practices Act; provides penalties; provides for private causes of actions; provides certain social media platforms are subject to jurisdiction of state courts. Effective Date: 07/01/2024

**Surrendered Infants;** Changing the term “newborn infant” to “infant”; increasing the age at which a child is considered an infant; authorizing a parent to leave an infant with medical staff or a licensed health care professional at a hospital after the delivery of the infant, upon the parent giving a certain notification; authorizing a parent to surrender an infant by calling 911 to request that an emergency medical services provider meet the surrendering parent at a specified location, etc. Effective Date: 07/01/2024
