The Utilities Operations center will house the systems and personnel that monitor the operation of the Wastewater Water Treatment facility and Water Treatment plant along with over 200 lift stations and generators throughout the city.

This project will minimize the possibility of a utility system failures or environmentally harmful sewage spills thus protecting public health.

This project will provide a centralized, secondary means of monitoring and operating the Citys sewer pumping/lift stations, along with City's water treatment plant control systems and waste water treatment plant control systems. Physical verification will be done to confirm the SCADA systems for the various Utility facilities are operational at the new Utilities EOC.
