### 4. Project/Program Description

The Town of Lantana (Town) utilizes a potable water distribution system consisting of a piping network that covers approximately 1,800 acres or 2.8 miles. The network is made up of pipes that are between 4 and 14 inches in diameter with the majority being between 6 and 8 inches in diameter. The oldest watermains were installed in 1962 and are made of asbestos cement (AC) that were installed behind homes along utility easements. These watermains have now exceeded or are nearing the end of their useful life and need to be replaced to ensure reliable water service delivery. The Town updated its 10-year Water Supply Facilities Work Plan in 2020. Recommendations cited in this update included a very costly incremental approach to replacing the AC watermains. This will prevent water loss in the distribution system and ensure that the community maintains a safe, stable and reliable source of potable water well into the future.
