b. What activities and services will be provided to meet the intended purpose of these funds?

This project will mitigate flooding in the Midway community; the intended purpose of the funds is to perform drainage improvements, which will also improve drainage system performance and reduce maintenance needs. A design contractor has been procured for design and construction.

c. What direct services will be provided to citizens by the appropriation project?

This project would benefit the entire Midway community of 1,500 residents, an underserved portion of the overall Sanford community. Residents will experience both flood reduction and water quality improvements, reducing the severity and duration of flooding in this area. Water quality will improve through a reduction of the pollutant load.

d. Who is the target population served by this project? How many individuals are expected to be served?

The 1,500+ residents located within the Midway Community will primarily benefit from this project, however residents and businesses throughout the City of Sanford will experience improvements as a result of the new stormwater system.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

1. Improved motorist and pedestrian access during rain events; the severity and amount of floods at various locations will be measured
2. Reduced severity and duration of flooding in the area, which will improve drainage system performance and reduce future maintenance needs; the severity and amount of floods at various locations will be measured
3. Pollutant load as it travels downstream will be reduced; water quality will be monitored
