The fully restored Priest Theatre will be a community asset that will allow for a variety of uses locally to a primarily rural population offering municipal, educational, arts and cultural functions, and will serve to enrich common cultural experiences and directly impact draw to the historic downtown area and businesses.

This project would allow the historic Priest Theatre to be available to the public for cultural and arts events, pre-k through high school, and college educational events, exhibits, film screening and performances, and community educational programs and events that educate and support improving water quality and environmental conditions in a region home to the greatest concentration of springs in the world and one of the highest producing aquifers.

Methodologies to be employed will include tracking of numbers of events and individuals attending/participating through attendance logs, ticket sales, and maintaining counts of events and polling area businesses for revenue changes associated with Priest Theatre activities.
