

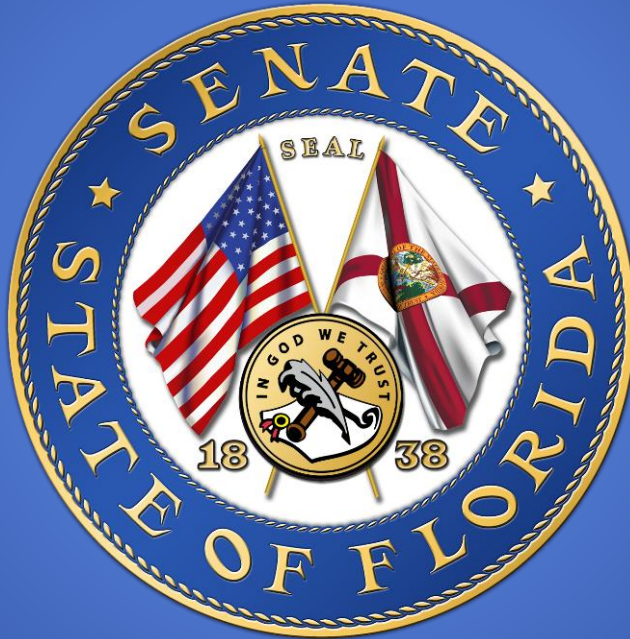

Compulsory Attendance in Florida

- All children who have attained the age of 6 years, or will attain the age of 6 years by February 1 of a school year, must attend school regularly.
- Attendance is compulsory until the child is 16.
- A child who is age 5 by September 1 is eligible to attend kindergarten, but kindergarten is not compulsory.

Section 1003.21, F.S.

- Each parent of a child within the compulsory attendance age is responsible for the child's attendance.
- Each district school board must establish an attendance policy that determines the required days of attendance and the criteria for an excused or unexcused absence.

Section 1003.24, F.S.

Enforcing School Attendance

- The school must contact the student's parent after each unexcused absence.
- The principal must refer the child to the school's child study team for a pattern of nonattendance (after 5 unexcused absences in a calendar month, or 10 unexcused absences within 90 days).
- The child study team must meet with the student's parent to identify potential remedies. If the initial meeting does not resolve the issue, the child study team must maintain frequent communication with the parent, and also:
 - Attempt to determine reasons for nonattendance and provide remedies, referrals to services, or referrals to scholarship options if the learning environment is a concern.
 - Evaluate the student for an alternative education program.
 - Implement an attendance contract.
- The child study team may refer the case to the Department of Juvenile Justice or other agencies for family services or recommend filing a truancy petition when all reasonable efforts to resolve nonattendance are exhausted.

Section 1003.26, F.S.

Addressing Truancy

- If the student continues nonattendance, the superintendent may file a truancy petition with a circuit court. The superintendent must refer a habitually truant child (15 unexcused absences in 90 days) to DJJ for services (s. 1003.26, F.S.).
- The truancy court must order the student to attend school and the parent to ensure attendance, and then may order alternative classes, parenting classes, counseling and mental or substance abuse services, state or community services, and job training (s. 984.151, F.S.).
- The district superintendent must report a minor student who is habitually truant to the DHSMV. The DHSMV may not issue a driver license or permit, or must suspend an existing license or permit, for such student (s. 1003.27, F.S.).
- Criminal prosecution against a student's parent may not begin until the school district has first made reasonable efforts and followed the statutory attendance intervention steps (s. 1003.24, F.S.), and the parent has refused to comply. The penalty is a second-misdemeanor (s. 1003.27, F.S.).

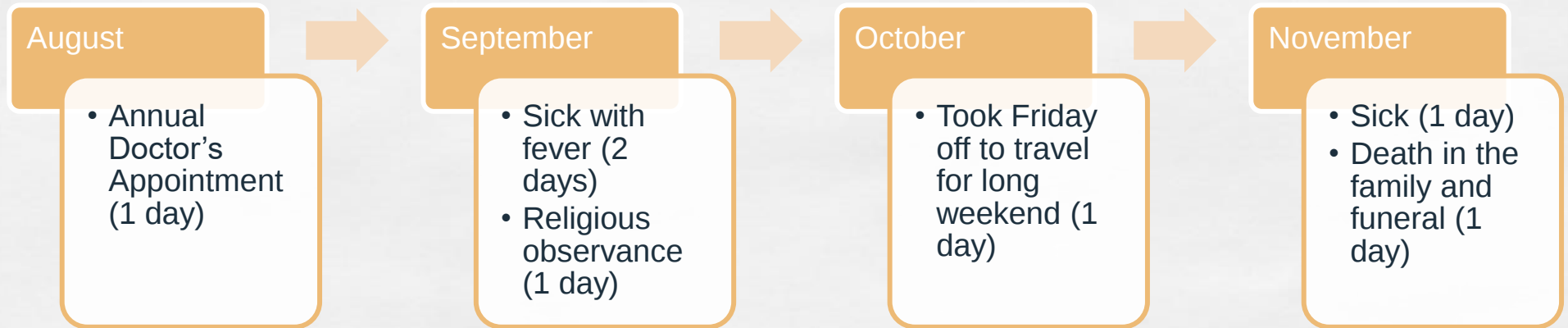

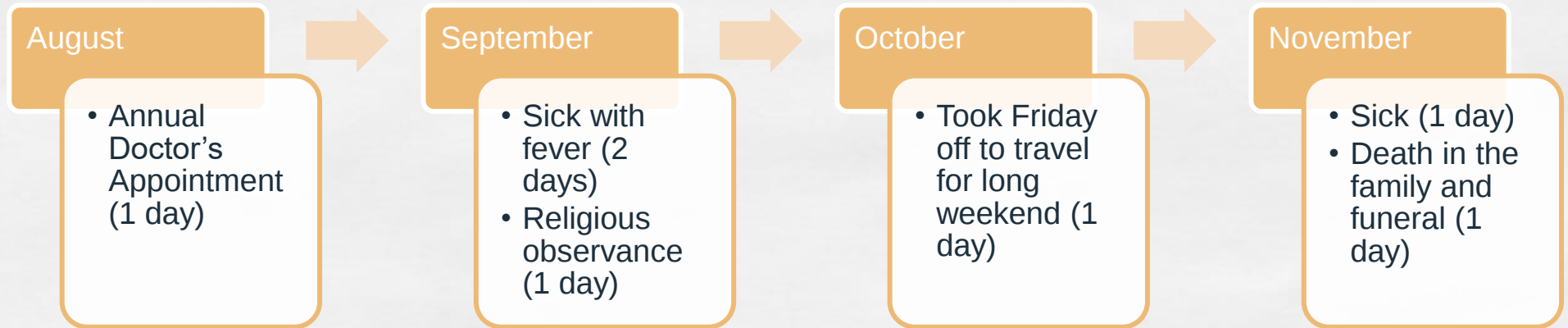

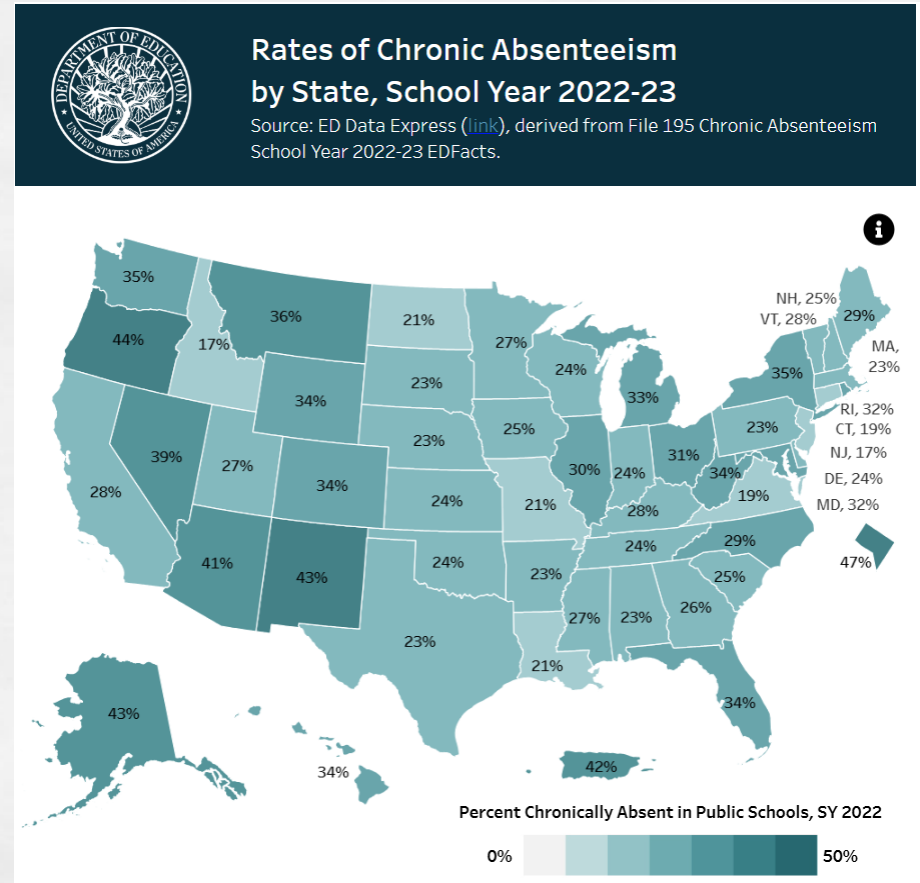

Missy is on track to be chronically absent

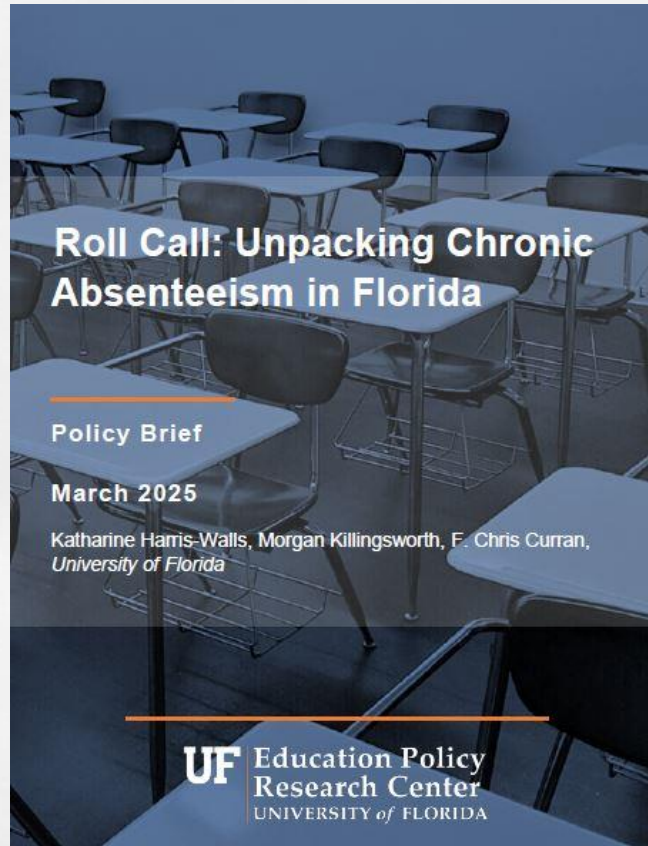
Absenteeism Nationally

- Chronic absenteeism is generally defined as missing 10% or more days of school (roughly 18 days out of a 180-day year)
- Absenteeism spiked during the pandemic
- Rates of absenteeism vary, but remain high
- FL's rates of chronic absenteeism have been among the upper half of the country

Absenteeism in FL

- How absences are measured varies across school districts in FL

Miami-Dade

- “A student is in school attendance for a full school day if the student is actually present **for at least two (2) hours of the school day...**”

Polk County

- “The student must also be present for **more than 50% of the academic day** to be counted present.”

Hillsborough County

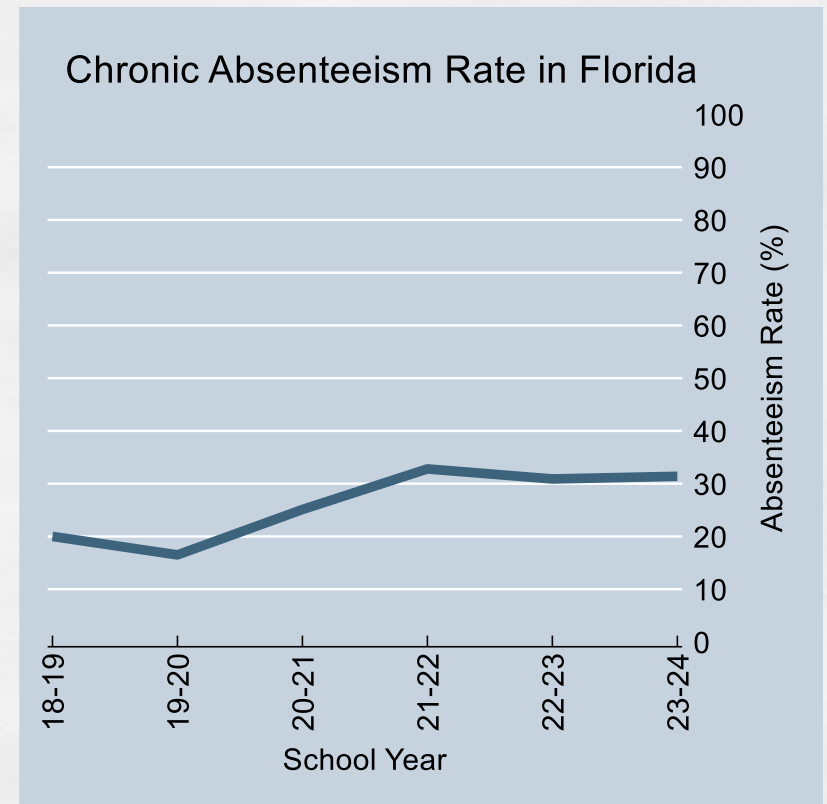
- “Elementary students in attendance for **“meaningful instruction”** during **any part of the school day** are counted present for the day.”

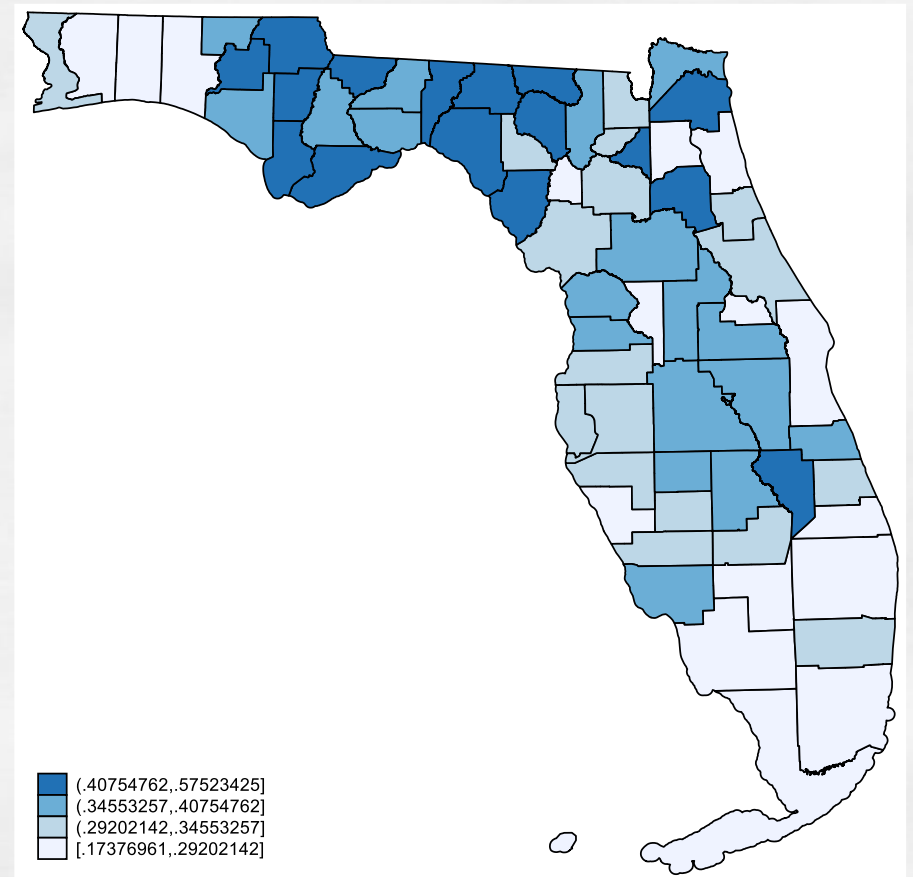
Chronically Absent

- Absenteeism rates in Florida, like the nation, have increased substantially since the pandemic.
- More than 50% higher than pre-pandemic levels.

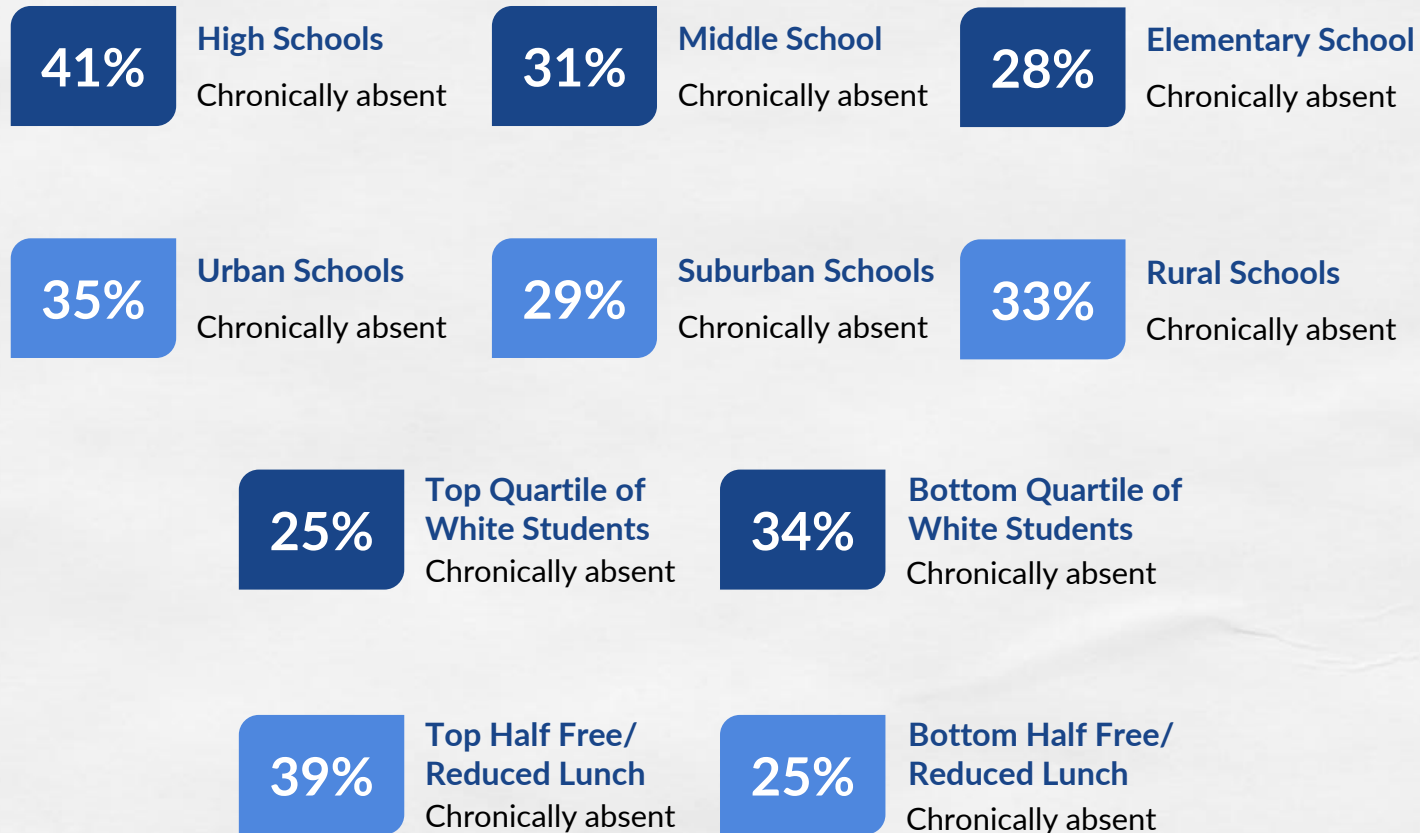


Variation Across the State

- The lowest five districts were Collier (17.4%), Santa Rosa (20.0%), Hendry (20.1%), St. Johns (20.1%), and Sarasota (20.1%)
- In contrast, the five highest districts were Putnam (57.5%), Gadsden (56%), Taylor (54.7%), Okeechobee (50.2%), and Franklin (50.2%)



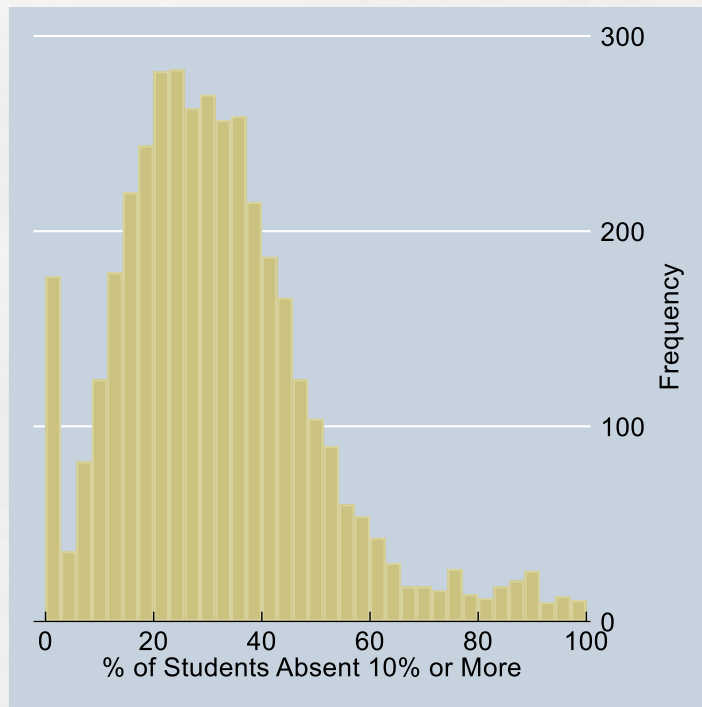
Variation Across the State



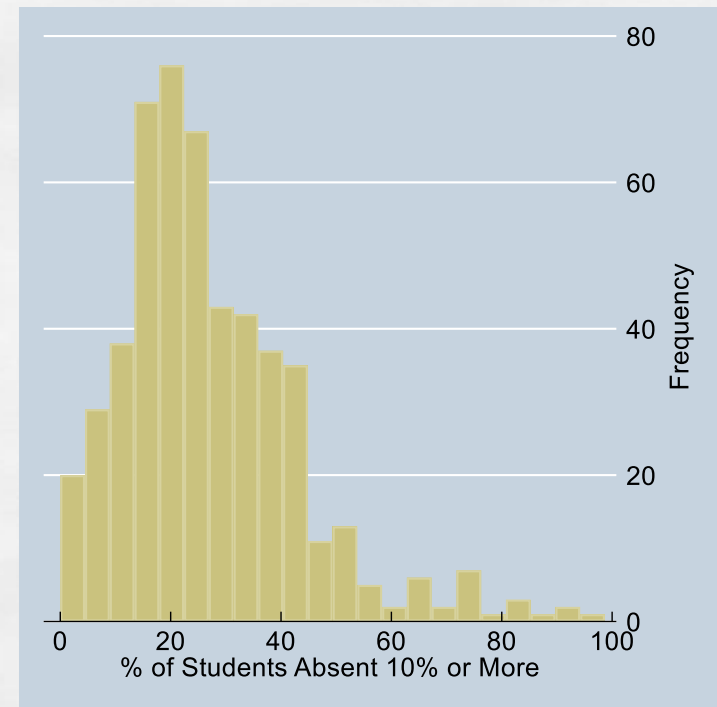
Variation Within Districts

Root Causes of Absenteeism

- Lingering COVID effects
 - Shifts in how we respond to sickness
 - Changes in how we view the necessity of regular school attendance
- Transportation challenges
- Mental health concerns
- Disengagement
- Differences between elementary and upper grades

Promising Approaches to Reduce Absenteeism

- Data-driven approaches
 - Early warning systems
- Multi-tiered response systems
 - From class and school-wide messaging and rewards to targeted interventions
- Relationships and connections
 - Check and Connect program
- Behavioral nudges
 - Text messaging and post-card interventions
- A focus on absenteeism as a symptom of other factors (health, transportation, mental well-being)

Florida Statute 1003.26 Overview

- Monitor daily attendance and identify patterns of non-attendance
- Initiate contact with parents after each unexcused absence or pattern of absences
- Schedule meetings with parents to determine the reason for absences and develop a plan for regular attendance (Multi-Tiered System of Supports)
- Implement school-based interventions (e.g., problem-solving teams, counseling, attendance contracts, referrals to support services)
- Document all interventions, contacts, and attempted remedies prior to escalating the case



Florida Statute 1003.26 Overview

- Develop an intervention plan through the team, including monitoring and support
- If non-attendance persists, schools must refer the case to the Superintendent for:
 - Truancy petition in Circuit Court
- Provide all required documentation to support the truancy petition (attendance records, parent contacts, interventions attempted)
- Continue collaborating with agencies/court until compliance improves



Florida Statute 1003.26

- CONTACT, REFER, AND ENFORCE.—

- (a) Upon each unexcused absence, or absence for which the reason is unknown, **the school principal or his or her designee must contact the student's parent to determine the reason for the absence.**
- (b) If a student has had at least five unexcused absences...within a calendar month or 10 unexcused absences...within a 90-calendar-day period...**the principal must refer the case to the school's child study team** to determine if early patterns of truancy are developing.
- (c) If the parent or child fails to attend the child study team meeting, the meeting shall be held in his or her absence, and **the child study team shall make written recommendations to remediate the truancy** based upon the information available to the school.



Florida Statute 1003.26

- CONTACT, REFER, AND ENFORCE.—

(c) The recommendations shall be provided to the parent within 7 days after the child study team meeting. **If the initial meeting does not resolve the problem, the child study team shall implement the following:**

1. Frequent attempts at communication between the teacher and the family.
2. Attempt to determine the reasons the child is truant from school and provide remedies...if the learning environment is an issue of concern.
3. Evaluation for alternative education programs.
4. Attendance contracts.

(d) The child study team must be diligent in facilitating intervention services and shall **report the case to the district school superintendent only when all reasonable efforts to resolve the nonattendance behavior are exhausted.**

When is sick too sick for school?



OK for school if...

- ▶ Clear runny nose or a little cough
- ▶ 24 hours since vomiting or diarrhea
- ▶ No fever or fever reducing medicine for 24 hours

Keep home if...

- ▶ Temperature is higher than 100°
- ▶ Vomiting or diarrhea
- ▶ Undiagnosed cough
- ▶ Pink/crusty eyes



Call the doctor if...

- ▶ Temperature higher than 100°, vomiting, or diarrhea for more than two days
- ▶ Sniffles for more than a week, and they are not getting better
- ▶ Still have asthma symptoms after using asthma medicine
- ▶ New cough that does not get better after two (2) days

FLORIDA'S ATTENDANCE LAW...

State of Florida Compulsory School Attendance Laws require all children who have attained the age of six (6) years by February 1 of any school year, or who are older than six (6) years of age but who have not attained the age of sixteen (16) years, to attend school regularly during the entire school term.

Parents failing to properly enroll or require their children to attend school regularly shall be guilty of a misdemeanor of the second degree punishable as provided in the law.

TIPS FOR PARENTS...

Did you know?

- ▶ Students should miss no more than 9 days of school each year to stay engaged, successful and on track for graduation
- ▶ By 6th grade, absenteeism is one of three signs that a student may drop out of high school
- ▶ By 9th grade, regular and high attendance is a better predictor of graduation rates than 8th grade test scores
- ▶ Students can be chronically absent even if they only miss a day or two every few weeks
- ▶ Attendance is an important life skill that will help your child graduate from college and keep a job

What You Can Do

Make school attendance a priority

- ▶ Talk about the importance of showing up to school every day, make that the exception
- ▶ Help your child maintain daily routines, such as finishing homework and getting a good night's sleep
- ▶ Try not to schedule dental and medical appointments during the school day
- ▶ Don't let your child stay home unless truly sick. Complaints of stomach aches or headaches may be signs of anxiety

Help your teen stay engaged

- ▶ Find out if your child feels engaged by his/her classes and feels safe from bullies and other threats.
- ▶ Make sure he/she is not missing class because of behavioral issues and school discipline policies. If any of these are problems, work with your school administration
- ▶ Stay on top of academic progress and seek help from teachers or tutors, if necessary. Make sure teachers know how to contact you
- ▶ Stay on top of your child's social contacts. Peer pressure can lead to skipping school, while students without many friends can feel isolated
- ▶ Encourage meaningful afterschool activities, including sports and clubs

Communicate with the school

- ▶ Know the school's attendance policy - incentives and penalties
- ▶ Talk to teachers if you notice sudden changes in behavior. These could be tied to something going on at school
- ▶ Check on your child's attendance to be sure absences are not piling up
- ▶ Ask for help from school officials, afterschool programs, other parents or community agencies if you're having trouble getting your child to school

REASONS TO STAY IN SCHOOL

Finding Work Is Easier

- ▶ You are almost twice as likely to be unemployed if you do not finish high school

You'll Earn More

- ▶ Studies show high school graduates make 60% more than dropouts

What This Means

High school graduates are:

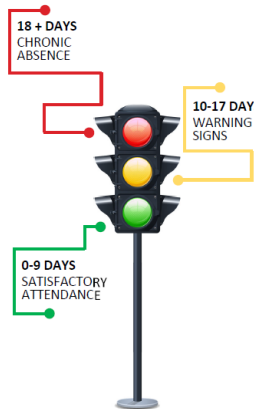
- ▶ Less likely to live at home
- ▶ More likely to be able to buy a car and rent an apartment
- ▶ Less likely to need welfare or public assistance

Less Likely To Be A Prison Inmate

- ▶ 75% of all prisoners are high school dropouts

Bottom Line- It's Your Future

- ▶ Your choices now will determine how well you live for the rest of your life

TIPS FOR PARENTS... PRE-K

Did you know?
Missing 10 percent of preschool (one or two days every few weeks) can:

- ▶ Make it harder to develop early reading skills
- ▶ Make it harder to get ready for kindergarten and first grade
- ▶ Develop a poor attendance pattern that's hard to break

What You Can Do
Talk about it – sing about it – make it an adventure!

- ▶ Set a regular bed time and morning routine
- ▶ Lay out clothes and pack backpacks the night before
- ▶ Share ideas with other parents for getting out the door on time

Before the school year starts:

- ▶ Find out what day school starts and make sure your child has the required shots

ELEMENTARY

Did you know?

- ▶ Starting in kindergarten, too many absences can cause children to fall behind in school
- ▶ Missing 10 percent (or about 18 days) can make it harder to learn to read
- ▶ Students can still fall behind if they miss just a day or two days every few weeks
- ▶ Being late to school may lead to poor attendance
- ▶ Absences can affect the whole classroom if the teacher has to slow down learning to help children catch up

What You Can Do

- ▶ Set a regular bed time and morning routine
- ▶ Lay out clothes and pack backpacks the night before
- ▶ Find out what day school starts and make sure your child has the required shots
- ▶ Don't let your child stay home unless truly sick. Keep in mind complaints of a stomach ache or headache can be a sign of anxiety and not a reason to stay home
- ▶ Avoid medical appointments and extended trips when school is in session

Call the doctor if...

- ▶ Temperature higher than 100°, vomiting, or diarrhea for more than two days
- ▶ Sniffles for more than a week, and they are not getting better
- ▶ Still have asthma symptoms after using asthma medicine
- ▶ New cough that does not get better after two (2) days

Call 911 if...

- ▶ If there is trouble breathing
- ▶ A severe allergic reaction—no emergency medication available

Social Media Posts for Parents

- Before school year begins
- Attendance awareness month (Sept.)
- Peak times (before/after breaks)



September sets the tone

Students who miss 2–4 days in September are 5x more likely to be chronically absent for the year compared to those who miss fewer than 2 days.

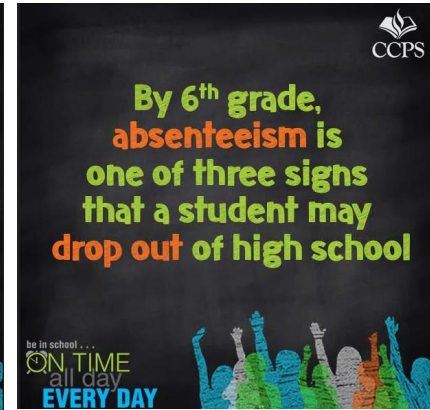
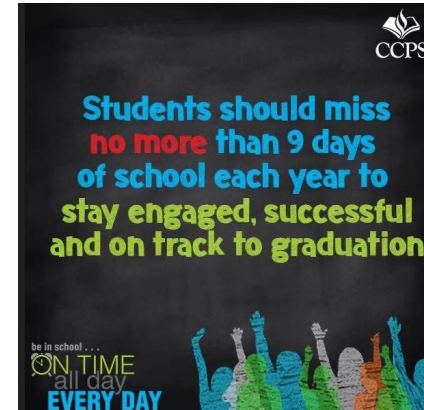

GENERAL

- Over 14.7 million (1 in 3) U.S. students miss nearly a month of school each year.
- The effects of poor attendance are particularly pronounced among low-income children. Unfortunately, 2 in 10 low-income children, 2.5 in 10 homeless children, and 4 in 10 transient children are likely to be chronically absent.
- Chronic absenteeism is about 15% less likely among English learners than non-English learners.
- Students with disabilities are almost 3 times more likely to be chronically absent than students without disabilities.
- The month of September matters. Students who missed 2 to 4 days in September were 5 times more likely to be chronically absent for the year than those who missed fewer than 2 days in September.

ELEMENTARY

- Only 17% of students who were chronically absent in kindergarten and 1st grade (18 or more days both years) can read on grade level after 3rd grade.
- Chronic absenteeism in kindergarten, and even PreK, can predict lower test scores, poor attendance, and retention in later grades.
- Chronically absent students in kindergarten and first grade are 4 times more likely to drop out in the future.
- Attending preschool matters. Students who do not attend preschool are more likely to be chronically absent in kindergarten.

SECONDARY

- By 6th grade, chronic absences becomes a leading indicator that a student will drop out of high school.
- By 9th grade, attendance can be a better indicator of dropout than 8th grade test scores.
- One year of chronic absenteeism between 8th and 12th grade can result in a seven-fold increase in the likelihood of dropping out.
- Each week of absence per semester in 9th grade is associated with a more than 20 percentage point decline in the probability of graduating from high school.
- Chronic absenteeism rates are highest in high school. Overall, almost 20 percent of students in high school are chronically absent compared to more than 14 percent of students in middle school and 14 percent in elementary school.

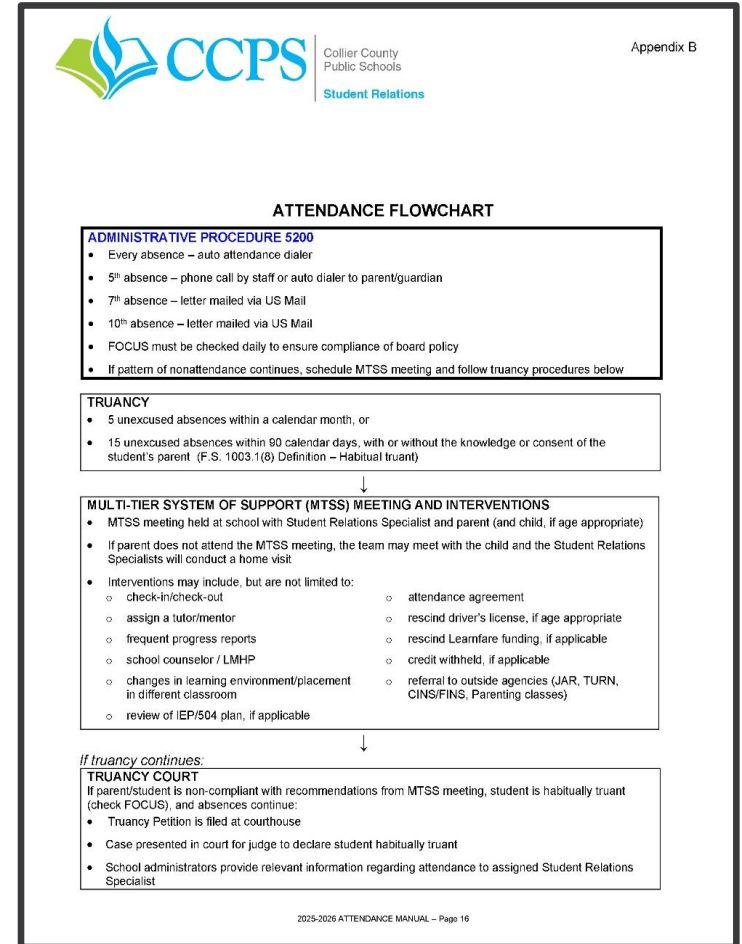

RE: Florida School Attendance Laws (F.S. 1003.01(8), 1003.21, 1003.26, 1003.27, 984.151)

Florida law states that all children who are either six years of age, who will be six years old by February 1 of any school year, or who are older than six years of age but who have not attained the age of 16 years, must attend school regularly during the entire school term.

Children failing to attend school properly will be called to the attention of the Attendance Specialist of the Collier County Public Schools, and if found to be truant or habitual truant may be referred to the Juvenile Circuit Court of Collier County and dealt with as a dependent child. Parents who do not make a legitimate effort to have their children attend school regularly are also liable for prosecution in circuit court.

Failure to comply with the Attendance Laws may result in the filing of a truancy petition, which will require both the parent and child to appear in Truancy Court. Parents failing to properly enroll or require their children to attend school regularly shall be guilty of a misdemeanor of the second degree punishable as provided in law.

1003.27(2)(a) In each case of non-enrollment or of non-attendance upon the part of a student who is required to attend some school, when no valid reason for such non-enrollment or nonattendance is found, the district school Superintendent shall institute a criminal prosecution against the student's parent.

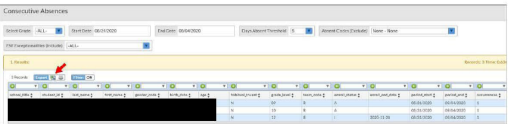

FTE WINDOW – ATTENDANCE

- Window: September 26 – October 10 (Fall)
- Window: January 23 – February 6 (Spring)
- Students must be in attendance at least 1 day during the window
- Be cognizant when assigning 10 days OSS during the FTE window, ensure at least 1 day is ISS
- Run consecutive absence report **daily** (see above) during the FTE window
 - Don't wait until FTE to start running the report
- Ensure staff call parents by day 2 – continue with phone calls each day during the window
- **Reminder** – Please ensure teachers submit attendance and continuously address the need for timely and accurate attendance taking with teachers before and during FTE
 - Reports are only accurate if teacher attendance is submitted

LUTHERAN SERVICES (LSF)

- Provide families the support they may need while also attempting to correct attendance concerns
- For students ages 6-17, submit a counseling referral when a student has at least 5 absences and any of the following:
 - Student is struggling with complicated conflicts at home or at school
 - The family is in crisis over distressing situations
 - The student exhibits truancy or is ungovernable and/or a runaway
- Counseling provided by Lutheran Services can be individual and/or family counseling
- Typically suggested for families with low income or lack of resources, and for families seeking a preventative style approach
- Not to be confused with a T.U.R.N. case staffing meeting or a CINS/FINS petition for Truancy Court
- This is a preventative approach
- Goal is to provide services to families much sooner than past practice
- Contact assigned attendance specialist or Student Relations with any questions

LSF:

- Receive LSF referral
- Assign referral to a counselor and counselor schedules an 'intake'
- If student/parent are unsuccessful, a case staffing (TURN) meeting is scheduled
- At the case staffing (TURN), the committee can decide if a CINS/FINS petition for truancy court should be filed

CCPS: Student Relations Specialists or any school administrators can file a LSF referral

- Student Relations specialists will file LSF referrals due to attendance
- School administrators can file LSF referrals due to services needed (ungovernable students)

TRUANCY COURT

- If parent/student is non-compliant with interventions/recommendations provided during the MTSS meeting and absences have continued, a Truancy Petition is filed at the courthouse
- Case presented in court for judge to declare student habitually truant
- Once students are active in Truancy Court, attendance meetings are no longer required by the school
- Once students are active in Truancy Court, Student Relations Specialists will continue to monitor attendance and communicate via phone or email with school administrators in order to report school related information back to Truancy Court

PROCEDURES FOR ABSENTEEISM (Appendix B)

A student is considered habitual truant when a child (age 6-16) has fifteen (15) unexcused absences within ninety (90) calendar days, with or without knowledge of justifiable consent of parent/guardian. (F.S. 984.03)

Student Relations Specialists work collaboratively with the schools to decrease absenteeism. For students who begin to accumulate absences, schools will adhere to the following:

- Communication
 - Auto phone dialer for every absence
 - 5th absence phone call by staff or auto dialer to parent/guardian
 - 7th and 10th absences – letter mailed via US Mail

Should attendance not improve, adhere to MTSS process:

- Discuss potential issues/concerns for the absences
- Provide interventions/recommendations for support (counseling/LMHP, parenting classes, referral to outside agencies)
- Document attendance meeting in FOCUS under the Attendance Review tab

Should attendance continue to not improve and student is habitually truant under F.S. 984.03:

- Truancy Court
 - A petition will be filed by the district
 - A court hearing in front of judge
 - Adjudication of habitual truant

MTSS ATTENDANCE MEETINGS (To be conducted by Student Relations Specialists)

PURPOSE OF ATTENDANCE MEETINGS

- To provide information to parents regarding attendance state laws and District policies and procedures in order to circumvent further truancy proceedings
- Review and obtain parent/guardian and student signatures on an Attendance Agreement

MTSS ATTENDANCE MEETING PROCESS

- Occur at the request of the school with school administrators, counselors and parents/guardians present
- Student Relations Specialists provide monthly attendance reports to school administration
- Student Relations Specialists are to meet with students only during scheduled initial attendance meetings
- Students may be pulled out of class during attendance meetings under the direction of the school administrator
- Schedule attendance meetings no more than once a month per school, if needed
- TURN Referral Forms may be submitted when the school administration is in agreement that the student/family may benefit from additional services
- Student Relations will submit TURN referral forms if needed

- Expand judicial authority by providing judges with more sanction options, allowing for more effective and timely interventions



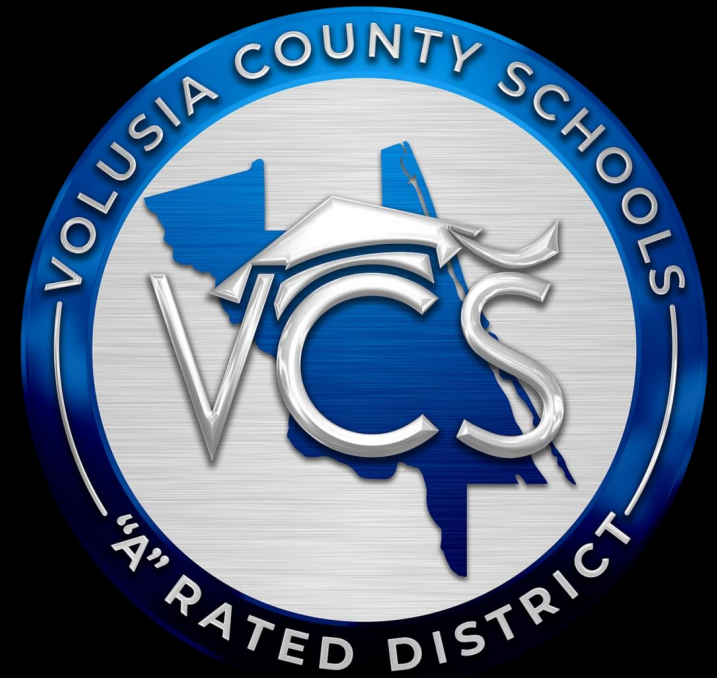

Under Dr. Balgobin's leadership, Volusia County Schools has prioritized student attendance as a critical foundation for academic success. The district's comprehensive approach combines strategic data analysis, community engagement, and innovative technology solutions to address chronic absenteeism and ensure every student has the opportunity to thrive.

YoY Chronic Absenteeism Rates: *The Challenge Ahead*

Students are considered chronically absent if they accumulate 10% or more absences during a school year. This critical threshold represents approximately 18 or more missed school days annually. The data reveals significant attendance challenges that intensified during the COVID-19 pandemic and have persisted in the post-pandemic period.

The pandemic's impact is evident in the dramatic increase from 16.2% in 2019-20 to 31.3% in 2020-21. While we've worked diligently to address these challenges, the 2023-24 chronic absenteeism rate of 34.3% demonstrates that attendance recovery requires sustained, systemic intervention. Alternative education settings face unique challenges with consistently higher rates, while online learning programs maintain notably lower chronic absenteeism percentages.

Six Strategic Pillars Driving Student Attendance

Our thorough strategy addresses absenteeism by providing early support, recognizing achievements, and resolving issues before they escalate.

Attendance Matters Campaign

The "Attendance Matters" campaign emphasizes that just 2 days absent per month equals chronic absenteeism. We deploy multilingual materials, social media outreach, and community forums. Business partnerships offer workplace flexibility for parents, with monthly awareness themes ensuring year-round momentum.

Data Analytics Dashboard

The Data Analytics Dashboard enables intelligence-driven action with real-time tracking across all schools. It provides chronic absenteeism warnings, subgroup equity analysis, and identifies seasonal trends. Mobile access empowers administrators to make data-driven decisions during home visits, targeting resources effectively.

Recognition & Incentives

Recognition & Incentives celebrate success at every level. Students earn certificates and assembly recognition. Classes compete in "March Madness" competitions, and schools win \$500 (1st place) or \$250 (2nd place) per grade level. Families receive principal letters and invitations to appreciation events, building a culture of positive reinforcement.

Automated Early Warning System

Our Automated Early Warning System provides real-time intervention. Elementary families receive notifications by 10:00 AM for absences, while secondary alerts are every period. Progressive notifications trigger at days 2, 4, 7, 9, 11, 13, and 14, with bi-weekly summaries and multilingual support.

Multi-Tiered Support System

Tier 1 (All Students): promotes a positive environment with recognition programs.

Tier 2 (5–9% Absences): includes personalized meetings and weekly check-ins.

Tier 3 (10%+ Absences): offers intensive case management, home visits, and support for transportation, health, and housing.

Community Partnerships

Community Partnerships remove barriers together. AdventHealth provides health screenings and telehealth services, plus 168 bikes for transportation. Businesses offer mentoring, job shadowing, and workplace flexibility. Faith groups deliver family support, and media partners amplify our message through PSAs, creating community-wide buy-in.

Implementation Plan

Volusia County Schools has developed a comprehensive, multi-faceted approach to combat chronic absenteeism.

Our implementation plan combines public awareness campaigns, technology-driven notification systems, robust data analytics, tiered support interventions, recognition programs, and community partnerships.

Each component works synergistically to create a culture where attendance is valued, barriers are addressed, and every student has the support needed to attend school regularly.



Public Awareness: Attendance Matters Campaign

Our district-wide "Attendance Matters" campaign educates families and communities about the critical connection between regular school attendance and academic achievement. Through multilingual materials, social media engagement, and community events, we're shifting the conversation around attendance from compliance to opportunity.

Campaign Highlights:

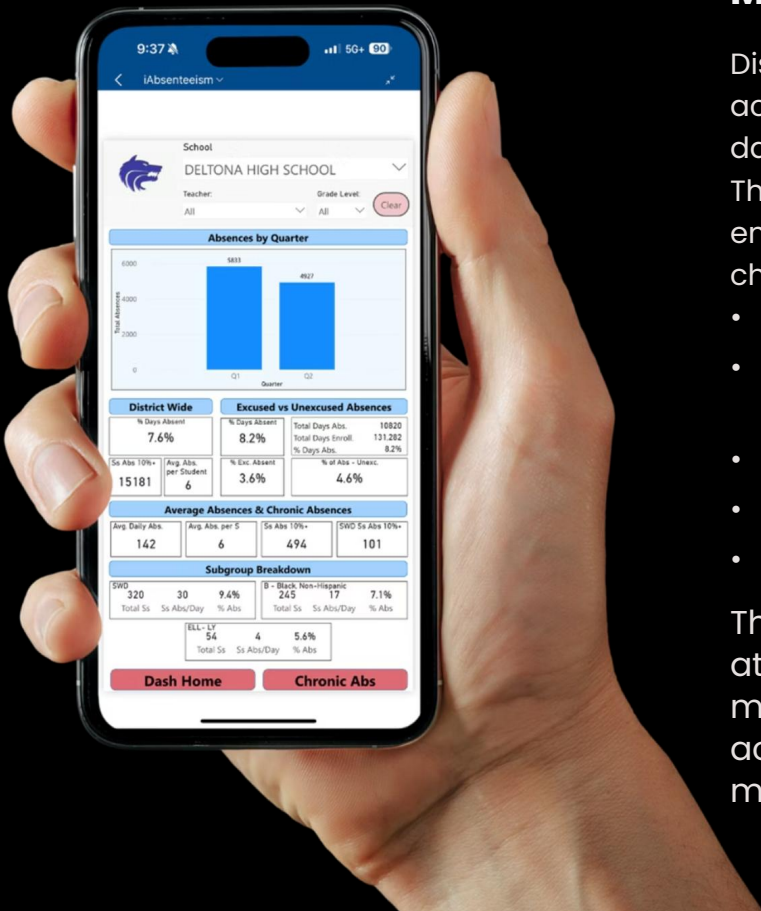

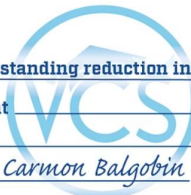

LEY DE ASISTENCIA DE FLORIDA

CONSEJOS PARA PADRES...

¿Sabía que?

- ▶ Los estudiantes no deben faltar más de 9 días a la escuela cada año para mantenerse comprometidos, exitosos y en camino a la graduación
- ▶ En 6º grado, el ausentismo es una de las tres señales de que un estudiante puede abandonar la escuela secundaria
- ▶ En el noveno grado, la asistencia regular y elevada es un mejor predictor de las tasas de graduación que los resultados de los exámenes del octavo grado

¿Qué puede hacer usted?

- ▶ Hable de la importancia de ir a la escuela todos los días, haz que faltar sea la excepción

- ▶ Trate de no programar citas de detalles o médicas durante el día de escuela

- ▶ Mantente al tanto de tu progreso académico y busca la ayuda de profesores o tutores, si es necesario. Asegúrate de que los profesores saben cómo ponerse en contacto con usted
- ▶ Esté al tanto de las relaciones sociales de su hijo. La presión de los compañeros puede llevar a faltar a la escuela, mientras que los estudiantes sin muchos amigos pueden sentirse aislados

- ▶ Fomentar actividades extraescolares significativas, incluyendo deportes y clubes

Comuníquese con la escuela

- ▶ Conozca la política de asistencia de la escuela— incentivos y penalidades
- ▶ Hable con los maestros su nota repentinos cambios de comportamiento. Esto podría estar atado a algo que esté pasando de la escuela
- ▶ Verifique la asistencia de su hijo para asegurarse de que las ausencias no se acumulen
- ▶ Pida ayuda a los administradores de la escuela, a los programas extraescolares, a otros padres o a los organismos de la comunidad si tiene problemas para llevar a su hijo a la escuela

- ▶ Vomiting or diarrhea
- ▶ Undiagnosed cough
- ▶ Pink/crusty eyes



Call the doctor if...

- ▶ Temperature higher than 100°, vomiting, or diarrhea for more than two days
- ▶ Sniffles for more than a week, and they are not getting better
- ▶ Still have asthma symptoms after using asthma medicine
- ▶ New cough that does not get better after two (2) days

FLORIDA'S ATTENDANCE LAW...

State of Florida Compulsory School Attendance Laws require all children who have attained the age of six (6) years by February 1 of any school year, or who are older than six (6) years of age but who have not attained the age of sixteen (16) years, to attend school regularly during the entire school term.

Parents failing to properly enroll or require their children to attend school regularly shall be guilty of a misdemeanor of the second degree punishable as provided in the law.

TIPS FOR PARENTS...

Did you know?

- ▶ Students should miss no more than 9 days of school each year to stay engaged, successful and on track for graduation
- ▶ By 6th grade, absenteeism is one of three signs that a student may drop out of high school
- ▶ By 9th grade, regular and high attendance is a better predictor of graduation rates than 8th grade test scores
- ▶ Students can be chronically absent even if they only miss a day or two every few weeks
- ▶ Attendance is an important life skill that will help your child graduate from college and keep a job

What You Can Do

Make school attendance a priority

- ▶ Talk about the importance of showing up to school every day, make that the exception
- ▶ Help your child maintain daily routines, such as finishing homework and getting a good night's sleep
- ▶ Try not to schedule dental and medical appointments during the school day
- ▶ Don't let your child stay home unless truly sick. Complaints of stomach aches or headaches may be signs of anxiety

Help your teen stay engaged

- ▶ Find out if your child feels engaged by his/her classes and feels safe from bullies and other threats.
- ▶ Make sure he/she is not missing class because of behavioral issues and school discipline policies. If any of these are problems, work with your school administration
- ▶ Stay on top of academic progress and seek help from teachers or tutors, if necessary. Make sure teachers know how to contact you
- ▶ Stay on top of your child's social contacts. Peer pressure can lead to skipping school, while students without many friends can feel isolated
- ▶ Encourage meaningful afterschool activities,

including sports and clubs

Communicate with the school

- ▶ Know the school's attendance policy – incentives and penalties
- ▶ Talk to teachers if you notice sudden changes in behavior. These could be tied to something going on at school
- ▶ Check on your child's attendance to be sure absences are not piling up
- ▶ Ask for help from school officials, afterschool programs, other parents or community agencies if you're having trouble getting your child to school

REASONS TO STAY IN SCHOOL

Finding Work Is Easier

- ▶ You are almost twice as likely to be unemployed if you do not finish high school

You'll Earn More

- ▶ Studies show high school graduates make 50% more than dropouts

What This Means

High school graduates are:

- ▶ Less likely to live at home
- ▶ More likely to be able to buy a car and rent an apartment
- ▶ Less likely to need welfare or public assistance

Less Likely To Be A Prison Inmate

- ▶ 75% of all prisoners are high school dropouts

- ▶ Your choices now will determine how well you live for the rest of your life

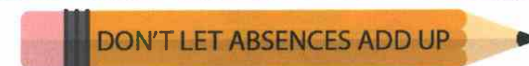

TIPS FOR PARENTS...

Did you know?

- ▶ Students should miss no more than 9 days of school each year to stay engaged, successful and on track for graduation
- ▶ By 6th grade, absenteeism is one of three signs that a student may drop out of high school
- ▶ By 9th grade, regular and high attendance is a better predictor of graduation rates than 8th grade test scores
- ▶ Students can be chronically absent even if they only miss a day or two every few weeks
- ▶ Attendance is an important life skill that will help your child graduate from college and keep a job

What You Can Do

Make school attendance a priority

- ▶ Talk about the importance of showing up to school every day, make that the exception
- ▶ Help your child maintain daily routines, such as finishing homework and getting a good night's sleep
- ▶ Try not to schedule dental and medical appointments during the school day
- ▶ Don't let your child stay home unless truly sick. Complaints of stomach aches or headaches may be signs of anxiety

Help your teen stay engaged

- ▶ Find out if your child feels engaged by his/her classes and feels safe from bullies and other threats.
- ▶ Make sure he/she is not missing class because of behavioral issues and school discipline policies. If any of these are problems, work with your school administration
- ▶ Stay on top of academic progress and seek help from teachers or tutors, if necessary. Make sure teachers know how to contact you
- ▶ Stay on top of your child's social contacts. Peer pressure can lead to skipping school, while students without many friends can feel isolated
- ▶ Encourage meaningful afterschool activities,

including sports and clubs

Communicate with the school

- ▶ Know the school's attendance policy – incentives and penalties
- ▶ Talk to teachers if you notice sudden changes in behavior. These could be tied to something going on at school
- ▶ Check on your child's attendance to be sure absences are not piling up
- ▶ Ask for help from school officials, afterschool programs, other parents or community agencies if you're having trouble getting your child to school

REASONS TO STAY IN SCHOOL

Finding Work Is Easier

- ▶ You are almost twice as likely to be unemployed if you do not finish high school

You'll Earn More

- ▶ Studies show high school graduates make 50% more than dropouts

What This Means

High school graduates are:

- ▶ Less likely to live at home
- ▶ More likely to be able to buy a car and rent an apartment
- ▶ Less likely to need welfare or public assistance

Less Likely To Be A Prison Inmate

When is sick too sick for school?



OK for school if...

- ▶ Clear runny nose or a little cough
- ▶ 24 hours since vomiting or diarrhea
- ▶ No fever or fever reducing medicine for 24 hours

Keep home if...

- ▶ Temperature is higher than 100°
- ▶ Vomiting or diarrhea
- ▶ Undiagnosed cough
- ▶ Pink/crusty eyes



Call the doctor if...

- ▶ Temperature higher than 100°, vomiting, or diarrhea for more than two days
- ▶ Sniffles for more than a week, and they are not getting better
- ▶ Still have asthma symptoms after using asthma medicine
- ▶ New cough that does not get better after two (2) days

CONSEJOS PARA PADRES...

¿Sabía que?

- ▶ Los estudiantes no deben faltar más de 9 días a la escuela cada año para mantenerse comprometidos, exitosos y en camino a la graduación
- ▶ En 6° grado, el ausentismo es una de las tres señales de que un estudiante puede abandonar la escuela secundaria
- ▶ En el noveno grado, la asistencia regular y elevada es un mejor predictor de las tasas de graduación que los resultados de los exámenes del octavo grado
- ▶ Los alumnos pueden tener un ausentismo crónico aunque sólo falten uno o dos días cada pocas semanas
- ▶ La asistencia es una habilidad importante para la vida que ayudará a su hijo a graduarse en la universidad y a mantener un trabajo

¿Qué puede hacer usted?

Haga que la asistencia a la escuela sea una prioridad

- ▶ Hable de la importancia de ir a la escuela todos los días, haz que faltar sea la excepción
- ▶ Ayude a su hijo a mantener las rutinas diarias, como terminar los deberes y dormir bien por la noche
- ▶ Trate de no programar citas de detalles o médicas durante el día de escuela
- ▶ No permita que su hijo se quede en casa a menos que esté verdaderamente enfermo. Dejas de dolor de estómago o de cabeza puede ser signos de ansiedad.

Ayude a su hijo a mantenerse comprometido

- ▶ Esté al tanto de las relaciones sociales de su hijo. La presión de los compañeros puede llevar a faltar a la escuela, mientras que los estudiantes sin muchos amigos pueden sentirse aislados

- ▶ Fomentar actividades extraescolares significativas, incluyendo deportes y clubes

Comuníquese con la escuela

- ▶ Conozca la política de asistencia de la escuela— incentivos y penalidades
- ▶ Hable con los maestros su nota repentinos cambios de comportamiento. Esto podría estar atado a algo que esté pasando de la escuela
- ▶ Verifique la asistencia de su hijo para asegurarse de que las ausencias no se acumulen
- ▶ Pida ayuda a los administradores de la escuela, a los programas extraescolares, a otros padres o a los organismos de la comunidad si tiene problemas para llevar a su hijo a la escuela

GENERAL

- Over 14.7 million (1 in 3) U.S. students miss nearly a month of school each year.
- The effects of poor attendance are particularly pronounced among low-income children. Unfortunately, 2 in 10 low-income children, 2.5 in 10 homeless children, and 4 in 10 transient children are likely to be chronically absent.
- Chronic absenteeism is about 15% less likely among English learners than non-English learners.
- Students with disabilities are almost 3 times more likely to be chronically absent than students without disabilities.
- The month of September matters. Students who missed 2 to 4 days in September were 5 times more likely to be chronically absent for the year than those who missed fewer than 2 days in September.

ELEMENTARY

- Only 17% of students who were chronically absent in kindergarten and 1st grade (18 or more days both years) can read on grade level after 3rd grade.
- Chronic absenteeism in kindergarten, and even PreK, can predict lower test scores, poor attendance, and retention in later grades.
- Chronically absent students in kindergarten and first grade are 4 times more likely to drop out in the future.
- Attending preschool matters. Students who do not attend preschool are more likely to be chronically absent in kindergarten.

SECONDARY

- By 6th grade, chronic absences becomes a leading indicator that a student will drop out of high school.
- By 9th grade, attendance can be a better indicator of dropout than 8th grade test scores.
- One year of chronic absenteeism between 8th and 12th grade can result in a seven-fold increase in the likelihood of dropping out.
- Each week of absence per semester in 9th grade is associated with a more than 20 percentage point decline in the probability of graduating from high school.
- Chronic absenteeism rates are highest in high school. Overall, almost 20 percent of students in high school are chronically absent compared to more than 14 percent of students in middle school and 14 percent in elementary school.

- El mes de septiembre importa. Los estudiantes que faltaron de 2 a 4 días en septiembre tenían 5 veces más probabilidades de estar ausentes crónicamente durante el año que aquellos que faltaron menos de 2 días en septiembre.

ESCUELA PRIMARIA

- Sólo el 17% de los estudiantes que estuvieron ausentes crónicamente en jardín de infantes y 1.er grado (18 días o más en ambos años) pueden leer al nivel de su grado después del 3.er grado.
- El ausentismo crónico en el jardín de infantes, e incluso en el preescolar, puede predecir puntajes más bajos en los exámenes, mala asistencia y retención en grados posteriores.
- Los estudiantes crónicamente ausentes en kindergarten y primer grado tienen 4 veces más probabilidades de abandonar la escuela en el futuro.
- Asistir a un programa pre-escolar sí es importante. Los alumnos que no cursaron pre-kindergarten son más probables de estar crónicamente ausentes durante kindergarten

ESCUELA INTERMEDIA

- Para el sexto grado, las ausencias crónicas se convierten en un indicador importante de que un estudiante abandonará la escuela secundaria.
- Para el noveno grado, la asistencia puede ser un mejor indicador de deserción que los puntajes de las pruebas del octavo grado. Un estudiante de escuela superior que se ausenta
- Un año de ausentismo crónico entre el octavo y el duodécimo grado puede multiplicar por siete la probabilidad de abandonar los estudios.
- Cada semana de ausencia por semestre en noveno grado se asocia con una disminución de más de 20 puntos porcentuales en la probabilidad de graduarse de la escuela secundaria.
- Las tasas de ausentismo crónico son más altas en la escuela secundaria. En general, casi el 20 por ciento de los estudiantes de la escuela secundaria están crónicamente ausentes en comparación con más del 14 por ciento de los estudiantes de la escuela intermedia y el 14 por ciento de la escuela primaria.

The 2025 Florida Statutes

[Title XLVIII](#)[EARLY LEARNING-20 EDUCATION CODE](#)[Chapter 1003](#)[PUBLIC K-12 EDUCATION](#)[View Entire Chapter](#)

1003.26 Enforcement of school attendance.—The Legislature finds that poor academic performance is associated with nonattendance and that school districts must take an active role in promoting and enforcing attendance as a means of improving student performance. It is the policy of the state that each district school superintendent be responsible for enforcing school attendance of all students subject to the compulsory school age in the school district and supporting enforcement of school attendance by local law enforcement agencies. The responsibility includes recommending policies and procedures to the district school board that require public schools to respond in a timely manner to every unexcused absence, and every absence for which the reason is unknown, of students enrolled in the schools. District school board policies shall require the parent of a student to justify each absence of the student, and that justification will be evaluated based on adopted district school board policies that define excused and unexcused absences. The policies must provide that public schools track excused and unexcused absences and contact the home in the case of an unexcused absence from school, or an absence from school for which the reason is unknown, to prevent the development of patterns of nonattendance. The Legislature finds that early intervention in school attendance is the most effective way of producing good attendance habits that will lead to improved student learning and achievement. Each public school is required to implement the following steps to promote and enforce regular school attendance:

(1) **CONTACT, REFER, AND ENFORCE.**—

(a) Upon each unexcused absence, or absence for which the reason is unknown, the school principal or his or her designee must contact the student's parent to determine the reason for the absence. If the absence is an excused absence, as defined by district school board policy, the school shall provide opportunities for the student to make up assigned work and not receive an academic penalty unless the work is not made up within a reasonable time.

(b) If a student has had at least five unexcused absences, or absences for which the reasons are unknown, within a calendar month or 10 unexcused absences, or absences for which the reasons are unknown, within a 90-calendar-day period, the student's primary teacher must report to the school principal or his or her designee that the student may be exhibiting a pattern of nonattendance. Unless there is clear evidence that the absences are not a pattern of nonattendance, the principal must refer the case to the school's child study team to determine if early patterns of truancy are developing. If the child study team finds that a pattern of nonattendance is developing, whether the absences are excused or not, a meeting with the parent must be scheduled to identify potential remedies, and the principal must notify the district school superintendent and the school district contact for home education programs that the referred student is exhibiting a pattern of nonattendance. The child study team may allow the parent to attend the meeting virtually or by telephone if the parent is unable to attend the meeting in person.

(c) If the parent or child fails to attend the child study team meeting, the meeting shall be held in his or her absence, and the child study team shall make written recommendations to remediate the truancy based upon the information available to the school. The recommendations shall be provided to the parent within 7 days after the child study team meeting. If the initial meeting does not resolve the problem, the child study team shall implement the following:

1. Frequent attempts at communication between the teacher and the family.

2. Attempt to determine the reasons the child is truant from school and provide remedies if available or refer the family to services, including referring the family for available scholarship options if the learning environment is an issue of concern.
3. Evaluation for alternative education programs.
4. Attendance contracts.

The child study team may, but is not required to, implement other interventions, including referral to the Department of Juvenile Justice's designated provider for voluntary family services, or to other agencies for family services or recommend filing a truancy petition pursuant to s. [984.151](#).

(d) The child study team must be diligent in facilitating intervention services and shall report the case to the district school superintendent only when all reasonable efforts to resolve the nonattendance behavior are exhausted.

(e) If the parent refuses to participate in the remedial strategies because he or she believes that those strategies are unnecessary or inappropriate, the parent may appeal to the district school board. The district school board may provide a hearing officer, and the hearing officer shall make a recommendation for final action to the district school board. If the district school board's final determination is that the strategies of the child study team are appropriate, and the parent still refuses to participate or cooperate, the district school superintendent may seek criminal prosecution for noncompliance with compulsory school attendance.

(f)1. If the parent of a child who has been identified as exhibiting a pattern of nonattendance enrolls the child in a home education program pursuant to chapter 1002, the district school superintendent shall provide the parent a copy of s. [1002.41](#) and the accountability requirements of this paragraph. The district school superintendent shall also refer the parent to a home education review committee composed of the district contact for home education programs and at least two home educators selected by the parent from a district list of all home educators who have conducted a home education program for at least 3 years and who have indicated a willingness to serve on the committee. The home education review committee shall review the portfolio of the student, as defined by s. [1002.41](#), every 30 days during the district's regular school terms until the committee is satisfied that the home education program is in compliance with s. [1002.41](#)(1)(d). The first portfolio review must occur within the first 30 calendar days after the establishment of the program. The provisions of subparagraph 2. do not apply once the committee determines the home education program is in compliance with s. [1002.41](#)(1)(d).

2. If the parent fails to provide a portfolio to the committee, the committee shall notify the district school superintendent. The district school superintendent shall then terminate the home education program and require the parent to enroll the child in an attendance option that meets the definition of the term "regular school attendance" under s. [1003.01](#)(16)(a), (b), (c), or (e), within 3 days. Upon termination of a home education program pursuant to this subparagraph, the parent shall not be eligible to reenroll the child in a home education program for 180 calendar days. Failure of a parent to enroll the child in an attendance option as required by this subparagraph after termination of the home education program pursuant to this subparagraph shall constitute noncompliance with the compulsory attendance requirements of s. [1003.21](#) and may result in criminal prosecution under s. [1003.27](#)(2). Nothing contained herein shall restrict the ability of the district school superintendent, or the ability of his or her designee, to review the portfolio pursuant to s. [1002.41](#)(1)(e).

(g) If a student subject to compulsory school attendance will not comply with attempts to enforce school attendance, the parent or the district school superintendent or his or her designee must refer the case to the Department of Juvenile Justice's authorized agent, which shall then offer voluntary family services, and schedule a meeting of the case staffing committee pursuant to s. [984.12](#) if the services do not remediate the child's truancy, and the district school superintendent or his or her designee may file a truancy petition pursuant to the procedures in s. [984.151](#).

(h) If a student subject to compulsory school attendance is responsive to the interventions described in this section and has completed the necessary requirements to pass the current grade as indicated in the district pupil progression plan, the student may not be determined to be a habitual truant and shall be promoted.

(2) GIVE WRITTEN NOTICE.—

(a) Under the direction of the district school superintendent, a designated school representative must provide written notice in person or by return-receipt mail to the parent, requiring the child's enrollment or attendance within 3 days after the date of notice, when no valid reason is found for a student's nonenrollment in school if the child is under compulsory education requirements, and is not exempt. If the child is not enrolled or in attendance in school within 3 days after the notice being provided, the designated school representative must report the case to the district school superintendent, who must refer the case to the child study team in paragraph (1)(b) at the school the student would be assigned according to district school board attendance area policies. In addition, the designated school representative may refer the case to the Department of Juvenile Justice's authorized agent for families in need of services. The child study team must diligently facilitate intervention services and report the case back to the district school superintendent within 15 days after referral of the case if reasonable efforts to resolve the nonenrollment behavior have been made and the child is still not attending school. If the parent refuses to cooperate or enroll the child in school within 15 days after referral of the case to the child study team, the district school superintendent must make a report to law enforcement and refer the case to the Office of the State Attorney to bring criminal prosecution against the parent.

(b) Subsequent to referring the case to the Office of the State Attorney, the district school superintendent or his or her designee must give written notice in person or by return-receipt mail to the parent that criminal prosecution is being sought for nonattendance. The district school superintendent may file a truancy petition, as defined in s. [984.03](#), following the procedures outlined in s. [984.151](#).

(3) **RETURN STUDENT TO PARENT.**—A designated school representative may visit the home or place of residence of a student and any other place in which he or she is likely to find any student who is required to attend school when the student is not enrolled or is absent from school during school hours without an excuse, and, when the student is found, shall return the student to his or her parent or to the principal or teacher in charge of the school, or to the private tutor from whom absent. If the parent cannot be located or is unavailable to take custody of the child, and the child is not to be presented to the child's school or tutor, the youth shall be referred to the Department of Juvenile Justice's shelter, to another facility, or other location established by the district school board to receive students who are absent from school. Upon receipt of the student, the parent shall be immediately notified.

(4) **REPORT TO APPROPRIATE AUTHORITY.**—A designated school representative shall report to the appropriate authority designated by law to receive such notices, all violations of the Child Labor Law that may come to his or her knowledge.

(5) **RIGHT TO INSPECT.**—A designated school representative shall have the right of access to, and inspection of, establishments where minors may be employed or detained only for the purpose of ascertaining whether students of compulsory school age are actually employed there and are actually working there regularly. The designated school representative shall, if he or she finds unsatisfactory working conditions or violations of the Child Labor Law, report his or her findings to the appropriate authority.

TRUANCY PETITION

COMES NOW, Petitioner, Dr. Leslie C. Ricciardelli, Superintendent of The District School Board of Collier County ("the District"), by and through counsel, and petitions this Court to adjudicate the above-named Minor Child (hereinafter "the student") as habitually truant, as defined in § 984.03(27), § 984.151, § 1003.01(8), § 1003.21, § 1003.26, and § 1003.27, Florida Statutes, and alleges as follows:

1. This Court has jurisdiction to hear a truancy petition, pursuant to § 1003.27 and § 984.151, Florida Statutes.
2. The student, [REDACTED], whose date of birth is, [REDACTED] resides at, [REDACTED] [REDACTED], and is enrolled at **Palmetto Ridge High School** as a student in the [REDACTED] grade.
3. The student's Parent(s), [REDACTED], resides at [REDACTED] **Naples, FL** [REDACTED].
4. In accordance with F.S. § 1003.26, F.S. § 1003.27, F.S. § 984.151(4), and District attendance policy and related administrative procedures, the school has tried on multiple occasions to encourage the student to attend school (see the school documentation appended hereto as Exhibit A):
 - a. The Principal or designee has contacted the Parent(s) on multiple occasions to determine the reason for each unexcused absence or absence for which the reasons were unknown.
 - b. After five (5) unexcused absences or absences for which the reasons were unknown within a calendar month or ten (10) unexcused absences within a ninety (90) calendar day period, the principal or designee referred the case to a Child Study Team (MTSS) and a meeting with the student's Parent(s) was scheduled and held on **October 6, 2025**. Parent did not attend the scheduled MTSS meeting. Home visit took place and attendance laws delivered on October 6, 2025.
 - c. The child study team implemented interventions to address the problem, was diligent in facilitating services, and reported the case to the Superintendent only when all reasonable efforts to resolve non-attendance were exhausted.

5. The school has made **06** contacts with the student, the Parent(s) of the student, and other interested parties.
6. The student has missed **23** unexcused school days during the 2025-2026 school year. The student missed **9** unexcused school days during the prior school year. A list of school days missed during the 2025-2026 school year is attached hereto as Exhibit B (reflects two semesters).
7. In accordance with F.S. §984.151(5), with the filing of this Petition, the Court shall hear the case within 30 days and has the right to accelerate the time in its discretion.
8. In accordance with F.S. § 984.151(6), both the student and the student's parent or guardian must attend the hearing.
9. Further, in accordance with F.S. §984.151(9) should sanctions or service be ordered by the Court, both the parent (or guardian) and the student will be required to participate in the completion of any such sanction or service.

WHEREFORE, the Petitioner asks that the court adjudicate the above-named student to be habitually truant and order the student and the student's Parent(s) to successfully complete sanctions as provided by law.

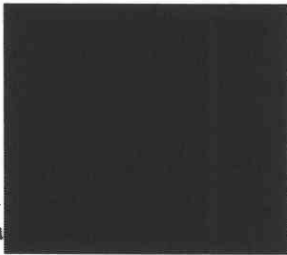

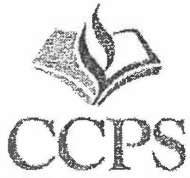

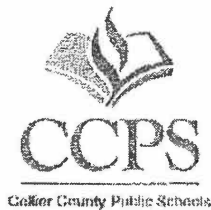

Per Florida Statute 1003.21 - The State of Florida Compulsory Attendance Laws require all children who have attained the age of six (6) years or who will have attained the age of six (6) years by February 1 of any school year or who are older than six (6) years of age but who have not attained the age of sixteen (16) years, except as otherwise provided, are required to attend school regularly during the entire school term.

Florida Statute 1003.27(2)(a) - In each case of non-enrollment or of non-attendance upon the part of a student who is required to attend some school, when no valid reason for such non-enrollment or non-attendance is found, the district school Superintendent shall institute a criminal prosecution against the student's parent.

Failure to comply with the abovementioned recommendations will result in a Petition for Truancy Court filed with the Judge and could result in an adjudication of habitually truant and may result in criminal prosecution against the student's parent, per F.S. 1003.27(2)(a).

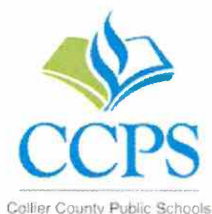

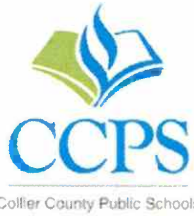
