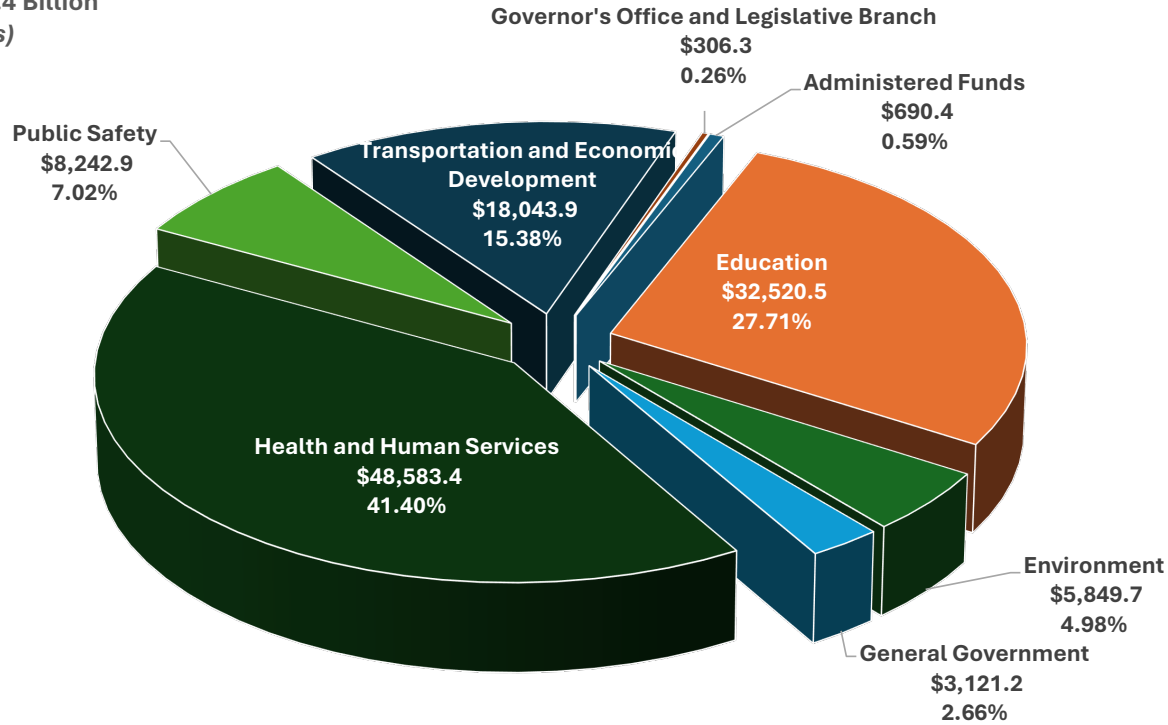

(\$ in Millions)

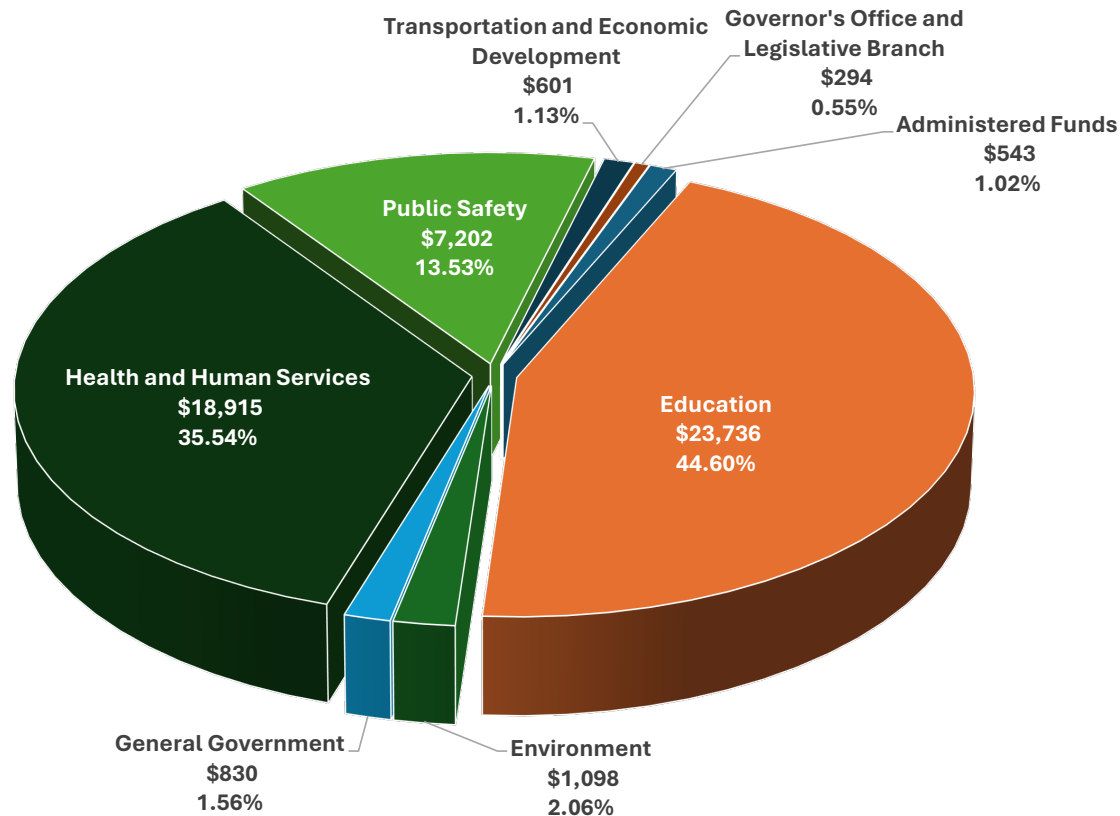

(\$ in Millions)

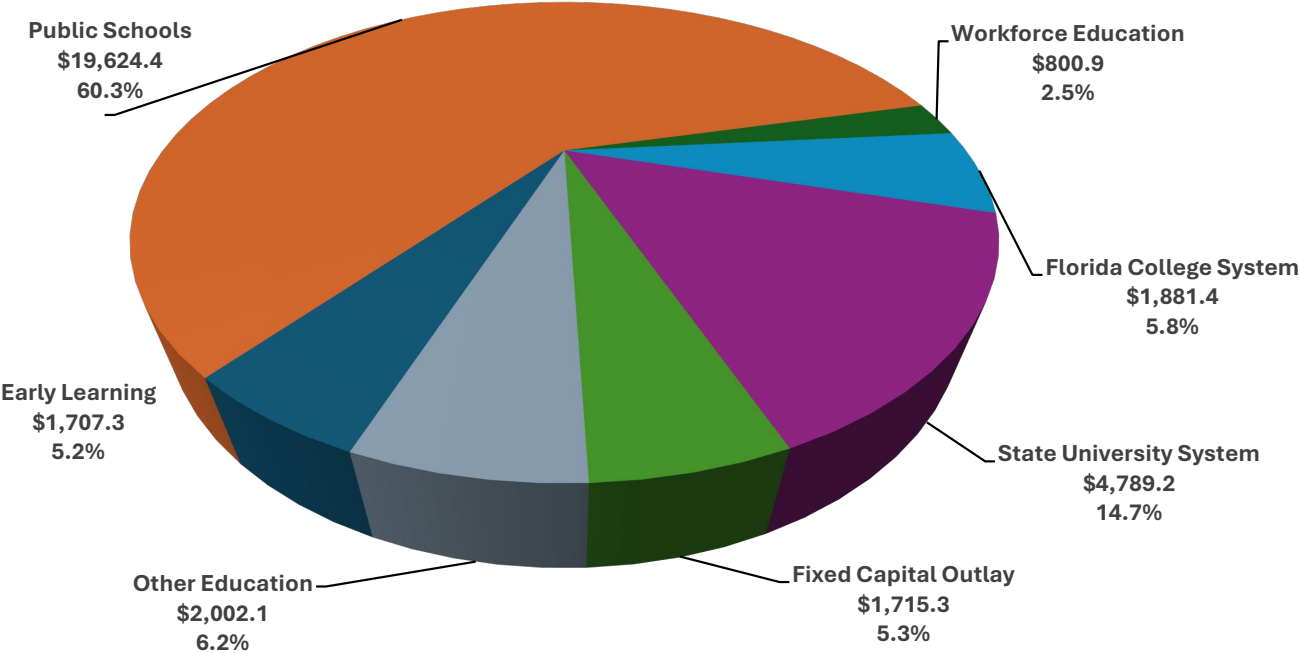

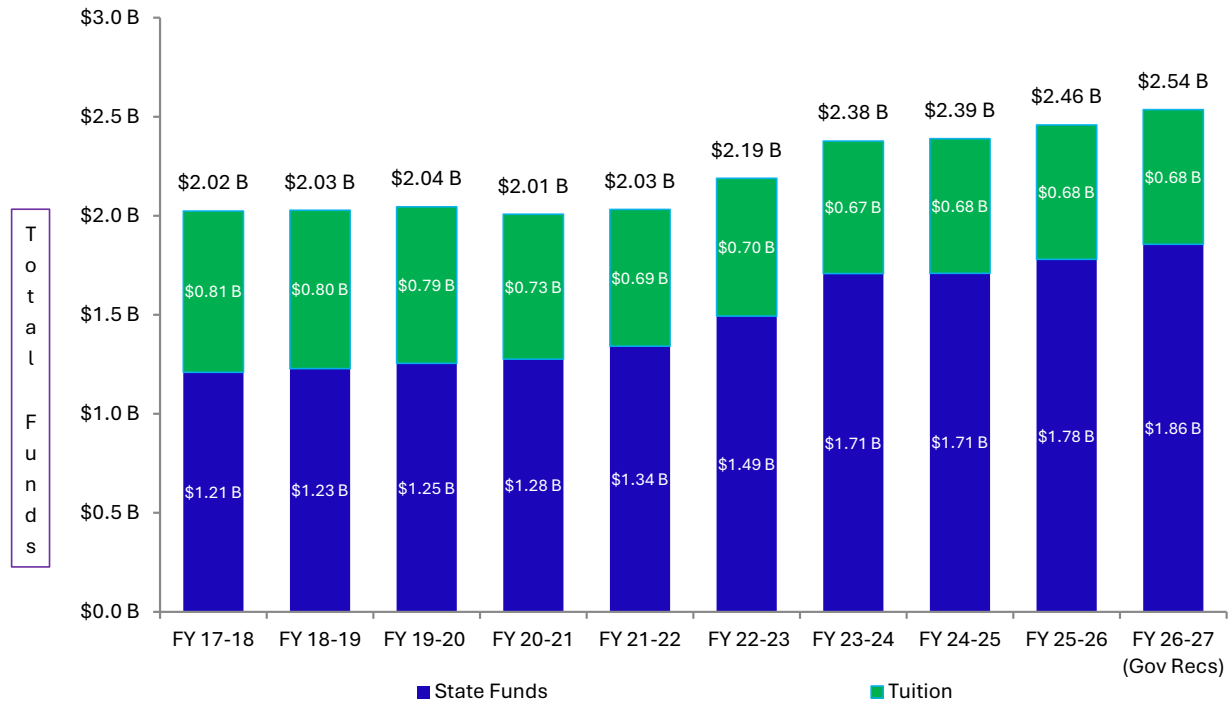

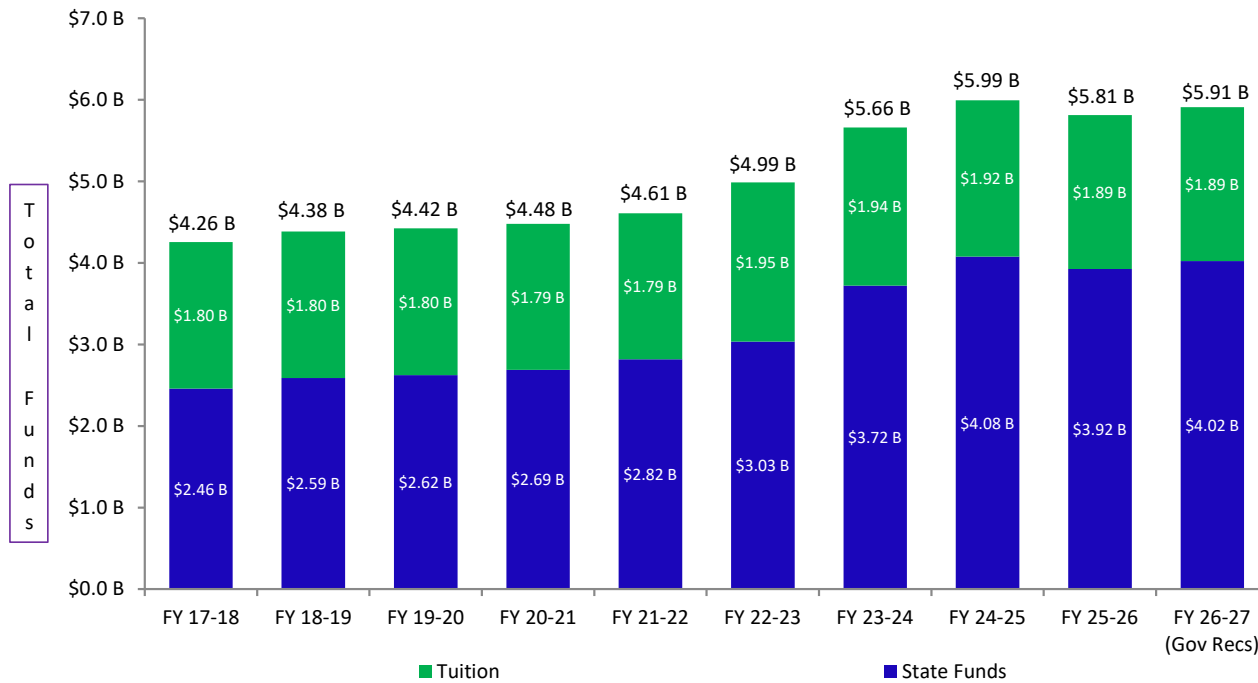
