
Total Education Funds by Policy Area

















Voluntary Prekindergarten Funding (*Millions*)



Voluntary Prekindergarten Base Student Allocation History




School Readiness Funding History State and Federal \$ in Millions







Public Schools Funds (FEFP) per FTE




Public Schools (FEFP) Funds per FTE Percent Increase (GAA)

 Elementary Schools permanent funding & statutory language
- Additional Property Tax Relief Reduce or eliminate increases in Required Local Effort funds (millage rate reduction) due to increased property values and ad valorem taxes
- Tax Credit Scholarship Lawsuit
- ☐ Revisions to accountability system requirements and effects on PreK-12 assessment funding
 - Changes to Federal Title I Funds Every Student Succeeds Act (ESSA); Implications and opportunities for Florida

Emerging PreK-12 Education Issues...continued

- Best and Brightest Scholarship Program Continuation and Revisions
- School Choice Issues
 - Expanding and providing incentive funds for charter schools that focus on "at risk" and disadvantaged students
 - Implementing HB 7029 (2016 legislative session) provisions that enable students, beginning in the 2017-2018 school year, to attend any public school in the state, including charter schools
 - Providing additional sources of funding for charter school capital outlay
 - Gardiner Scholarship workload funding
