





Historical Funding and Student Enrollment Information - Early Learning Programs


2024-25 Early Learning Appropriations (\$ Millions)



Voluntary Prekindergarten Funding (\$ Millions)




Voluntary Prekindergarten Full-Time Enrollment (FTE)




Voluntary Prekindergarten Base Student Allocation (BSA) History – School Year

School Readiness Funding History State and Federal (\$ Millions)




Historical Funding and Student Enrollment Information - FEFP and Other K-12 Programs


FEFP Total Funds Funding (\$ Billions)




FEFP Student FTE Enrollment




FEFP Student FTE Forecast




FEFP Funds per FTE

Base Budget Overview


- Primary differences from total FY 2024-25 Appropriations
 - Base budget excludes <u>nonrecurring funds</u> appropriated for FY 2024-25,
 which totaled approximately \$832.4 million for PreK-12 Education
 - Base budget includes other startup adjustments such as transfers from administered funds for various personnel/human resources
- Starting point for FY 2025-26 budget discussions and analysis
- PreK-12 Education base budget can be grouped into five major categories (discussed on next slide)
- The base budget <u>handout</u> identifies (1) the issue, (2) staff FTE count if applicable, (3) the base funding totals by general revenue and trust fund (all trust funds grouped into one total), and (4) a brief description of the issue

Major Types of Funding Categories

- 1. <u>Local Education Agency (LEA) Operational Funding</u> State appropriations provided to directly support the operations of a public LEA established pursuant to Florida law. This funding is appropriated as a <u>lump-sum allocation</u> to each LEA, in contrast to the funding provided to state agencies where funding is appropriated in specific operational categories such as salaries and benefits, expenses, OPS, and so forth. This provides LEAs significant flexibility in how they spend their state appropriations. In Florida, these LEAs currently include:
 - a) School districts (FEFP)
 - b) State Universities
 - c) Florida College System Institutions
 - d) District Career and Adult Education Centers
 - e) Florida School for the Deaf and Blind
 - f) Private Historically Black Colleges and Universities (HBCUs)
- 2. Performance or Incentive Funds
- 3. Specific Programs or Initiatives (examples include Voluntary Prekindergarten Program, student financial aid programs,....)
- 4. Typical Agency Operational Expenses (salaries and benefits, expenses, OCO,...)
- 5. Recurring Base Local Funding Initiatives


Individual with Disabilities Education Act (IDEA) Definition

A child with a disability means a child evaluated as having an intellectual disability, a hearing impairment (including deafness), a speech or language impairment, a visual impairment (including blindness), a serious emotional disturbance (referred to in this part as "emotional disturbance"), an orthopedic impairment, autism, traumatic brain injury, an other health impairment, a specific learning disability, deaf-blindness, or multiple disabilities, and who, by reason thereof, needs special education and related services.





- States are awarded an allocation each new fiscal year. The majority is allocated to LEAs.
- The Office of Special Education Programs at the USED has established a formula that states must use to calculate allocations for local educational agencies.
- Each LEA completes an IDEA application annually that is reviewed and approved by the Department before funds are disbursed.
- Each LEA is monitored for eighteen IDEA indicators and Florida is monitored by USED for indicator performance and monitoring of the LEAs.




Florida Diagnostic Learning Resources System (FDLRS)

FDLRS collaborates with districts, support personnel, administrators and students with disabilities to ensure these four functions are carried out.

parents to support student achievement.

Resource Development

FDLRS resources development is available in the areas of behavior management, instructional strategies, differentiated instruction, universal design for learning, explicit instruction, secondary transition and collaborative teaching.

Technology

FDLRS technology support personnel provide services in multiple areas including assistive technology, instructional technology, universal design for learning, accessible educational materials and virtual instruction.


