1	<b>SB 238</b> Altman (Similar H 11)	Child Safety Devices in Motor Vehicles; Provides child-restraint requirements for children ages 4 through 7 years of age who are less than a specified height. Provides certain exceptions. Redefines the term "motor vehicle" to exclude certain vehicles from such requirements. Provides a grace period.  TR 02/07/2011 Favorable CJ BC	Favorable Yeas 4 Nays 1
2	<b>SB 244</b> Bennett (Identical H 177)	Motor Vehicles/Highway Safety Act; Provides legislative intent relating to road rage and aggressive careless driving. Requires an operator of a motor vehicle to yield the left lane when being overtaken on a multilane highway. Specifies the allocation of moneys received from the increased fine imposed for aggressive careless driving. Requires the HSMV to provide information about the Highway Safety Act in driver's license educational materials, etc.  TR 02/07/2011 Fav/CS HR BC	Fav/CS Yeas 5 Nays 0
3	<b>SB 292</b> Dean	Mobile Home and Recreational Vehicle Parks; Specifies laws and rules to be enforced by the Department of Health. Provides that an operator of a mobile home park, lodging park, recreational vehicle park, or recreational camp who refuses to pay the operating permit fee required by law or who fails, neglects, or refuses to obtain an operating permit for the park commits a misdemeanor of the second degree. Provides a penalty for failure to depart from a park under certain circumstances, etc.  TR 02/07/2011 Favorable HR CA BC	Favorable Yeas 6 Nays 0
