#### DRIVE ELECTRIC FLORIDA – INTRODUCTIONS



#### Mission

Advance the energy, economic, and environmental security of the state of Florida by promoting the growth of electric vehicle ownership and the accompanying infrastructure.

#### Vision

Support and accelerate the adoption of plug-in electric vehicles in Florida by engaging and educating the public, businesses and policy-makers; facilitating collaboration; and supporting EV-friendly policy and programs.



#### Goals

- Encourage policy and incentive development in Florida that promotes electric vehicle adoption and/or removes barriers to adoption.
- Educate key stakeholders about electric vehicle priorities.

ABOUT ELECTRIC VEHICLES



#### What is an electric-vehicle?

- Electric vehicles use electricity as fuel. There are several types of electric vehicles. Some vehicles are electric only, referred to as battery electric vehicles (BEVs), and run entirely off electrically charged batteries. Other vehicles use both gas and electricity. These are called plug-in hybrid electric vehicles or extended-range electric vehicles (PHEVs, EREVs).
- Most major automotive manufacturers have already introduced or plan to introduce an electric vehicle in the coming years. There are now more than 20 different models of electric vehicles sold in the U.S., although not all of them are available yet for purchase here in Florida. Through January 2015, there are about 300,000 electric vehicles on U.S. roads and 10,000 in Florida.

#### How much does an electric-vehicle cost?

- Just like gas powered cars, electric vehicles come in all price ranges. Currently, EVs start in the \$20,000 range, with prices rising to the low \$100,000s. Leasing is another option. In fact, many people who have never leased a car before lease an EV.
- Owning an EV can be less expensive than owning a regular car, and EV owners typically save on repairs and routine maintenance costs because oil changes and transmission work is not needed.



#### How do I charge an electric-vehicle?

Simply plugging it in. Unlike gasoline-powered vehicles, electric vehicles refuel where they are typically parked and rarely need to go out of their way for a charge. The vast majority of charging occurs at home, followed by the workplace, and then public locations—major highways or destination locations (e.g. sporting arenas/beaches/retail locations).

- AC Level-1: refers to charging the battery with a standard 120-volt outlet and the cord that comes standard with your vehicle. A level-1 charge can replace between 3-5 miles of range per hour of charge. For the typical driver, this is sufficient to recharge their vehicle after a normal day's driving. More and more EV owners are choosing to use this most basic charging type at home and in the workplace.
- AC Level-2: refers to charging the battery with a dedicated 240-volt circuit. It is two to five times faster than Level-1. Level-2 charging typically requires professional installation from a licensed electrical contractor. Level-2 charging can replace from 10 to 60 miles of range per hour of charge—depending upon the charging equipment, installation and vehicle's specifications.
- **DC fast charging:** refers to high voltage charging station that can recharge equipped electric vehicles at much faster rates—from 20kW to 100kW or more. For example, a battery electric vehicle can recharge from 20 percent to 80 percent in less than 30 minutes.

#### How much does it cost to install a charging station?

- AC Level-1: A portable cord set comes standard with most new electric vehicles at no extra charge and can be used with a dedicated electrical outlet.
- AC Level-2: This equipment starts around \$450 to more than \$2000 depending on features and options selected. Installation costs can range from several hundred dollars (or more) for a simple single-family home installations, to thousands of dollars for multi-unit residential and commercial installations-depending upon several factors including distance from power source, trenching needs, electrical panel capacity, etc.
- **DC fast charging:** Equipment costs range from around \$13,000 to \$40,000 depending upon features and options selected. Installation costs can vary dramatically-depending upon complexity of installation and whether electrical infrastructure upgrades are necessary. Use of DC fast charge station may impact a facility's monthly electricity demand charge.

#### ISSUES AFFECTING ELECTRIC VEHICLE OWNERS IN FLORIDA



#### **Public Charging Infrastructure**

The state of Florida does not have a statewide network of electric vehicle charging infrastructure.

#### **Electric-Vehicle Parking Enforcement**

Section 366.94, F.S. relating to electric vehicle charging stations provides that it is unlawful for a motor vehicle operator to park, stand, or stop a vehicle that is not capable of using an EV charging station within any parking space specifically designated for charging an EV. Section 366.94, F.S. authorizes local law enforcement to charge a motor vehicle operator who violates this section with a noncriminal traffic infraction. However, the cross reference authorizing law enforcement to enforce the statute is incomplete, and law enforcement does not penalize violators.

#### **Multi-Unit Dwelling Owners & Charging Stations**

Multi-unit dwelling owners who wish to install electric-vehicle supply equipment (EVSE) or a charging station at his/her cost are sometimes prevented from doing so by the HOA, apartment, or condominium association. Multi-unit dwelling owners are unable to charge their EV while at home, forcing them to seek other alternatives.





#### FLORIDA POLICY AND ELECTRIC VEHICLES



#### Why Florida should enact EV-friendly policy

- Electric vehicles are good for the environment and promote energy security – but they can also boost a state's economy and create jobs.
- Even with today's low gasoline prices, electric vehicles cost about 50 percent less to fuel and 60 percent less to maintain than comparable gasoline vehicles.
- In addition to the economic benefits, widespread adoption of electric vehicles can dramatically reduce greenhouse gas emissions in Florida.
- Many other states have recognized these benefits and offer incentives and programs to increase EV adoption.

## **Failure to Comply Suspensions**

Commonly referred to as D-6 Suspensions

Individuals who violate Florida laws may be sanctioned through the suspension or revocation of their driver license for both driving and non-driving-related offenses which take away a person's driving privilege.

(ss. 318.15(1)(a), 320.02(12), 322.245(1), F.S.)



## Reason's for "Failure to Comply" Suspensions Include, but are not limited to:

- Failure to Pay Traffic Fine
- Failure to Appear on a Criminal Offense
- Failure to Pay on a Criminal Offense
- Failure to Appear for a Traffic Summons
- Failure to Comply with Traffic Summons (Out of State jurisdiction/Florida resident)
- School Election Made Failed to Attend (to avoid points)
- Fail to Complete Court Ordered School
- School Election Made When Not Eligible



## **Process to Suspend**

- A customer's driving privilege is suspended when they fail to comply with the court requirements on a traffic citation within a specific time frame.
- Upon notification from the county Clerk of Court, the department places a 20 day post dated suspension on customer record and notifies the driver by mail of pending action.
- To avoid suspension, the driver must present an acceptable court clearance document before the effective suspension date.



# Additional Sanctions for Failure to Pay/Comply Suspensions

- Prevents registration or renewal of a motor vehicle via an "administrative stop" when the owner or one of the co-owners of the vehicle has a driver license which is under suspension.
- Registrations cannot be processed until the suspension has been cleared.



## Traffic Citation Accounting Transmission System (TCATS) s. 318.18(8)(a), F.S.

The department shall contract with the Florida Association of Court Clerks, Inc., to design, establish, operate, upgrade, and maintain an automated statewide Uniform Traffic Citation Accounting System to be operated by the clerks of the court which shall include, but not be limited to, the accounting for traffic infractions by type, a record of the disposition of the citations, and an accounting system for the fines assessed and the subsequent fine amounts paid to the clerks of the court.



# **Failed to Comply Submissions**

- Florida Clerks of Court submit Failure to Pay/Comply Sanctions electronically, through the automated Traffic Citation Accounting Transmission System (TCATS) system.
  - Out of State courts submit their Failure to Pay/Comply Sanctions manually, through the mail.



## **Court Clearance Requirements**

Requirements include the documentation from the courts that the suspension has been satisfied.

Documentation can be in the form of:

- Clearance Form with court seal
- Electronic county court clearance
- An out of state cash receipt that includes the Citation Number, compliance date and court seal



## **Reinstatement Time Periods**

- Driver Licenses are suspended indefinitely, until the driver meets the court requirements for reinstatement.
- Once suspended, in addition to submitting proof of compliance, the driver must pay a reinstatement fee of \$60.00.
- If compliance/payment is made prior to suspension, no fee is required.



# Retention of "Failure to Pay/Comply" Suspensions

- A Failure to Pay/Comply suspension cleared <u>prior</u> to the suspension date should purge from the record on the next weekly scheduled purge.
- If a Failure to Pay/Comply suspension is cleared after the suspension date, the suspension information remain on the record for one year from the reinstatement date.
  - After a year, the Failure to Pay/Comply converts to a correspondence entry and remains on the record for two more years (3 years from the reinstatement date).
- Data Retention for Civil Citations is 7 years on driving record and Criminal Citations do not purge.

## 2014 OPPAGA Report: "Options Exist to Modify Use of Driver License Suspension for Non-Driving-Related Reasons"

Report included options to consider such as:

- Remove mandatory suspension/revocation requirement such as theft, and failure to appear for worthless checks instead be at the courts discretion; Eliminate suspension as a sanction for certain offenses like seatbelt violations and broken tail lights; and Evaluate the effectiveness of a dl suspension for school truancy.
- Chapter No. 2014-216 (HB 7005) Implemented several provisions of the OPPAGA Report (Worthless Checks Misdemeanor Theft, Drug Offenses, and Sale to Minors Prohibitions

## **Civil Traffic Violations**

The process begins with a ticket issued to a violator

- Violator has 30 days to elect options, unless nature of offense requires mandatory hearing [sec. 318.14(4)(a), F.S.]
  - Options are: pay civil penalty, contest violation and request a court hearing, or pay civil penalty and make an election to attend traffic school, if eligible
    - If requested, violator may enter into payment plan with Clerk, pursuant to sec. 28.246, F.S., to pay civil penalty and delinquency. Service fees for payment plan administration apply per sec. 28.24(26), F.S.



# **Civil Traffic Violations (continued)**

 If violator fails to elect an option, the Clerk must notify DHSMV of non-compliance in accordance with sec. 318.15(1)(a), F.S., within 10 days from the failure to comply date

#### Non-Compliance Process:

- Pursuant to sec. 318.18(8)(a), F.S., and sec. 28.24(8), F.S., an additional \$23 is assessed for failure to make an election
- Clerk creates the D-6 transaction and submits via the Traffic Citation Accounting Transmission System (TCATS)



# **Civil Traffic Violations (continued)**

- Upon successful processing of the D-6 transaction, DHSMV sends the violator a letter stating that their driver license will be suspended if action is not taken by a certain date
- If the violator fails to pay within 90 days from the offense date, the citation can be sent to a collection agency for further processing. Pursuant to sec. 28.246(6), F.S., a collection agency fee of up to 40 percent can be charged.
- Reinstatement of the driver license requires payment of a \$60 reinstatement fee pursuant to sec. 318.15(2), F.S.



## **Criminal Traffic Violations**

- The process begins with a criminal citation issued to defendant
  - Defendant fails to appear for a hearing where written notice was provided at the time of the violation
    - The Court may order a warrant for failure to appear at the hearing (FTA), forfeit the surety or cash bond, or revoke the Release on Recognizance (ROR) and order the suspension of the driver license



# Criminal Traffic Violations (continued)

- The Clerk processes Bench Warrant for Failure to Appear (FTA), delivers warrant to Sheriff's Office for service, and suspends driver license if ordered
- Pursuant to sec. 322.245, F.S., a \$25 fee is assessed upon suspension of the driver license
- Upon order of the Court to set aside the suspension, the Clerk prepares an Affidavit to Reinstate Driver License and provides to the defendant to go to DHSMV or the Tax Collector to reinstate driver license



## **Non-payment of Financial Obligations**

- Financial Obligation Suspension: Defendant fails to pay required fine by the required due date, pursuant to payment plan, for any criminal, traffic, or civil infraction case
  - Pursuant to sec. 322.245(1), F.S., the Clerk must notify the defendant of such failure to comply and notify them that if compliance is not met within 30 days, their driver license will be suspended
  - Clerk sends electronic notice of failure to pay fine to DHSMV, pursuant to sec. 322.245(5)(a), F.S.



# Non-payment of Financial Obligations (continued)

- If the defendant fails to pay or enter into a payment agreement within 30 days:
  - Court costs may be reduced to judgment and interest accrued
  - The case may be sent to a collection agency for further processing. Pursuant to sec. 28.246(6),
    F.S., a collection agency fee of up to 40 percent can be charged.



# Non-payment of Financial Obligations (continued)

- For criminal cases, upon receiving payment in full, Clerk prepares an Affidavit to Reinstate Driver License and provides to the defendant to go to DHSMV or the Tax Collector to reinstate driver license
- For traffic and civil infraction cases, upon receiving payment in full, Clerk can process the D-6 clearance online or prepare a Certificate of Payment and provide to the defendant to go to DHSMV or the Tax Collector to reinstate driver license



### **Court-Ordered Suspensions**

- Non-Compliance with a Court Order: Defendant fails to comply with Court requirements
  - The Court may order the suspension of a driver license, violate probation, or impose other sanctions, as it deems appropriate
  - Based on order of the Court or upon receiving payment in full, Clerk prepares an Affidavit to Reinstate Driver License and provides to the defendant to go to DHSMV or the Tax Collector to reinstate driver license



### **Statutory Basis for Additional Fees**

- Fees related to driver license suspension and clearance, payment plans, and collections:
  - sec. 28.24(26), F.S., Payment Plan fee of either \$5 per transaction or a \$25 onetime set-up
  - sec. 28.246(6), F.S., Collection Agency fee up to 40 percent
  - sec. 28.24(8), F.S., \$7 D-6 fee
  - sec. 318.15(1)(b), F.S., \$18 Failure to Complete Traffic School fee
  - sec. 318.15(2), F.S., \$60 Reinstatement fee
  - sec. 318.18(8)(a), F.S., \$16 Late fee
  - sec. 322.245, F.S., \$25 Delinquency fee for FTA
