I. Summary:

CS/SB 430 preempts regulation of petroleum fuel measuring devices to the State and the Department of Agriculture and Consumer Services (department) and eliminates the department's authority to impose penalties for violations of petroleum fuel measuring device rules unless an owner or operator of a petroleum fuel measuring device has failed to install a security device or measure.

The bill takes effect July 1, 2021.

II. Present Situation:

The Department of Agriculture and Consumer Services

Generally

The Department of Agriculture and Consumer Services (department) has broad duties under s. 525.07, F.S., including safeguarding the public from deceptive business practices, supporting Florida's agricultural economy, and protecting the environment.¹ Nineteen divisions and offices within the department support its mission.² The Division of Consumer Services inspects all measuring devices used in selling or distributing fuel at retail gas pumps and ensures the use of security mechanisms on gas pumps that help to prevent the use of skimmers.³ This division also

provides consumer education regarding a variety of scams and frauds that target Florida residents, including identity theft and credit card fraud.⁴

Petroleum Inspection and Enforcement

The department conducts routine inspections of petroleum distribution systems and analyzes samples of petroleum⁵ products.⁶ These inspections include regular testing of gasoline, alternative fuels,⁷ kerosene, diesel, fuel oil, antifreeze products, and brake fluid.⁸ Petroleum fuel must be labeled accurately,⁹ and any mislabeled product must be placed under a stop-sale order with the device or storage tanks of that product sealed until a release order is issued.¹⁰

The department is also required to inspect all measuring devices used in selling or distributing petroleum fuel at wholesale and retail.¹¹ The department may put a sticker on each petroleum measuring device that has been inspected by the department, and at that point, the device owner is responsible for its proper use and maintenance.¹² Each individual who owns or manages a petroleum measuring device must ensure that the device is measuring properly based upon the tolerances¹³ defined by the department.¹⁴

Additionally, s. 525.07(10), F.S., requires each individual who owns or manages a petroleum measuring device to affix or install a security measure to restrict the unauthorized access of customer payment card information.¹⁵ Individuals must remedy any inadequate security measure within five days of receiving a written notice of noncompliance from the department.¹⁶ After the fifth day of noncompliance, further use of the retail petroleum measuring device may be prohibited by the department, and a repeat violation found on the same device is cause for the

measuring device to immediately be taken out of service.¹⁷ The department may also seize any skimming device¹⁸ for use as evidence.¹⁹

For violations of ch. 525, F.S., the department has the authority to issue warning letters, impose administrative fines, or revoke or suspend any registration issued by the department.²⁰

Card Skimmers

A card skimmer is an electronic device that is illegally installed inside gas pumps to collect a consumer's credit or debit card information when a card is swiped through the reader.²¹ Criminals sell the consumer's information or use the information to make illegal purchases.²² The department has discovered and removed over 4,860 skimmers since 2015.²³ The use, possession, or sale of a skimmer is punishable as a third-degree felony under Florida law.²⁴

Local Regulations

Currently, local governments are not prohibited from enacting fuel pump security measures that are more restrictive than the rules established by the department. For instance, Lee County requires each fuel pump to be equipped with a visible lock, a system that would render the pump inoperable if it is accessed without a security code, or a device that encrypts customer payment card information.²⁵ Failure to affix an adequate security measure may result in fines of \$250 per gas pump for every day that the appropriate devices are not installed.²⁶ Collier County,²⁷ Charlotte County,²⁸ and the Village of Estero²⁹ also have local fuel pump ordinances.

Preemption

Local governments have broad authority to legislate on any matter that is not inconsistent with federal or state law. A local government enactment may be inconsistent with state law if (1) the Legislature has preempted a particular subject area or (2) the local enactment conflicts with a state statute. Where state preemption applies, it precludes a local government from exercising authority in that particular area.³⁰

Florida law recognizes two types of preemption: express and implied. Express preemption requires a specific legislative statement; it cannot be implied or inferred.³¹ Express preemption of a field by the Legislature must be accomplished by clear language stating that intent.³² In cases where the Legislature expressly or specifically preempts an area, Legislative intent is apparent.³³

In cases determining the validity of ordinances enacted in the face of state preemption, the effect has been to find such ordinances null and void.³⁴ Implied preemption is actually a decision by the courts to create preemption in the absence of an explicit legislative directive.³⁵ Preemption of a local government enactment is implied only where the legislative scheme is so pervasive as to evidence an intent to preempt the particular area, and strong public policy reasons exist for finding preemption.³⁶ Implied preemption is found where the local legislation would present the danger of conflict with the state's pervasive regulatory scheme.³⁷

III. Effect of Proposed Changes:

The bill removes the ability for local jurisdictions to create and enforce regulations regarding petroleum fuel measuring devices that are beyond the rules established by the department.

The bill also eliminates the department's authority to impose penalties under s. 525.16, F.S.,³⁸ for violations of petroleum fuel measuring device rules under s. 525.07(10), F.S.,³⁹ unless an owner or operator of a petroleum fuel measuring device has failed to install a security device or measure.

Additionally, owners and managers of petroleum fuel measuring devices may be able to install less expensive security measures to restrict the unauthorized access of customer payment card information if they are currently subject to more stringent requirements pursuant to a local ordinance.

C. Government Sector Impact:

The department may experience a reduction in assessed administrative penalties or fines. Because the number of violations triggered by a failure to install a security device or measure is indeterminate, the extent of any reduction is unknown.

COMMITTEE SUBSTITUTE - Substantial Changes

I. Summary:

CS/SB 676 creates 12 new specialty license plates, including the following:

- Florida State Parks
- Support Healthcare Heroes
- Inter Miami CF
- Toastmasters
- Gopher Tortoise
- Orlando United
- Biscayne Bay
- Margaritaville
- Protect Marine Wildlife
- Disease Prevention and Early Detection
- Honor Flight
- Ethical Ecotourism

The bill also creates one new special military plate for recipients of the Army of Occupation Award, amends three existing specialty license plates (Florida Indian River Lagoon, Wildlife Foundation of Florida and Divine Nine) and revises requirements for the issuance of certain special license plates. According to the DHSMV, the bill will have a negative, but insignificant fiscal impact associated with programming cost. These cost can be absorbed within existing resources.

The bill has an effective date of October 1, 2021.

II. Present Situation:

Specialty License Plates

Presently, there are 120 specialty license plates available for purchase in Florida¹ and another 33 specialty license plates available for pre-sale², for a total of 153 specialty license plates.³ Specialty license plates are available to an owner or lessee of a motor vehicle who is willing to pay an annual use fee, ranging from \$15 to \$25, paid in addition to required license taxes and service fees.⁴ The annual use fees are distributed to an organization or organizations in support of a particular cause or charity signified on the plate's design and designated in statute.⁵ In order to establish a specialty license plate and after the plate is approved by law, s. 320.08053, F.S., requires the following actions within certain timelines:

- Within 60 days, the organization must submit an art design for the plate, in a medium prescribed by the DHSMV;
- Within 120 days, the DHSMV must establish a method to issue pre-sale vouchers for the specialty license plate; and
- Within 24 months after the pre-sale vouchers are established, the organization must obtain a minimum of 3,000 voucher sales, or in the case of an out-of-state college or university license plate, 4,000 voucher sales, before manufacturing of the plate may begin.

If the minimum sales requirement has not been met by the end of the 24-month pre-sale period, then the DHSMV will discontinue the plate and issuance of pre-sale vouchers. Upon discontinuation, a purchaser of a presale voucher may use the annual use fee as a credit towards any other specialty license plate or apply for a refund with the DHSMV.⁶

New specialty license plates that have been approved by law but are awaiting issuance will be issued in the order they appear in s. 320.08058, F.S., provided that they have met the presale requirement. If the next awaiting specialty license plate has not met the presale requirement, the department will proceed in the order provided in s. 320.08058, F.S., to identify the next qualified specialty license plate that has met the presale requirement.⁷

If the Legislature has approved 150 or more specialty license plates, the DHSMV may not make any new specialty license plates available for design or issuance until a sufficient number of plates are discontinued so that the number of plates being issued does not exceed 150.⁸

The annual use fees collected by an organization and any interest earned from the fees may be expended only for use in this state unless the annual use fee is derived from the sale of specified United States Armed Forces and veterans-related specialty plates.⁹ Additionally, organizations must adhere to certain accountability requirements, including an annual audit or attestation document affirming that funds received have been spent in accordance with applicable statutes.¹⁰

DHSMV Costs Defrayed

The DHSMV is authorized to retain a sufficient portion of annual use fees collected from the sale of specialty plates to defray its costs for inventory, distribution, and other direct costs associated with the specialty license plate program. The remainder of the proceeds collected are distributed as provided by law.¹¹

Discontinuance of Specialty Plates

The DHSMV must discontinue the issuance of an approved specialty license plate if the number of valid registrations falls below 1,000 plates for at least 12 consecutive months. A warning letter is mailed to the sponsoring organization following the first month in which the total number of valid specialty license plate registrations is below 1,000 plates. Collegiate plates for Florida universities are exempt from the minimum specialty license plate requirement.¹² In addition, the DHSMV is authorized to discontinue any specialty license plate if the organization no longer exists, stops providing services that are authorized to be funded from the annual use fee proceeds, or pursuant to an organizational recipient's request.¹³

However, effective July 1, 2023, the requirement increases so that the DHSMV must discontinue the issuance of an approved specialty license plate if the number of valid registrations falls below 3,000 or in the case of an out-of-state college or university license plate, 4,000, for at least 12 consecutive months. The DHSMV must mail a warning letter to the sponsoring organization following the first month in which the total number of valid specialty plate registrations is below 3,000, or in the case of an out-of-state college or university license plate, 4,000. This does not apply to in-state collegiate license plates established under s. 320.08058(3), license plates of institutions in and entities of the State University System, specialty license plates that have statutory eligibility limitations for purchase, specialty license plates for which annual use fees are distributed by a foundation for student and teacher leadership programs and teacher recruitment and retention, or Florida Professional Sports Team license plates established under s. 320.08058(9).¹⁴

Existing Specialty License Plates

Florida Indian River Lagoon Specialty License Plate

Section 320.08058(10), F.S., provides that the first \$5 million in revenues collected annually from the Florida Indian River Lagoon (IRL) license plate must be transferred to the St. Johns River Water Management District. The district must account for these funds separate from all other funds received and must distribute the funds to the applicants awarded funds.

The application for award of Florida IRL license plate annual use fees is administered by the St. Johns River and South Florida Water Management Districts for IRL projects and in accordance with their contracting and purchasing policies and procedures, with the select restrictions on how the fees are to be used.¹⁵

Section 320.08058(10)(d), F.S., provides that it is the intent of the Legislature that revenues generated by the Florida IRL license plate annual use fees must not be used as replacement funds for Surface Water Improvement and Management Act funds, but must be used solely for the enhancement of the IRL area.

Fish & Wildlife Foundation of Florida Specialty License Plate

The Fish & Wildlife Foundation of Florida, Inc., a nonprofit 501(c)(3) organization, was formed on September 29, 1994, as a nonprofit organization to support the health and well-being of Florida's fish and wildlife resources and their habitats. They are the citizen-support organization of the Florida Fish and Wildlife Conservation Commission and work with a variety of other public and private organizations to achieve science-based conservation, research, education, and outdoor recreation goals. Their grant making traditionally focuses on providing outdoor education and recreational opportunities for youth, combatting invasive species like lionfish, improving management of wildlife habitats and fisheries, protecting Florida's freshwater springs, and improving public access to hunting, fishing and boating resources.¹⁶

Divine Nine Specialty License Plate

Section 320.08058(101), F.S., provides for the annual use fees from the Divine Nine license plate to be distributed as follows:

- Five percent of the proceeds shall be distributed to the United Negro College Fund, Inc., for college scholarships for Florida residents attending Florida's historically black colleges and universities.
- The remaining 95 percent of the proceeds shall be distributed to one of the participating fraternities or sororities as selected by the purchaser of the plate. Each of those organizations may use ten percent for marketing of the plate.

License plates created under s. 320.08058(101), F.S., must have their plate sales combined for the purpose of meeting the minimum license plate sales threshold and for determining the license plate limits.

Military Service Special License Plates

Currently, s. 320.089, F.S., authorizes 23 special license plates available to military service members or veterans for certain types of military service. Examples of service include Veteran of the U.S. Armed Forces, World War II Veteran, and Woman Veteran. While anyone who pays the appropriate fees may purchase most specialty license plates, one must provide proof of eligibility to obtain a military special license plate.

Military special license plates are each stamped with words consistent with the type of special license plate issued. A likeness of the related campaign medal or badge appears on the plate followed by the license plate serial number.

Applicants for special license plates are required to pay the annual license tax¹⁷ with the exception of certain disabled veterans who qualify for the Pearl Harbor, Purple Heart, or Prisoner of War plate, to whom such plates are issued at no cost.¹⁸ The first \$100,000 of the revenue generated annually from the issuance of special use plates is deposited into the Grants and Donations Trust Fund under the Veterans' Nursing Homes of Florida Act. Any additional revenue is deposited into the State Homes for Veterans Trust Fund and used to construct, operate, and maintain domiciliary and nursing homes for veterans.¹⁹

Army of Occupation Medal

The Army Occupation Medal was established by War Department Circular 102, dated April 5, 1946. The medal was designed by Mr. Thomas Hudson Jones and the first medal was presented to General Eisenhower on April 2, 1947. The ribbon design uses the color black to represent Germany and the color red to represent Japan. On February 4, 1948, the Secretary of the Navy requested the Heraldic Section, Department of the Army, design a suitable Navy Occupation Service Medal. This medal was designed by Mr. Thomas Hudson Jones on March 30, 1948. The service clasp is worn on the suspension ribbon to indicate area of occupation. The Berlin Airlift Device is a miniature of a C-54 type aircraft and is worn on the suspension ribbon and service ribbon to indicate 90 days consecutive service between June 26, 1948 and September 30, 1949.²⁰

The Army Occupation Medal was awarded for 30 days consecutive service while assigned to Germany, Austria, Italy, Japan, and Korea during specific periods of time during 1945 to 1990.²¹

Emergency Medical Services Trust Fund

Funds deposited into the Emergency Medical Services Trust Fund must be used solely to improve and expand prehospital emergency medical services in the state. The Department of Health (DOH) must annually dispense funds contained in the Emergency Medical Services Trust Fund as follows:

- Forty-five percent of funds must be divided among the counties according to the proportion of the combined amount deposited in the trust fund from the county. These funds may not be used to match grant funds identified below. An individual board of county commissioners may distribute these funds to emergency medical services organizations and youth athletic organizations within the county, as it deems appropriate;
- Forty percent of funds must be used by the DOH for making matching grants to local agencies, municipalities, emergency medical services organizations, and youth athletic organizations for the purpose of conducting research, increasing existing levels of emergency medical services, evaluation, community education, injury-prevention programs, and training in cardiopulmonary resuscitation and other lifesaving and first aid techniques; and
- Fifteen percent of funds must be used by the DOH for capital equipment outlay, personnel, community education, evaluation, and other costs associated with the administration of ch. 401, F.S. (Medical Telecommunications and Transportation). Any funds not annually used for this purpose must be used for making additional rural grant funds available.²²

Community Organizations

Florida State Parks Foundation, Inc.

The Florida State Parks Foundation, Inc., founded in 1993, supports the Florida State Park system through programs that preserve and protect state parks, educate visitors about the value of state parks, encourage community engagement and active use of state parks, and provide financial support to supplement state funding. The foundation is a non-profit Florida corporation under s. 501(3)(c) of the Internal Revenue Code.^{23, 24}

Inter Miami CF

The Inter Miami CF Foundation Corporation²⁵ is an organization which uses the game of soccer as a catalyst for positive change in the South Florida community. They focus on education and empowerment, access and inclusion and health and wellness for kids and young adults in underserved communities. The Inter Miami CF Foundation Corporation uses the clubs reach, expertise and resources to strategically plan and execute sports-based development and direct-service community programs, initiatives and events. They invest in, enhance and support existing organizations that align with their mission while developing their own programs: all with the goal of measurable results and scalable impact.²⁶

Toastmasters International

Toastmasters began as a series of speaking clubs organized by Ralph C. Smedley during his time working for the YMCA (Young Men's Christian Association). Smedley was director of education at the YMCA and he saw a need for the men in the community to learn how to speak,

conduct meetings, plan programs and work on committees. He decided to organize a club where they could learn these skills in a social environment. He named this group the Toastmasters Club; "toastmaster" was a popular term that referred to a person who gave toasts at banquets and other occasions.²⁷

Since 1924, Toastmasters International has helped people from diverse backgrounds become more confident speakers, communicators, and leaders. Toastmasters International is a non-profit educational organization that teaches public speaking and leadership skills through a worldwide network of clubs. The organization's membership exceeds 358,000 in 142 countries.²⁸

Toastmasters International is not listed in the Department of State Division of Corporations sunbiz.org database as a Florida business entity.

In 1965 the Ralph C. Smedley Memorial Fund was established to honor and uphold Ralph C. Smedley's legacy and to open doors for the many millions of potential Toastmaster yet to come. Though the historic fund had humble beginnings with a local impact, the reinvigorated Smedley Fund retains its same purpose—the advancement of communication and leadership education through the research, development, and distribution of educational programs and materials.²⁹

Wildlands Conservation, Inc.

The Wildlands Conservation is a non-profit organization, created in 2003³⁰, specializing in conservation planning and policy, land management, land protection, research, education and outreach. The Wildlands Conservation works on conservation projects throughout Florida. They strive to work with landowners and others around the state to maximize conservation and minimize impacts, which can be costly to that landowner³¹. Wildlands offers gopher tortoise relocation in attempt to save tortoises from sites permitted for development. They are committed to ensuring that gopher tortoise survey and relocation work is done thoroughly and professionally as possible to protect gopher tortoises across the state³².

Mental Health Association of Central Florida, Inc.

The Mental Health Association of Central Florida³³ has been serving the mental health needs of Orange, Osceola, Seminole, Brevard, and Lake counties since 1946. Their mission is to provide

mental health services, support and information to the members of the Orlando and surrounding Central Florida community.³⁴

onePULSE Foundation, Inc.

The onePULSE Foundation³⁵ was established to create a sanctuary of hope following the tragic day of June 12, 2016. The foundation was created to honor the 117 victims and the countless first responders and healthcare professionals who treated them. The foundation is intended to support a memorial that opens hearts, a museum that opens minds, educational programs that open eyes and endowed scholarships that open doors. All donations are used for the construction and operation of the National memorial and museum, educational programs and 49 Legacy Scholarships. ³⁶

Two Spirit Health Services, Inc.

Two Spirit Health Services³⁷ is a non- profit corporation incorporated in 2011. They provide mental health, behavioral, substance abuse, primary care, transgender health, and related services to individuals in the Lesbian, Gay, Bisexual and Transgender community who live in and around the Central Florida area.³⁸

The Miami Foundation, Inc.

The Miami Foundation, founded in 1967,³⁹ seeks to encourage philanthropy and charitable giving by developing a permanent endowment to meet current and future emerging charitable needs. Grants are made in broad program areas including education, health, human services, arts and culture, the environment, and community and economic development. In addition, field of interest and special funding initiatives have enabled significant grant making addressing the issues of abused and neglected children, immigrants and refugees, AIDS, homelessness, social justice, African-American affairs, care of animals, and heart disease.⁴⁰

SFC Charitable Foundation, Inc.

The SFC Charitable Foundation, Inc., was founded in 1994.⁴¹ The SFC Charitable Foundation, Inc., does business as the Singing for Change Foundation, which is a private foundation established in 1995 by Jimmy Buffett, as a way of saying thank you to the friends, fans, and concert-goers around the country who have loyally supported his music career.⁴²

Initially funded with contributions from Jimmy Buffett's 1995 summer tour, Singing for Change continues to receive one dollar from each concert ticket sold during his tours. Printed on the bottom of each ticket is the words "\$1 to SFC Charitable Foundation." Funds raised during Jimmy Buffett's concert tours are redistributed each year in the form of grants to small, grassroots organizations located primarily in communities where he performs. Singing for Change has disbursed almost \$11 million in grants in its 23-year history.⁴³

Protect Wild Dolphins Alliance, Inc.

Protect Wild Dolphins Alliance, Inc.,⁴⁴ d/b/a Protect Wild Dolphins, operates exclusively for charitable, scientific, and educational purposes, including but not limited to the support and conduct of research, scientific and educational activities for the protection and preservation of marine mammals, including, but not limited to, release to the wild programs, the rescue, rehabilitation, release and/or retirement of marine mammals as well as the establishment and operation of a safe haven for unwanted and/or surplus dolphins and other marine mammals. Protect Wild Dolphins Alliance rescues and rehabilitates stranded marine mammals in order to advance science and education in marine wildlife health and conservation and believes in the humane treatment of all sick and injured marine animals and seeks to advance the One Ocean One Health concept in order to protect ocean heritage.⁴⁵

The Women's Breast & Heart Initiative, Florida Affiliate, Inc.

The Women's Breast & Heart Initiative (WBHI), established in 2005, is a nonprofit outreach organization piloting communities toward lifesaving, preventive self-care. Through boots-on-theground education and screening initiatives, WBHI encourages and supports social responsibility, community organization and the good health of women. Through strategic partnerships with local colleges and universities, health care partners and professional entities, WBHI has established a network of dedicated and compassionate volunteers. Their relationships with professors and student volunteers in particular help further their goals and provide real-time examples of how the power of the individual can enact social change.⁴⁶

Honor Flight

Honor Flight's mission is to transport America's veterans to Washington, D.C., to visit the memorials dedicated to honoring those who have served and sacrificed for our country. It is a national network of independent hubs working together to further Honor Flight's mission. The network currently serves veterans from World War II, the Korean War, and the Vietnam War, as well as terminally ill veterans who served during any era.⁴⁷ Florida's Honor Flight Network hubs are non-profit corporations under s. 501(c)(3) of the Internal Revenue Code. Honor Flight Hubs

in Florida include Collier-Lee, First Coast, Central Florida, West Central Florida, South Florida, Tallahassee, Southeast Florida, Southwest Florida, Space Coast, and The Villages.⁴⁸

Florida Society for Ethical Ecotourism

In 1998 the CREW Land and Water Trust and the Florida Department of Environmental Protection Rookery Bay National Estuarine Research Reserve received a grant from the Advisory Council of Environmental Education, within the Florida Game & Fresh Water Fish Commission, to provide an educational workshop for ecotour providers of Southwest Florida. As a result of the grant, a day-long Southwest Florida Eco/Heritage Tourism Workshop took place in downtown Ft. Myers in which 85 people participated.⁴⁹

Following the workshop, a group of volunteers from Southwest Florida communities met and formed the Society for Ethical Ecotourism in Southwest Florida. In 2011 they changed their name to the Florida Society for Ethical Ecotourism, Inc.⁵⁰ The Florida Society for Ethical Ecotourism, Inc., is registered as an active nonprofit corporation with the DOS.⁵¹

Paddle Florida, Inc.

Paddle Florida, Inc., is a nonprofit corporation⁵² organized to support canoeing and kayaking in Florida. The organization supports multi-day paddling/camping trips in each of Florida's five water management districts, showcasing the state's natural beauty and rich cultural heritage while promoting water conservation, wildlife preservation, springs restoration, and waterways protection. Paddle Florida seeks to promote Florida as an international destination for nature-based tourism.⁵³

III. Effect of Proposed Changes:

Existing Specialty License Plates (Section 2)

Florida Indian River Lagoon License Plate

The Indian River Lagoon (IRL) was nominated as an Estuary of National Significance and joined the National Estuary Program in 1990 under the sponsorship of the St. Johns and South Florida Water Management Districts and was formally established in 1991. The IRL National Estuary Program is part of a national network of twenty-eight estuary programs established under the Federal Clean Water Act and administered nationally by the United States Environmental Protection Agency. The Program's Comprehensive Conservation and Management Plan was published in 1997 and updated in 2008.⁵⁴

The IRL Council was established in February 2015 as a special district of Florida. The IRL Council includes representatives of five counties bordering the lagoon (Volusia, Brevard, St. Lucie and Martin counties and the Indian River County Lagoon Coalition,), the St. Johns River and South Florida Water Management Districts, and the Florida Department of Environmental Protection.⁵⁵

The bill amends s. 320.08058(10), F.S., to direct the distribution of the first \$5 million collected each year to the IRL Council, who will also account for the transfer and distribution of funds, instead of the St. Johns River Water Management District, and states the Legislature supports the restoration efforts of the IRL National Estuary Program and its partners and intends for the Florida Indian River Lagoon license plate to provide a continuous funding source to support this worthwhile effort and to heighten public awareness of this economically significant resource.

The bill directs the IRL Council to administer projects in Volusia, Brevard, and Indian River Counties from funds derived from the appropriate percentage of license plate revenues, and for the South Florida Water Management District to administer projects in St. Lucie, Martin, and Palm Beach counties.

The bill provides that in Volusia County, project implementation may occur in all estuarine waters extending north to and including the Indian River Lagoon National Estuary Program's Indian River Lagoon-Halifax River planning boundary amendments that include the Tomoka Basin and in Palm Beach County, first priority must be given to projects within the Indian River Lagoon, and second priority must be given to projects within adjacent estuarine waters, including the Loxahatchee River and other tributaries to the Indian River Lagoon.

The bill provides that it is the intent of the Legislature that revenues generated by the Florida Indian River Lagoon license plate annual use fees must not be used as replacement funds for other available funding sources but must be used solely for the enhancement of the Indian River Lagoon and tributaries in the Indian River Lagoon watershed as defined by the Indian River Lagoon National Estuary Program project boundary defined in the Indian River Lagoon Comprehensive Conservation and Management Plan or as provided in this section.

Wildlife Foundation of Florida License Plate

The bill amends s. 320.08058(46), F.S., to update the name of the Florida Fish and Wildlife Conservation Commission citizen support organization to the Fish & Wildlife Foundation of Florida, Inc., and requires that 75 percent of the annual revenues from the sale of the license plate must be encumbered to fund programs and projects within the state that preserve open space and wildlife habitat, promote conservation, promote hunting and shooting sports, improve wildlife habitat, and establish open space for the perpetual use of the public. Unencumbered funds from one year may be carried over to the following year, but must be spent within 2 years of receipt or dedicated to a project within 2 years of receipt in the form of a contract, a grant award, or an approved plan by the governing board of the Fish & Wildlife Foundation of Florida, Inc.

Divine Nine License Plate

The mission of the Association to Preserve African American Society, History and Tradition is to collect, preserve and exhibit historical artifacts and information which illustrate the meaningful role African Americans have played in the Orlando area and the State of Florida. The Association is dedicated to collecting and exhibiting memorabilia which commemorate the achievements of African Americans educators, athletes, musicians, religious, civic, and cultural leaders.⁵⁶

The bill amends s. 320.08058(101), F.S., to remove the portion of revenues distributed to the eligible organizations, and instead directs 10 percent of the proceeds must be distributed to the Association to Preserve African-American Society, History, and Tradition, Inc., solely for the marketing of the plate.

The bill also provides that to be eligible for issuance of a Divine Nine license plate representing an eligible organization, a person must be a resident of Florida who is the registered owner of a motor vehicle and who is a member of the applicable organization. The person must also present proof of membership in the organization, which may be established by:

- A card distributed by the organization indicating the person's membership in the organization; or
- A written letter on the organization's letterhead which is signed by the organization's national president or his or her designated official and which states that the person was inducted into the organization.

Proof of membership in an eligible organization is required only for initial issuance of a Divine Nine license plate. A person need not present such proof for renewal of the license plate.

In addition, a Divine Nine license plate:

- May be personalized;
- Notwithstanding any other law to the contrary, may be displayed on a privately owned passenger motor vehicle, pickup truck, boat, or pleasure motor vehicle including, but not limited to, a recreational vehicle; and
- May not be transferred between vehicle owners.

New Specialty License Plates (Sections 1 and 2)

Florida State Parks License Plate

The bill directs the DHSMV to develop the Florida State Parks specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Explore Our State Parks" at the bottom of the plate.

The bill directs the annual use fees from the sale of the plate to be distributed to the Florida State Parks Foundation, Inc. Up to 10 percent of the fees from the sale of the plate may be used for

marketing the plate and costs directly associated with the administration of the Florida State Parks Foundation.

Support Healthcare Heroes License Plate

The bill directs the DHMSV to develop a Support Healthcare Heroes specialty license plate bearing the colors and design approved by the DHSMV. The word "Florida" must appear at the top of the plate, and the words "Support Healthcare Heroes" must appear at the bottom of the plate.

The annual use fees from the sale of the plate must be distributed annually into the Emergency Medical Services Trust Fund within the Department of Health to provide financial support for prehospital medical services pursuant to s. 401.113, F.S.

Inter Miami CF License Plate

The bill directs the DHSMV to develop the Florida Inter Miami CF specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Inter Miami CF" at the bottom of the plate.

The bill directs the annual use fees to be distributed to Inter Miami CF Foundation Corporation, a nonprofit corporation under s. 501(c)(3) of the Internal Revenue Code, which may use a maximum of 10 percent of the proceeds to promote and market the plate. The remainder of the proceeds must be used by the Inter Miami CF Foundation Corporation to plan and execute sports-based development and direct-service community programs, initiatives, and events.

Toastmasters License Plate

The bill directs the DHSMV to develop the Florida Toastmasters International specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "www.Toastmasters.org" at the bottom of the plate.

The bill directs the annual use fees to be distributed to the Ralph C. Smedley Memorial Fund of Toastmasters International, of which:

- Twenty-five percent shall be used to develop charitable and educational programs for the indigent, homeless, visually and hearing disabled, incarcerated, and youth populations that are unable to afford or to participate in established Toastmasters programs.
 - Up to 5 percent of this distribution may be used for administrative expenses.
- Seventy-five percent shall be proportionally redistributed to the divisions of Districts 47, 48, 77, and 84 of Toastmasters International which reside in this state.
 - Up to 5 percent of this distribution may be used for marketing of the plate
- The remainder shall be used for educators, nonprofits, governmental organizations, scholarships, materials, and computers and other equipment for the purpose of implementing the charitable and educational programs for the indigent, homeless, visually and hearing disabled, incarcerated, and youth populations that are unable to afford or to participate in the established Toastmasters programs.

Gopher Tortoise License Plate

The bill directs the DHSMV to develop the Florida Gopher Tortoise specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Protect the Gopher Tortoise" at the bottom of the plate.

The bill directs the annual use fees to be distributed to Wildlands Conservation, Inc., to fund gopher tortoise and commensal species research, education, and conservation, as well as upland habitat protection, restoration, and management in this state. Up to 15 percent of the funds received by Wildlands Conservation, Inc., may be used for marketing of the plate and costs directly associated with the administration of the gopher tortoise protection program. Wildlands Conservation, Inc., shall use and distribute the funds to eligible Florida-based scientific, conservation, and educational organizations for gopher tortoise and upland habitat research, conservation, and management.

Orlando United License Plate

The bill directs the DHSMV to develop the Florida Orlando United specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Orlando United" at the bottom of the plate.

The bill directs the annual use fees to be distributed as follows:

- Five percent shall be distributed to the Mental Health Association of Central Florida, Inc., to be used for marketing of the license plate.
- Thirty-one percent shall be distributed to the Mental Health Association of Central Florida, Inc.
 - Of this amount, up to 5 percent may be used for administrative expenses.
 - The remainder shall be used to offer free personalized counseling to any person affected by the shooting at the Pulse nightclub in Orlando on June 12, 2016.
- Two percent shall be distributed to onePULSE Foundation, Inc., to be used for marketing of the license plate.
- Thirty-one percent shall be distributed to onePULSE Foundation, Inc.
 - Of this amount, up to 5 percent may be used for administrative expenses.
 - The remainder shall be used to support the construction and maintenance of the onePULSE Foundation Memorial.
- Thirty-one percent shall be distributed to Two Spirit Health Services, Inc.
 - Of this amount, up to 5 percent may be used for administrative expenses.
 - The remainder shall be used to offer free personalized counseling to any person affected by the shooting at the Pulse nightclub in Orlando on June 12, 2016.

Biscayne Bay License Plate

The bill directs the DHSMV to develop the Florida Biscayne Bay specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Protect Biscayne Bay" at the bottom of the plate.

The bill directs the annual use fees to be distributed to the Miami Foundation, Inc., a Florida nonprofit corporation, to be used as follows:

- Up to 10 percent of the fees may be used for promotion and marketing of the license plate and for direct reimbursement for administrative costs, startup costs, and costs incurred in the development and approval process of the license plate. All vendors associated with administrative costs shall be selected by competitive bid.
- The remaining fees shall be used to raise awareness and support the mission and efforts of conserving Biscayne Bay. The Miami Foundation Board of Trustees must approve and is accountable for all such expenditures.

Margaritaville License Plate

The bill directs the DHSMV to develop a Margaritaville specialty license plate bearing the colors and design approved by the DHSMV. The word "Florida" must appear at the top of the plate, and the word "Margaritaville" must appear at the bottom or the side of the plate.

The bill directs the DHSMV to retain all annual use fees from the sale of the plate until all startup costs for developing and issuing the plate have been recovered. Thereafter, up to 10 percent of the annual use fee revenue may be used for administration, promotion, and marketing of the specialty license plate. All remaining proceeds shall be used by the SFC Charitable Foundation, Inc., to provide grants to nonprofit organizations in communities impacted by natural or manmade disasters for purposes of recovery, rebuilding, and future sustainability and to promote and inspire local grassroots leaders who work to improve the quality of life in those communities and other communities in this state.

Protect Marine Wildlife License Plate

The bill directs the DHSMV to develop a Protect Marine Wildlife specialty license plate bearing the colors and design approved by the DHSMV. The word "Florida" must appear at the top of the plate, and the word "Protect Marine Wildlife" must appear at the bottom of the plate.

The bill directs the DHSMV to retain all annual use fees from the sale of the plate until all startup costs for developing and issuing the plate have been recovered. Thereafter, up to 10 percent of the annual use fee revenue may be used for administration, promotion, and marketing of the specialty license plate. All remaining proceeds shall be used by the Protect Wild Dolphins Alliance, Inc., to fund its conservation, research, and educational programs that focus on the conservation of Florida's threatened and protected marine wildlife species.

Disease Prevention & Early Detection License Plate

The bill directs the DHSMV to develop the Florida Disease Prevention & Early Detection specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Disease Prevention & Early Detection" at the bottom of the plate.

The bill directs the annual use fees to be distributed to the Women's Breast & Heart Initiative, Florida Affiliate, Inc., which may use a maximum of 10 percent of the proceeds to promote and market the plate. The remainder of the proceeds shall be used by The Women's Breast & Heart Initiative, Florida Affiliate, Inc., to provide increased education and awareness relating to early detection, 28 prevention, and screening of breast and heart issues.

Honor Flight License Plate

The bill directs the DHSMV to develop the Florida Honor Flight specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and "Honor Flight" at the bottom of the plate.

The annual use fees from the sale of the plate must be distributed equally among the Honor Flight Network hubs in this state, each of which is a nonprofit corporation under s. 501(c)(3) of the Internal Revenue Code, to be used as follows:

- Up to 10 percent of the fees may be used for promotion and marketing of the license plate.
- The remaining fees must be used to further the Honor Flight Network's mission of transporting military veterans to Washington, D.C., in order to visit the memorials dedicated to honoring those who have served and sacrificed for the United States.

The bill also amends s. 320.08056, F.S., to exclude the Honor Flight license plate from the restriction that all fees and any interest earned from the fees may be expended only for use in this state.

Ethical Ecotourism License Plate

The bill directs the DHSMV to develop the Florida Ethical Ecotourism specialty license plate bearing the colors and design approved by the DHSMV. The new license plates will display the word "Florida" at the top of the plate and words approved by the DHSMV must appear at the bottom of the plate.

The bill directs the annual use fees to be distributed equally between the Florida Society for Ethical Ecotourism and Paddle Florida, Inc., each of which may use up to 10 percent of such proceeds for administrative costs and the marketing of the plate. The remaining proceeds must be used by the Florida Society for Ethical Ecotourism to provide environmental education and awareness that encourage behaviors that contribute to the sustainability of Florida's natural ecosystems and resources and by Paddle Florida, Inc., to raise awareness about water conservation, wildlife preservation, restoration of springs, and protection of waterways in this state.

Special License Plates (Section 3)

The bill amends s. 320.0807(5), F.S., to remove the prior to January 1, 2021, service period eligibility requirement that an applicant must have served as President of the Senate or Speaker of the House of Representatives in order to be issued a license plate stamped "Senate President" and "House Speaker" followed by the number assigned by the DHSMV or chosen by the applicant if it is not already in use.

New Military Service Special License Plate (Section 4)

Army of Occupation Veterans License Plate

The bill amends s. 320.089, F.S., to create the Army of Occupation Veterans license plate. The owner or lessee of an automobile or truck for private use, a truck weighing not more than 7,999 pounds, or a recreational vehicle,⁵⁷ which is not used for hire or commercial use who is a resident of this state and a current or former member of the United States military who was permanently assigned to occupation forces in specific overseas locations during the Cold War between May 9, 1945, and October 2, 1990, upon application to the DHSMV accompanied by proof of active membership or former active duty status during this period at one of these locations and payment of the license tax for the vehicle, will be issued a license plate which, in lieu of the registration license number is stamped with the words "Army of Occupation" and a likeness of the Army of Occupation Medal, followed by the registration license number of the plate. Proof that the applicant was awarded the Army of Occupation Medal will be sufficient to establish eligibility for the license plate.

The bill has an effective date of October 1, 2021.

B. Private Sector Impact:

Once the license plates goes into production, organizations receiving license plate revenue may receive additional revenues associated with the sale of the corresponding license plates.

Current law prohibits the redesign of a specialty license plate unless the inventory of the license plate has been depleted. However, the organization may purchase the remaining inventory of the specialty license plate from the DHSMV at the DHSMV's cost.⁵⁸ Should any of the organizations associated with specialty license plates that have been amended desire to redesign their plates they may be required to purchase the remaining inventory of its specialty license plates at the DHSMV's cost prior to the authorized redesign of these specialty license plates.

C. Government Sector Impact:

Programming will be required initially to allow the DHSMV to accept vouchers, but the DHSMV may not finalize a design or issue the new license plate if the 150 cap is reached prior to the license plate selling 3,000 vouchers. The amount of programming is determined by the number of plates and the number of distributions per plate. One specialty license plate with a single distribution recipient will require between 200 to 250 hours of programming. Additional distributions will generally require an additional 5 to 10 hours per distribution.⁵⁹

The DHSMV is authorized to retain revenues from the first proceeds of specialty license plate sales to defray departmental expenditures related to the specialty license plate program.⁶⁰

The first \$100,000 in general revenue generated from the sale of special license plates issued under s. 320.089, F.S., (to include the Army of Occupation Veterans license plate) is deposited into the Grants and Donations Trust Fund within the Florida Department of Veterans' Affairs, to be used for the purposes established by s. 296.38(2), F.S.⁶¹ Any additional general revenue generated from the sale of such plates is deposited into the Operations and Maintenance Trust Fund within the Department of Veterans' Affairs and used to support program operations that benefit veterans or the operation, maintenance, or construction of domiciliary and nursing homes for veterans, subject to the requirements of chapter 216, F.S., (Planning and Budgeting); to the extent that eligible individuals

I. Summary:

CS/SB 1034 creates the following honorary or memorial road and bridge designations:

- Bridge number 100850 on S.R. 60/Courtney Campbell Causeway over Old Tampa Bay in Hillsborough County as "Virginia Creighton Bridge."
- The portion of S.R. 715/Bacom Point Road between W. Morgan Road and S.W. 14th Street in Palm Beach County as "Deputy Sheriff Donta Manuel and Deputy Sheriff Jonathan Wallace Highway."
- The portion of S.R. 100 in Clay County between the Bradford County line and the Putnam County line as "Veterans Honor Highway."
- Upon completion of construction, the interchange at First Coast Expressway/S.R. 23 and Henley Road in Clay County as "Sergeant Eric John Twisdale Memorial Interchange."
- The portion of I-75 between the Charlotte County line bordering DeSoto County and the Lee County line bordering Collier County as "Purple Heart Highway."
- The portion of Davie Boulevard between S.W. 35th Avenue and S.W. 36th Avenue in Broward County as "Rubin Stacy Memorial Boulevard."
- The portion of S.R. A1A between Glenwood Avenue and Park Avenue in Brevard County as "Sophia Nelson Memorial Highway."
- The portion of U.S. 19/S.R. 55 between U.S. 41/S.R. 45/Tamiami Trail and Palm View Road in Manatee County as "Tiffiany Marie Olson Memorial Highway."
- The portion of U.S. 27/S.R. 25 between the Polk County line and the Glades County line in Highlands County as "Deputy William Gentry, Jr., Highway."

- The portion of S.R. 520/W. King Street between S.R. 501/Clearlake Road and S.R. 519/Fiske Boulevard in Brevard County as "Sgt. George Lee Taylor, Sr., Memorial Highway."
- The portion of S.R. 519/Fiske Boulevard between Rosa L. Jones Drive and I-95 in Brevard County as "Dr. Martin Luther King, Jr., Boulevard."
- The intersection of Southwest 23rd Avenue and Southwest 8th Street in the City of Miami, Miami-Dade County, as "Arturo Diaz Artiles Plaza."

The bill directs the Florida Department of Transportation (FDOT) to erect suitable markers.

The estimated cost to the FDOT to install the designation markers required under the bill is \$12,000. See Section V, "Fiscal Impact Statement," for details.

The bill takes effect July 1, 2021.

II. Present Situation:

Section 334.071, F.S., provides that legislative designations of transportation facilities are for honorary or memorial purposes or to distinguish a particular facility. Such designations are not to be construed as requiring any action by local governments or private parties regarding the changing of any street signs, mailing addresses, or 911 emergency telephone number system listings, unless the legislation specifically provides for such changes.¹

When the Legislature establishes road or bridge designations, the FDOT is required to place markers only at the termini specified for each highway segment or bridge designated by the law creating the designation and to erect any other markers it deems appropriate for the transportation facility.²

The FDOT may not erect the markers for honorary road or bridge designations unless the affected city or county commission enacts a resolution supporting the designation. When the designated road or bridge segment is located in more than one city or county, each affected local government must pass resolutions supporting the designations before installation of the markers.³

Virginia Creighton

Virginia Creighton worked in the field of wetland science and regulation for almost three decades, with a combination of government policy, regulatory, and environmental consulting experience. Ms. Creighton was a certified Professional Wetland Scientist and specialized in formal jurisdictional determinations and wetland qualitative analyses. She acted as an environmental project manager on multiple FDOT and local-level projects, as well as for private developments, including small and large-scale developments of regional impact. She was directly involved in obtaining environmental resource permits for over fifty transportation projects. Ms. Creighton was essential to development of the Courtney Campbell Causeway – Old Tampa Bay Water Quality Improvement project, and she received an award for the Best Project

in Florida from the FDOT in 2018. Ms. Creighton passed away on May 29, 2020, survived by her husband and two sons.⁴

Deputy Sheriffs Donta Manuel and Jonathan Wallace

On November 28, 2007, as other deputies pursued a stolen vehicle that had just passed over "stop sticks"⁵ in the roadway on State Road 715 near Lake Okeechobee, Deputies Manuel and Wallace ran into the roadway in an attempt to remove the stop sticks. Apparently, due to the darkness, Deputies Manuel and Wallace did not perceive the speed at which the pursuing patrol cars were following behind the suspect vehicle. One of the pursuing patrol cars struck and killed both deputies. The driver of that pursuing patrol car was seriously injured and flown to a local hospital. One of the suspects in the stolen vehicle was apprehended a short time later.

Deputy Manuel served with the Palm Beach County Sheriff's Office (PBCSO) for 13 years. He is survived by his wife, Suzette Manuel, sons Donta and Diontray Manuel, and daughter Dashja Trawick.⁶ Deputy Wallace served with the PBSCO for 18 months. He is survived by his mother, Patricia Wallace.⁷

Florida's Veterans

The Florida Department of Veterans Affairs notes that:

Florida has earned a reputation as the most veteran-friendly state in the nation. Our state's veterans bring more than \$18.4 billion federal dollars annually into Florida's economy.

Florida has the third largest population of veterans in the nation after California and Texas with more than 1.5 million veterans -12 percent of the Sunshine State's population 18 and over.⁸

The bill honors Florida's veterans in Clay County and throughout the state.

Sergeant Eric John Twisdale

Sergeant Twisdale served with the Clay County Sheriff's Office (CCSO) for 22 years, having previously served with the Jacksonville Sheriff's Office. One of thousands of law enforcement

officers and other first responders throughout the county who contracted COVID-19 while selflessly serving the public, Sergeant Twisdale passed away on August 16, 2020, at the age of 49, after contracting the infection, presumably from exposure at the Sheriff's Office. Sergeant Twisdale is survived by his children, Katie, Thomas, and Stephanie; his grandchildren, Cain, Declan, Finola, Jameson, and Autumn; his brothers, Norman and Tim; his sister, Debbie; and several aunts, uncles, nieces, nephews, cousins, and his second family, the CCSO.⁹

Purple Heart Highway

The Purple Heart is awarded to members of the U.S. Armed Forces who are wounded by an instrument of war in the hands of the enemy and posthumously to the next of kin in the name of those who are killed in action or die of wounds received in action. It is a combat decoration.¹⁰

Rubin Stacy

Rubin Stacy was born in about 1907 in Thomas County, Georgia. Various sources indicate that in June of 1935, Mr. Stacy was a homeless tenant farmer who was accused of threatening a woman, Marion Jones, in Fort Lauderdale, who let Mr. Stacy into her home after he asked for food or water. Ms. Jones later recanted the accusation. Mr. Stacy was subsequently arrested on a charge of attempted murder and brought to jail in Broward County. After being identified as Ms. Jones' attacker, Mr. Stacy was returned to the Broward County Jail, where "lynching rumors" prompted the Broward County Sheriff, Walter Clark, to move Mr. Stacy to the Dade County jail in Miami. On July 19, 1935, the car transporting Mr. Stacy was attacked and forced off the road. Reports indicate that Mr. Stacy was abducted and taken back to Ms. Jones' home, where he was hung with rope taken from her clothesline. Mr. Stacy, reportedly one of at least 280 people who were hung between 1882 and 1968 in Florida, was survived by a wife and toddler son. No one was indicted for his death.¹¹

Sophia Nelson

In December of 2019, 12-year-old Sophia Nelson was struck and killed by a vehicle while attempting to cross State Road A1A near Ellwood Avenue in Satellite Beach, using a mid-block crosswalk. The driver of the vehicle reportedly applied brakes and slowed down but failed to stop, indicating that she did not see Sophia. No criminal charges were brought against the driver due to a lack of any evidence that the driver was operating the vehicle in a dangerous or reckless

manner. Sophia is survived by her parents, Mark and Jill Nelson, who have supported legislation relating to mid-block crosswalks to reduce driver confusion and increase pedestrian safety.¹²

Tiffiany Marie Olson

On December 7, 2005, 22 year-old Tiffiany Marie Olson was involved in a serious accident while a passenger on a motorcycle. Law enforcement was unable to find any contact information for her family and, by the time they were able to notify her mother, Tiffany had passed away from her injuries. Tiffiany's mother was unable to say goodbye. In her honor, Tiffiany's mother, Christine Olson, worked tirelessly toward a process allowing people to voluntarily have contact information placed in the Driver and Vehicle Information Database of the Department of Highway Safety and Motor Vehicles, facilitating prompt notification in the case of life-threatening crashes.¹³

Deputy William Gentry, Jr.

Deputy Gentry grew up in Fort Myers, joining the Highlands County Sheriff's Office (HCSO) in March of 2005 and joined the K-9 Unit as soon as he could. For four years, he and his K-9 partner, Roni, patrolled the county. When Roni retired from service in 2012, Deputy Gentry transferred back to road patrol, and then to the Special Investigations Unit, targeting illegal drugs until 2013. After a brief period of time using his talents as an artist and woodworker to make custom pool cues, Deputy Gentry returned to the HCSO in 2017, becoming a field training deputy and mentoring young deputies beginning their law enforcement careers. Responding to an animal abuse call with a trainee, Deputy Gentry was shot by a 69 year-old suspect and succumbed to his wounds on May 7, 2018. He is survived by his parents, his younger brother, and his beloved dogs.¹⁴

Sgt. George Lee Taylor, Sr.

George Lee Taylor, Sr., was born in Oak Hill, West Virginia, in 1950 and moved to Florida around 1960. He served in the U.S. Army after high school, from 1967 to 1971, as a Paratrooper with the 173rd Airborne Brigade during the Vietnam War. He served honorably, earning a Purple Heart, Bronze Star, and Combat Infantry Badge. After returning home, he worked tirelessly to address the needs of veterans, with a specific focus on finding homeless camps and the homeless veterans in them to help veterans get the care and housing they deserve. He founded National Veterans Homeless Support in 2008, and he is said to have helped to reduce the homeless veteran population in Brevard County by 90 percent. Mr. Taylor passed away on May 17, 2020.

He is survived by his wife, Jan; two sons, three daughters, three brothers, three sisters, and ten grandchildren.¹⁵

Martin Luther King, Jr.

Martin Luther King, Jr., was a Baptist minister and social activist who led the civil rights movement in the United States from the mid-1950s until his death by assassination in 1968. His leadership led to the ending the legal segregation in the South and other parts of the United States. He rose to national prominence as head of the Southern Christian Leadership Conference, promoting nonviolent efforts to achieve civil rights. He was awarded the Nobel Peace Prize in 1964.

Arturo Diaz Artiles

Arturo Diaz Artiles was a Cuban exile, born in Santa Clara Cuba in 1920 and immigrating to the City of Miami in 1962. In 1965, he opened the Santa Clara Pharmacy at the corner of Southwest 23rd Avenue and Southwest 8th Street in Miami, only the second Cuban-owned pharmacy in the city at the time. Mr. Artiles' pharmacy filled prescriptions, but it served as an important community gathering location for Cuban exiles, especially the elderly. Mr. Artiles operated the pharmacy for nearly 50 years until 2004. During that time, he also received the United Way Dade County Gold award for 30 years of service to his community, the Latin Real Estate Organization Board of Directors Award, and the City's Certification of Appreciation. A founding member of the Latin Chamber of Commerce, the Miami-Dade County Commission issued a proclamation declaring February 25 as Arturo "Arturito" Diaz Artiles Day and presented him with a key to the County. Mr. Artiles passed away on November 11, 2013. He is survived by his three children, Arturo Diaz, Jr., Ana Cepero, and Aixa Schulte.¹⁶

COMMITTEE SUBSTITUTE - Substantial Changes

I. Summary:

CS/SB 1466 revises provisions relating to the Florida Department of Transportation's (FDOT) funding of master planning and eligible aviation development projects at certain publicly owned, publicly operated airports. Currently, the FDOT is generally authorized to fund up to 50 percent of the portion of eligible project costs which are not federally funded but may provide funding at a higher rate, dependent upon the availability of federal funds, as follows:

- If federal funds are *not* available, the FDOT may fund up to 80 percent of master planning and eligible aviation development projects at such airports, and a 20 percent local match is required.
- If federal funds *are* available, the FDOT may fund up to 80 percent of *the non-federal* share of such projects, or 80 percent of the local match requirement.

This funding is currently limited to airports that have no scheduled commercial service. The bill revises this restriction so that the 80 percent funding levels are limited to general aviation airports, or commercial service airports that have been classified as a nonprimary airport by the Federal Aviation Administration.

The bill results in potential funding at the 80 percent funding levels for Vero Beach Regional Airport.

The bill presents no fiscal impact to the FDOT, as the available funding for the identified projects is not revised. The bill may increase by one the number of airports potentially competing

for such funding. The bill may increase opportunities for the identified airport to advance aviation projects. See the "Fiscal Impact Statement" below.

The bill takes effect July 1, 2021.

II. Present Situation:

Airport Oversight

The Federal Aviation Administration (FAA) is responsible for planning and developing a safe and efficient national airport system. This includes all programs related to airport safety and inspections and standards for airport design, construction, and operation. Federal law requires each commercial service airport to operate under a federal certificate and comply with federal aviation requirements. The FAA is responsible for national airport planning and environmental and social requirements and establishes policies related to airport rates and charges, compliance with grant assurances, and airport privatization.¹

At the state level, the FDOT is responsible for planning airport systems and promoting the further development and improvement of airport facilities.² The owner or lessee of a proposed public airport³ must receive the FDOT's approval before site acquisition, construction, or establishment of a public airport facility.⁴ The FDOT is also responsible for licensing public airport facilities before the operation of aircraft to or from the facility and must inspect such facilities prior to licensing or license renewal.⁵ Florida law authorizes local governments to establish and operate airports⁶ and governs airport zoning and land use issues.⁷

FAA Airport Categories

Under federal regulations:

- A general aviation airport is a public-use airport that, as determined by the FAA, does not have scheduled service or has scheduled service of less than 2,500 passenger boardings each year.⁸
- A commercial service airport is defined as a public airport that the FAA determines has at least 2,500 commercial passenger boardings each year and is receiving scheduled passenger service.⁹

- A large hub airport is a commercial service airport that has at least 1 percent of the commercial passenger boardings in United States.¹⁰
- A medium hub airport is a commercial service airport that has at least 0.25 percent but less than 1 percent of the commercial passenger boardings in the United States.¹¹
- A small hub airport is a commercial service airport that has at least 0.05 percent but less than 0.25 percent of the commercial passenger boardings in the United States.¹²
- A non-hub airport has less than 0.05 percent of all commercial passenger boardings in the United States but has more than 10,000 passenger boardings.¹³
- Nonprimary airports are commercial service airports that have at least 2,500 and no more than 10,000 passenger boardings each year.¹⁴
- Primary airports are commercial service airports that have more than 10,000 passenger boardings each year.¹⁵

Federal Airport Funding

Airports receive federal grants administered by the FAA. The main grant program for federal funds is the Airport Improvement Program (AIP). The AIP provides grants to public agencies (and, in some cases, to private owners and entities) for the planning and development of public-use airports.¹⁶

Eligible AIP projects include airport improvements related to enhancing airport safety, capacity, security, and environmental concerns. In general, airports may receive AIP funds for most airfield capital improvements or rehabilitation projects and, in some specific situations, for terminals, hangars, and nonaviation development. Certain professional services that are necessary for eligible projects may also be eligible. The FAA must be able to determine that the projects are justified based on civil aeronautical demand. The projects must also meet federal environmental and procurement requirements.¹⁷

State Airport Funding

Sections 332.003 through 332.007, F.S., create the Florida Airport Development and Assistance Act (Act). The act sets a number of duties of the FDOT, including, but not limited to:

- Providing coordination and assistance for the development of a viable aviation system.
- Assisting airport sponsors in airport master planning.
- Providing financial and technical assistance to public agencies operating public-use airports¹⁸ by making resources available on a cost-reimbursement basis to such agencies for special needs of limited duration.
- Administering the FDOT's participation in the program of aviation and airport grants.
- Encouraging the maximum allocation of federal funds to local airport projects in this state.¹⁹

Section 332.007, F.S., relates to the administration and financing of aviation and airport programs and projects. The FDOT must prepare and continuously update an aviation and airport work program based on a collection of the local sponsors'²⁰ proposed projects to be included in the FDOT's work program.²¹ The FDOT's airport work program must separately identify development projects and discretionary capacity improvement projects.²² The FDOT's airport work program must be consistent with the statewide aviation system plan and, to the maximum extent feasible, consistent with approved local government comprehensive plans. Projects involving FDOT-administered funds to be undertaken and implemented by the airport sponsor must be included in the aviation and airport work program.²³ Assistance may only be provided for projects which are included in the FDOT's adopted work program.²⁴

Only projects or programs provided for in the Act that will contribute to the implementation of the state aviation system plan, that are consistent with and will contribute to the implementation of any airport master plan or layout plan, and that are consistent, to the maximum extent feasible, with the approved local government comprehensive plans are eligible for the expenditure of state funds in accordance with fund participation rates and priorities.²⁵

Authorized Funding Participation Levels

Current law authorizes the FDOT to participate in the capital cost of eligible public airport and aviation development projects at specified rates, unless otherwise provided in the General Appropriations Act or the substantive bill implementing the General Appropriations Act. Subject

to availability of appropriated funds, the FDOT may generally fund up to 50 percent of the portion of eligible airport project costs which are not funded by the federal government.²⁶ However, subject to appropriations, the FDOT may fund the capital cost of eligible public airport and aviation development projects at a higher rate for certain types of projects.

When federal funds are not available, the FDOT may fund up to 80 percent of master planning²⁷ and eligible aviation development projects²⁸ at publicly owned, publicly operated airports, requiring a 20 percent local match. If federal funds are available, the FDOT may fund up to 80 percent of the nonfederal share of such projects, or 80 percent of the local match requirement. Such funding is currently limited to airports that have no scheduled commercial service.²⁹

III. Effect of Proposed Changes:

The bill amends s. 332.007(6)(c), F.S., revising the airports potentially eligible for FDOT participation in funding of master planning and eligible aviation development projects. The bill removes the current restriction of such funding to the identified projects at publicly owned, publicly operated airports having no scheduled commercial service and limits such funding to general aviation airports³⁰ or commercial service airports that have been classified as a nonprimary airport by the FAA.

This revision results in potential funding eligibility at the 80 percent funding levels for the specified projects at Vero Beach Regional (currently, Florida's only non-primary airport).

The bill takes effect July 1, 2021.
