On a recent Friday, Gov. Ron DeSantis, quietly and privately signed into law <u>dramatic and far-reaching changes to</u> <u>Florida's torts law</u> – changes that will drastically limit the ability of Floridians to hold insurance companies and big businesses accountable for injury or harm.

<u>HB 837</u>, which is now in effect, impacts all lines of insurance, and shields corporations from financial responsibility when they ignore their duty to safeguard clients, even allowing juries to blame criminals when deciding negligence.

MARTIN LUTHER KING, JR. REMEMBRANCE

"On the balcony of the Lorraine Motel 55 years ago today - The Dreamer was shot down by hatred and ill contempt for progress and freedom. Thank God they didn't kill The Dream."

The night before he was assassinated, Dr. Martin Luther King, Jr. shared one of his most powerful speeches in Memphis, Tennessee, where city sanitation workers were striking:

"I don't know what will happen now - we've got some difficult days ahead. But it really doesn't matter with me now, because I've been to the mountaintop. I don't mind. Like anybody, I would like to live a long life longevity has its place. But I'm not concerned about that now. I just want to do God's will. And He's allowed me to go up to the mountain. I've looked over and I've seen the Promised Land. I may not get there with you. But I want you to know tonight, that we, as a people, will get to the Promised Land."

Democrats Fighting to Improve Florida's Mental Health System

Three bills by Democratic Senator Darryl Rouson moving through the process seek to improve Florida's behavioral and mental health services and resources:

SB 508 - Problem-Solving Courts

Revises statutes for the state's pre-trial intervention court programs. Passed the full Senate.

SB 1012 - Certified Peer Specialist Pilot Program

Creates the Certified Peer Specialist Pilot Program to offer inmates a path to becoming certified peer specialists. Passed its first committee.

<u>SB 1016</u> - Mental Health and Substance Abuse

Revises several requirements and duties of managing agencies to better deliver behavioral health services Passed its first committee.

Here's a glance at other bills filed by Senate Democrats heard in committee during Week 5:

SB <u>174</u> -Protection of Specified Personnel - Senator Polsky
Protects justices, judicial assistants, family members, and law enforcement
from threats

SB 196- Guidance Services on Academic & Career Planning - Senator Jones Requires middle schoolers personalized career plans to be developed with a certified school counselor, requires parental notification on high school acceleration options

SB 338 & 340 - Trust Fund for Victims of Human Trafficking - Senator Osgood Creates, provides funding for, and authorizes the use of the Trust Fund for Victims of Human Trafficking

SB 424 - Time Limitations for Prosecution of Certain Sexual Offenses -**Senator Davis** Extends the time allowed for prosecution of first degree or second degree

sexual battery

SB 490 & 492 - Family & Household Members of Homicide Victims & **Deceased Minors and its Public Records Exemption - Senator Jones** Requires law enforcement to provide contact information to the next of kin for a minor involved in a death investigation

SB 678 - Disposal of Property - Senator Powell

Florida Department of Transportation may convey property to a governmental

SB <u>828</u> - Grand Juries - Senator Polsky

Amends statutes related to disclosure of evidence by a court to include in cases where the disclosure would further a public interest

SB 832 - Holocaust Remembrance Day - Senator Berman

Requires Governor to proclaim January 27 each year as "Holocaust Remembrance Day".

SB 858 - Benefits, Training, and Employment for Veterans and their Spouses - Senator Torres

Establishes the Military Corpsmen and Medics of Florida Program to assist veterans and their spouses

SB 1046 & 1048 - Victims of Reform School Abuse

Provides a process for former students of reform schools who were abused to be certified as victims, provides a public records exemption

SB 1282 - Public Restroom Requirements - Senator Stewart

Requiring the Florida Building Commission adopt certain requirements for public restroom facilities.

SB 1302 - Translation Services - Senator Torres Authorizes a clerk of the circuit court to provide translation services

SB 1336 - Disposal of Food Waste Materials Study - Senator Polsky

Directs the Department of Environmental Protection to conduct a study on the disposal of food waste materials

SB <u>1352</u> - Medicaid Enrollees with Sickle Cell Disease - Senator Rouson Requires the Agency for Health Care Administration to review if Medicaid enrollees with Sickle Cell Disease are properly covered to meet their needs

SB 1408 - Sickle Cell Program - Senator Davis Requires the Department of Health to establish a grant program to prevent, care for, and treat sickle cell disease

SB 1440 - Court Proceedings - Senator Book Authorizes A/V technology for dependency & delinquency proceedings

SB 1538 - Implementation of the Recommendations of the Blue-Green Algae Task Force - Senator Stewart Requires the Department of Environmental Protection to monitor and reassess their projects

SB 1564 - Year-round School Pilot Program - Senator Stewart

entity without consideration if the property is to be used for affordable housingDirects the Department of Education to conduct a pilot program relating to the cost and benefits of Year-round School

SB 1578 - Florida Children's Initiatives - Senator Thompson

Clarifies and streamlines provisions related to the Department of Children and Families Florida Children's Initiatives

SB 1606 - Florida Museum of Black History - Senator Powell

Creates a Florida Museum of Black History Task Force and requiring the Division of Historical Resources to oversee the construction of a Florida Museum of **Black History**

SB 1646 - Commercial Service Airport Transparency and Accountability -**Senator Davis**

Revises legislation enacted in 2020 relating to commercial service airport transparency and accountability

SB 1712 - Municipal Water and Sewer Utility Rates - Senator Jones Requires municipalities to charge customers who receive utilities in another municipality the same rates and fees as customers who are inside its municipality
