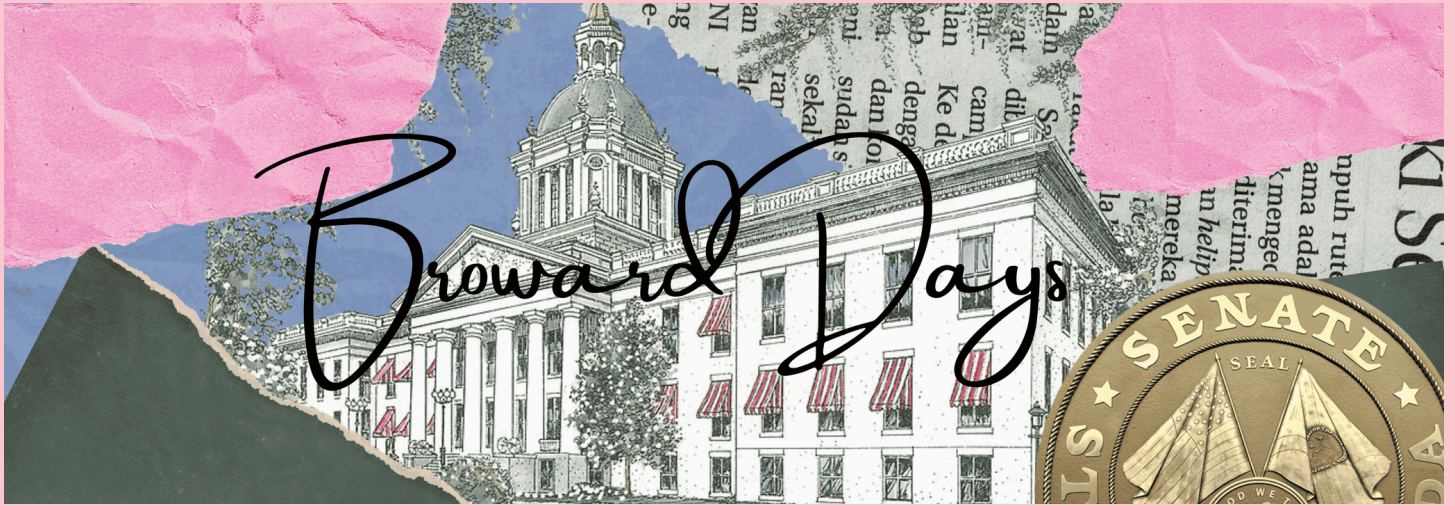
I'm proud to share a meaningful step forward coming out of District 32! In week three, **CS/SB 1670: Specialty License Plates / Outsider License Plate** was heard in the Transportation Committee and passed unanimously.

This bill directs the Department of Highway Safety and Motor Vehicles to develop an *Outsider* license plate, with proceeds benefiting the Hooper Brothers Foundation, Inc., a Florida-based nonprofit dedicated to creating and restoring iconic public destinations across our state.

Revenue generated from the plate will be reinvested directly into communities—supporting preservation, placemaking, and projects that celebrate Florida's unique character. The legislation also ensures transparency and accountability by limiting administrative and marketing costs and prioritizing mission-driven use of funds.

District 32 is proud to lead on creative, community-centered solutions that bring people together and invest in what makes our state special.





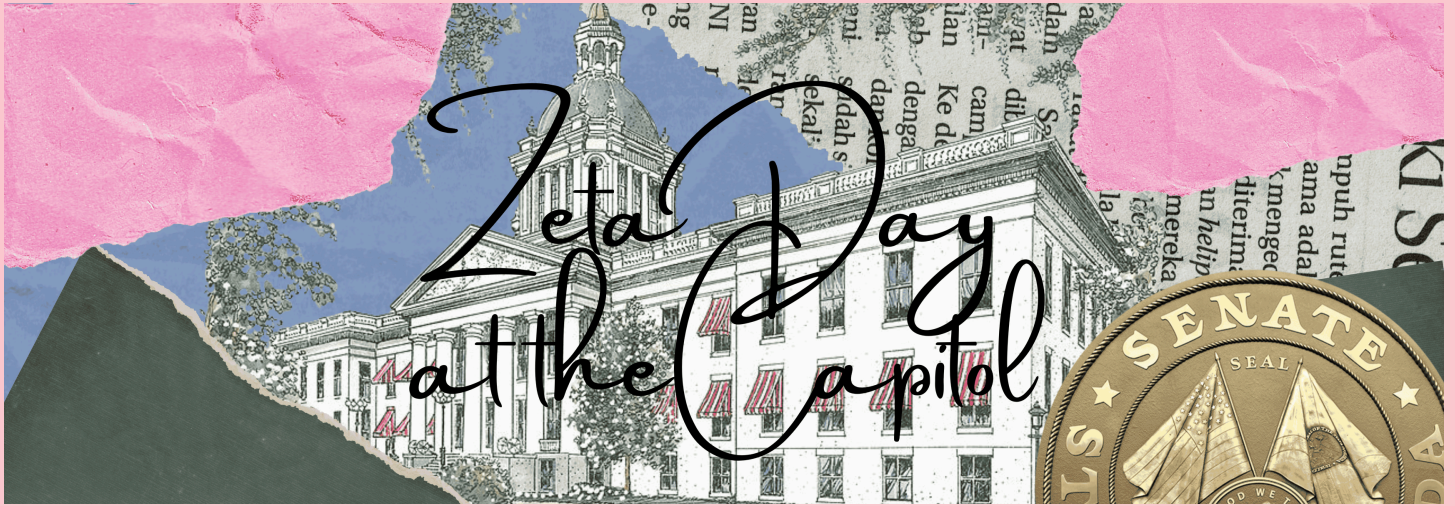
