As we approach the final weeks of the 2020 Legislative Session, the Florida Senate continues our work to advance important legislation to address the most pressing issues facing our state. One of the most important issues to me is improving water quality in Florida's waterways.

This past week my colleagues and I continued our efforts to protect and restore water quality throughout our state. The Clean Waterways Act. Senate Bill (SB) 712 and House Bill (HB) 1343, have passed all of their assigned committees and are now headed to their respective chambers for final consideration.

Next Stop:

This comprehensive legislation will expedite improvements and restoration of Florida's water bodies that are being adversely affected by blue-green algae blooms. The Clean Waterways Act addresses significant sources of nutrient pollution that are contributing to these blooms including onsite sewage treatment and disposal (septic) systems, overflows and discharges from Waste Water Treatment facilities, and stormwater runoff.

I am grateful to Governor Ron DeSantis and Senate President Bill Galvano for their leadership and continued commitment to protect Florida's waters. I look forward to working with my colleagues to get this important legislation to the Governor's desk to ensure the restoration of our most precious natural resource.

### **Legislation Update**

This past week I **presented** the following legislation:

SB 716: County Boundaries was unanimously approved by the Florida Senate this past week. This bill provides for a boundary line change to property that is located partially in Indian River County and partially in St. Lucie County. This legislation alters the boundary lines, which has the support of the property owners and both Counties involved.

SB 646: Student Athlete Achievement Act allows student athletes the right to benefit from their own name, image or likeness, just like every other student on their college campus. This legislation was approved by the Senate Rules Committee this past week, and will now go to the Senate Floor for consideration. I look forward to working with my colleagues to pass this bill in support of Florida's 11,000 student athletes in their efforts to participate in the free market.

SB 1414: Fish and Wildlife Activities increases the number of free fishing days from 4 to 6 days, to allow more anglers to get out and experience our state's natural resources. This legislation also expands the list of Conditional Nonnative species that are prohibited from being bred or sold, except for educational, research or eradication purposes, to include the Green Iguana and Black & White Tegu. This bill was approved by the Senate Rules Committee, and will now go to the Senate Floor for consideration.

<u>SB 666: FDFC</u> was approved by the Senate Rules Committee this week. This legislation redesigns the board of directors, adds additional annual reporting requirements, and sets a sunset provision for the Florida Development Finance Corporation (FDFC). This legislation will now go to the Senate Floor for consideration.

The following legislation passed on the Senate Floor:

SB 936: Disability Retirement Benefits improves access to benefits for disabled veterans by easing proof of disability requirements for a veteran in the Florida Retirement System who is receiving care at a federal Veterans Health Administration (VHA) facility. Currently, a veteran is required to receive certification of proof of total and permanent disability from physicians licensed in Florida or the state in which the veteran works. This legislation will allow a veteran to obtain proof of disability from a VHA physician regardless of the state that the physician is licensed in.

<u>HB 73: Environmental Regulation</u> identifies contamination-related details that must be included in recycling contracts between municipalities and haulers or Multi Re-use Facilities (MRFs). Haulers would not be required to transport contaminated materials that violate the definition of acceptable recyclables, and MRFs would not be required to process them.

HB 61: Adoption Benefits provides incentives for veterans and military members to adopt children from the state's child-welfare system. This legislation expands a program that provides incentives to state employees to adopt children. State employees can receive a one-time benefit of \$10,000 for the adoption of a child with special needs and \$5,000 for adoption of a child without special needs. The bill makes those benefits available to veterans and military members as well.

Governor Ron DeSantis recently **signed** the following legislation into law:

<u>SB 476: Law Enforcement Vehicles</u> ensures law enforcement have the ability to park their patrol cars at home without fear of penalties from HOAs or condo associations. The bill takes effect immediately.

HB 1087: Domestic Violence Services Following the recently disclosed information regarding the Florida Coalition Against Domestic Violence's (FCADV) untenable practices over the past several years. This legislation removes the FCADV from statute and allows the Department of Children and Families (DCF) to administer all programs related to domestic violence services so that survivors in need of these services can continue to receive vital care.

### **Housing Loan Program for Military and Veterans**

Governor Ron DeSantis recently announced the "Salute Our Soldiers" Military Loan Program (SOS) that will be offered to veterans and active duty military personnel throughout the state.

"I'm excited to announce my administration's newest veteran-focused initiative: the "Salute Our Soldiers" Military Housing Loan Program for veterans and active duty military personnel throughout the state," said Governor DeSantis. "To start, Florida Housing will set aside funds to assist over 1,000 veterans and active duty military members by making the homebuying process easier and more affordable. More veterans calling Florida home is a great thing for all involved and we look forward to the positive impacts this program will have on the lives of our veterans and the communities in which they live."

Administered by the Florida Housing Finance Corporation, this program is offering up to \$8 million in a variety of down payment and closing cost assistance, coupled with low-interest rate first mortgages. Importantly, there will be down payment and closing cost assistance options that will be forgivable after five years. The program will be available starting March 2, 2020.

Some of the attributes of the program include:

- Florida Assist down payment assistance: \$7,500 at 0% interest with no payments for 30 years, but due upon sale or refinance;
- Salute Our Soldiers PLUS forgivable down payment assistance: Choice of 3%, 4% or 5% of the purchase price that is forgiven at 20% per year over five years. Active duty military members who receive official orders to relocate will have any remaining balance forgiven upon sale of the home;
- Homebuyer Loan Program (HLP) down payment assistance: \$10,000 at 3% interest over 15 years.
- Reduced costs (no documentary stamp taxes or intangible taxes on the notes and mortgages) and fees to the military homebuyer; and
- Veterans are exempt from the first-time homebuyer requirement. Active duty military members cannot have owned a primary residence in the last three years.

### **Brevard Veterans Center Revolutionary War Celebration**

On March 10, 1783 the last Naval battle of the Revolutionary War was fought off Cape Canaveral Florida. USS Captains John Barry and John Green were trying to deliver a shipload of Spanish silver to the Continental Congress, when they were attacked by British battleships off the coast of Cape Canaveral. After a short firefight and assistance from the French ship, Triton, the British were chased into the night.

Captain John Barry continued North and delivered the silver to Newport, Rhode Island. Upon his arrival they learned that the Treaty of Paris had been signed, bringing the Revolution to a close and making this engagement the last naval battle of the Revolution.

The Brevard Veterans Memorial Center will be hosting a celebration of this Last Naval Battle of the Revolutionary War on Saturday, March 7th from 10:00 am - Noon at their facility (400 S Sykes Creek Pkwy, Merritt Island).
