State to Audit City of Gainesville





Joint Legislative Auditing Committee

You voiced your concerns, and we took action.

In response to multiple Gainesville residents concerned with the City of Gainesville's financial health, Representative Chuck Clemons and I formally requested the Joint Legislative Audit Committee to direct the State Auditor General to take a look into the city's operational and managerial practices.

The JLAC committee members voted unanimously to proceed with a comprehensive audit by the state. This is about restoring public trust and confidence in our community, and I appreciate the willingness of Gainesville officials to cooperate with the process. Unanimous Support for Meaningful Legislation



Early Childhood Music Education Incentive Program: This program is one of my top priorities, and I believe that adopting music education into K-2 is the most transformative, cost-effective way to positively impact early childhood education. Studies have already shown that exposure to fine arts increases tests scores and fosters lifelong creativity, and this pilot program will allow the University of Florida to study just how much music classes impact learning gains, social development, and teamwork. Happy to have recieved unanimous support from the Education Committee members!

<u>Peer-to-Peer Support for First Responders</u>: It is estimated that nationwide, 84 percent of first responders have experienced a traumatic event on the job, and for the past few years, we have lost more law enforcement officials to suicide than in the line of duty. Our bill allows confidentiality to first responders who confide in their fellow first responders about the personal and professional tolls of the job. This week, this bill unanimously passed its second committee stop!

<u>Back to School Tax Holiday</u>: We are one step closer to saving Florida families money as they prepare their children for the 2020 school year! From July 31 through August 9, 2020, tax-exempt items would include clothing and bags under \$60, school supplies under \$15, and computers and related accessories under \$1,000. During this year's holiday, Floridians save more than \$36 million.

Ocala's historic fire bell was returned to its original location, at the corner od SE Broadway Street and SE Osceola Avenue, where the original fire house once stood. The 130 year-old bell arrived in 1889, and sounded the ended of two world wars.





Ocala Mayor Kent Guinn officially opened the Osceola Trak, connecting Tuscawilla Art Park to the Downtown Market! This multi-use park system welcomes walkers, bicyclists, and more to explore the city.

The Marion County CTE Showcase demonstrated how impressive the course offerigs are at Vanguard High School and North Marion High School! The state-of-the-art labs and industry-current equipment are providing our students with the tools they need to be leaders in our future workforce.

Alachua County Leads State in Recycling!



November 11-15 was "Florida Recycles Week," and Alachua County was recognized for being a statewide leader in recycling!

Florida Department of Environmental Protection Secretary Noah Valenstein celebrated Alachua County as one of three counties to reach the state's 70% recycling goal. Great job, Alachua County!

With your support, I'm excited to again champion <u>SB 326</u> to decrease recycling contamination. Here are some easy ways we can keep up the good work, and reduce recycling contamination:

- Confused about what to recycle? Paper, cardboard, bottles and cans only. When in doubt, throw it out.
- It's easier to recycle aluminum than to spell it. Recycle clean, dry, empty cans.
- On average, Americans drink one beverage from an aluminum can every day! In Florida, we recycle less than 20% of the cans we use. Cans are 100% recyclable.
- The cardboard box can be recycled, BUT the package CANNOT be recycled at the curb. Reuse the packing materials when you send your next holiday gift.
