## Legislative Update - Honoring Their Service

I am not presenting any bills this week, so I want to take the opportunity to introduce you to a few pieces of legislation I have filed to honor the service and sacrifices of our servicemembers and veterans.

SB 416: POW-MIA Vietnam Veterans Bracelet Memorial

- Honors American soldiers who were prisoners of war or missing in action
- Authorizes the placement of a memorial near the existing Vietnam Memorial

#### **SB 764: Veterans Treatment Courts**

Codifies best practices for Veteran Treatment Courts

## **SB 770: Military Affairs**

Updates the Florida Code of Military Justice

## SB 922: Veterans' Preference in Employment (VET Act)

 Authorizes the state and its political subdivisions to waive certain post-secondary requirements for employment for certain servicemembers and veterans

## SB: 958: Honor Flight Specialty License Plate

• Creates a Honor Flight Specialty License Plate

# SB 494: Administration of Vaccines Approved by Health Policy Committee

This week the Senate Committee on Health Policy, chaired by Senator Manny Diaz Jr. approved **SB 494: Administration of Vaccines** 

The on-going pandemic has highlighted the importance of our local pharmacists, who have been on the front lines since the start of the COVID-19 pandemic. We trust our local pharmacists to administer flu and shingle shots and we should trust them to administer the COVID-19 vaccine and any future vaccines recommended by the CDC.
