## Holding Donald Trump Accountable

We watched in horror as a band of thugs stormed the Capitol in an attempt to destroy our previously unbroken tradition of a peaceful transfer of power. Leading this criminal mob was President Donald J. Trump. Following this repugnant display of sedition by a sitting president, Donald Trump was rightfully impeached by the House of Representatives for incitement of insurrection.

Donald Trump's treacherous actions are not only a violation of federal law and an affront to the Constitution, but they clearly violated our state statutes as well. By intentionally stoking the flames before and during the siege in D.C. Donald Trump incited insurrection, advocated for the overthrow of our government, and attempted to subvert the U.S. Constitution and functions of Congress.
