## ALACHUA COUNTY EMERGENCY RENTAL ASSISTANCE PROGRAM

The Alachua County Emergency Rental Assistance Program (ERAP) is a Federal Grant which is intended to assist households who are unable to pay, or are having difficulty paying rent and/or utilities due to the COVID-19 pandemic. This program can assist eligible households with the payment of late rent and/or utilities and may also assist with the payment of rent in advance.

FLORIDA DEPARTMENT OF EDUCATION UPDATE

## **Governor Ron DeSantis Announces Federal Stimulus Budget Recommendations**

The federal stimulus package provides \$1.9 trillion in new spending in response to the COVID-19 pandemic. The Act includes "Coronavirus State and Local Recovery Funds," which provides \$195.3 billion to the States and the District of Columbia.

The Governor's recommendations include providing assistance to Floridians in need, and making major investments in critical areas such as infrastructure, education, and workforce development to continue Florida's rapid economic recovery. Governor DeSantis'

budget recommendations to the Florida Legislature regarding the use of these federal funds are listed below:

### **Providing Assistance to Floridians**

- \$208.4 Million (FY 20-21) Direct Payments to Pandemic First Responders
- \$73.2 Million (FY 21-22) Re-Employment Assistance Modernization
- \$56.6 Million (FY 21-22) Re-Employment Assistance Operations
- \$72 Million (FY 21-22) Behavioral Health System Modernization

### <u>Promoting Economic Development and Recovery</u>

- \$258.2 Million (FY 20-21) Relief for Florida's Seaports
- \$150 Million (FY 21-22) Florida Job Growth Grant Fund
- \$50 Million (FY 21-22) VISIT FLORIDA
- \$50 Million (FY 21-22) Economic Development Transportation Fund

## <u>Investing in Infrastructure, Resiliency and Readiness</u>

- \$938.4 Million (FY 20-21) Transportation Work Program
- \$1 Billion (FY 21-22) Resilient Florida Grant Program
- \$1 Billion (FY 21-22) Emergency Management Response Fund
- \$41.7 Million (FY 21-22) Florida National Guard Expansion

## Workforce Training and Research

- \$125 Million (FY 21-22) Education and Employment Training Program
- \$60 Million (FY 21-22) Workforce Development Capitalization Incentive Grants
- \$10 Million (FY 21-22) Alzheimer's Disease Research Program

The Governor's recommendations total \$4.1 billion, of which \$1.4 billion is recommended for immediate use during the current fiscal

year. The Governor is not recommending the appropriation of the full anticipated state allocation, and instead is requesting the Legislature leave a portion of the funds aside to evaluate Florida's economic recovery throughout the year and make additional targeted appropriations at a later time.

## SB 530 NONOPIOID ALTERNATIVES

We have seen far too many of our loved ones fall victim to addictions, including opioids. This year, I have proposed legislation that will allow physicians to educate patients about alternative options for opioids via hardcopy or electronic materials. Senate Bill 530 (Nonopioid Alternatives) will require health care practitioners, who prescribe or order opioid drugs, to

inform the patient or the patient's representative of available nonopioid alternatives for the treatment of pain. In addition, the practitioner must discuss the advantages and disadvantages of nonopioid alternatives and provide an educational pamphlet in an electronic or printed form.

Growing up in the 1970's, I have witnessed numerous individuals fall victim to the opioid epidemic. Some of these people suffered from addiction, incarceration, or have passed away. I made the pledge long-ago to help those who have suffered from this awful disease. Since the late 1990's I have been involved with many drug and rehabilitation organizations in my community. I was the founding president of House of Hope in Gainesville, a transitional home for men and women recently released from prison. At House of Hope, I had the privilege of working closely with recently incarcerated people who wanted to put in the work to better themselves and contribute to society.

This led me to seek proactive and long-term solutions to fight the opioid crisis. I recently became a member of the National Conference of State Legislature's 2021 Opioid Policy Fellows Program. This program allows state legislators from across the country to work together on health policies and programs. The fellowship will include 20 to 25 legislators who have been chosen to discuss strengthening prescription drug monitoring programs, developing prescribing guidelines, increasing naloxone access, and supporting access to treatment and recovery services.

It is important that we continue to bring awareness to the impacts of addiction and overdose issues in our communities. Oftentimes, these opioid addictions are formed by patients recovering from first-time injuries who may have not known they had other options. I am proposing an electronic OR printed copy of an educational pamphlet be provided to patients to keep up with evolving technology and telemedicine practices. This legislation will allow patients to be better informed on available medicines and alternatives to opioids. SB 530 will allow patients to be better educated about how dangerous these drugs can be and will help increase access to alternative pain solutions and prevention strategies for opioid addiction.
