Legislative Updates

Special Session C has been called before the 2024 legislative session from November 6th through November 9th and will coincide with the scheduled interim Committee Week. Legislators will be addressing the Israel conflict in the Middle East and the aftermath of Hurricane Idalia with the following Special Session issues:

- Hurricane Relief
- · Support for Israel
- Expanded Sanctions Against Terrorist Regimes
- Additional Security Infrastructure to Guard Against Anti-Semitic Violence, Hate Crimes
- Additional Funding for Students with Unique Abilities
- Increased Resilience Efforts to Help Lessen Insurance Costs

Since our last update, we've filed an additional bill:

(SB 252) - Psychiatric Treatments: This bill defines the terms electroconvulsive
treatment and psychosurgical procedure. It also requires that only physicians
can perform electroconvulsive treatment and psychosurgical procedures and
prohibits the performance of electroconvulsive treatment and psychosurgical
procedures on minors.

We will continue updating you as we file more bills for the 2024 legislative session. If you plan to be in Tallahassee for a Committee Week, please make sure to schedule an appointment. If you have an idea for a bill or want to propose a change to a Florida law, please contact our office. Many bills start as ideas suggested by Florida residents.


