Legislative Updates



SB 676: Minimum Wage Requirements by Senator Martin Senator Arrington voted **no** on this bill for the second time in Government Oversight and Accountability. She believes we should not create an option that allows anyone especially our children and seniors to be exploited by their employers.

Bill Spotlight

Senator Arrington was thrilled to present two bills on the Senate floor this week.

SB 274: Transportation Facility Designations/Harris Rosen Way and Geraldine Thompson Way

This bill will honor philanthropist Harris Rosen and Senator Geraldine Thompson with road designations in Orlando. This bill not only passed, but the entire Senate co-sponsored this legislation to honor the lives of these individuals.

SB 280: Candidate Qualification

This bill aims to provided necessary legislative clarification to the candidate qualification process. It has received strong bipartisan support and was unanimously passed on the Senate floor.
