## FOCUSING ON PROTECTING FLORIDIANS

I have been unwavering in protecting Florida from undue influence by foreign countries of concern. This upcoming Legislative Session will be no different. <u>SB 1538</u> prohibits government entities from contracting with companies that have ties to these nations, ensuring taxpayer dollars do not support foreign adversaries.

Additionally, <u>SB 1090</u> strengthens consumer protections by requiring online marketplaces to verify and disclose sellers from these countries, hold proceeds in U.S.-based escrow accounts for 120 days, and comply with Florida's Deceptive and Unfair Trade Practices Act. These measures reflect my commitment to safeguarding Florida's economy, security, and transparency.

### HIGHLIGHTING TRANSPORTATION NEEDS

As Chairman of the Florida Senate Transportation Committee, I have the distinct privilege of sponsoring legislation that strengthens our state's transportation infrastructure and enhances mobility for all Floridians.

This session, we are advancing key initiatives aimed at improving safety, efficiency, and connectivity across our roadways, transit systems, and ports.

Here are some highlights of the transportation-focused legislation we are working on:

- <u>K-12 School Transportation (SB 1424</u>) This bill ensures that school districts provide transportation for students living more than one mile from their assigned schools. It also promotes the integration of artificial intelligence to improve efficiency and revises criteria for hazardous walking conditions to enhance student safety.
- <u>Transportation Facility Designations (SB 1408)</u> This bill designates specific transportation facilities across Florida to honor individuals and historical events. The Department of Transportation will install commemorative markers to recognize these contributions.

## **HELPING OUR FIRST RESPONDERS**

For the 2025 Legislative Session, I have introduced pivotal bills aimed at bolstering support for Florida's first responders. Here are some key highlights:

#### 1. Canine Heroes for First Responders Act (SB 688)

This act proposes the establishment of the Canine Support Grant Program, jointly administered by the Department of Law Enforcement and the State Fire Marshal. The program aims to provide support dogs to first responders, enhancing their well-being and operational efficiency. The bill outlines specific requirements for these support dogs to ensure they meet the unique needs of our emergency personnel.

#### 2. Public Safety Act (SB 1554)

This comprehensive legislation seeks to enhance public safety by:

- <u>Establishing a Counterterrorism/Counterintelligence Unit</u>: A dedicated unit within the Department of Law Enforcement focused on preventing and responding to threats.
- <u>Prohibiting Employment Discrimination</u>: Ensuring first responders are protected against workplace discrimination.
- <u>Implementing a Unified 911 System</u>: Mandating a cohesive 911 system across all county-level first responder agencies by a specified date, ensuring the closest unit responds to emergencies regardless of jurisdiction.
- <u>Introducing Honors</u>: Creating the Florida Medal of Valor and the Florida Blue/Red Heart Medal to recognize the bravery and sacrifices of our first responders.
