

As we enter Week 7 of the 2025 Legislative Session, the Capitol was abuzz with energy and purpose. On April 15, we welcomed families and advocates from across the state for Children's Day at the Capitol, a highlight of Children's Week Florida. The event featured engaging activities like Storybook Village and the inclusive Storybook Garden, providing a joyful and educational experience for our youngest citizens.

In legislative developments, the Senate Finance and Tax Committee advanced SPB 7034, a comprehensive tax relief package. This proposal includes permanent sales tax exemptions on clothing and shoes priced at \$75 or less, a series of targeted sales tax holidays, including those for disaster preparedness, back-to-school supplies, and hunting equipment, and a one-time vehicle registration fee credit. Additionally, the bill proposes a study on reducing property taxes, reflecting a commitment to long-term fiscal responsibility.

Highlights included the beloved Storybook Village, where stories were brought to life through interactive exhibits, and the newly introduced Storybook Garden, a sensory-friendly space designed to provide a calming environment for children who benefit from a quieter setting. Legislative Update



Advancing Targeted Tax Relief: SPB 7034

The Florida Senate is progressing with SPB 7034, a comprehensive tax relief package designed to provide meaningful support to families, businesses, and rural communities across the state. Key provisions of the bill include:

- Sales Tax Exemptions: Permanent elimination of sales tax on clothing and shoes priced at \$75 or less, aimed at easing the financial burden on families with growing children and seniors.
- Sales Tax Holidays: Implementation of several tax-free periods, including a weeklong back-to-school holiday, a two-week disaster preparedness holiday, a week-long tool and safety equipment holiday, and a month-long outdoor supplies holiday.
- Property Tax Study: Commissioning a study to explore the implications of permanently reducing property taxes, reflecting a commitment to long-term fiscal responsibility and economic growth.
- Rural Community Investment Program: Establishment of a program within the Department of Commerce to incentivize investments in rural areas, fostering economic development and job creation.

SPB 7034 represents a balanced approach to tax policy, addressing immediate needs while laying the groundwork for sustainable economic prosperity.
