Bill) and Senate Bill 2502 (Implementing Bill)

Date: April 3, 2025

The General Appropriations Bill for Fiscal Year 2025-2026, SB 2500, as Introduced, and the Appropriations Implementing Bill, SB 2502, as Introduced, and other bills relating to the state's budget, will be published electronically on the Senate's website, www.flsenate.gov, including the Appropriations webpage, www.flsenate.gov/Session/Appropriations, on Thursday, April 3, 2025.

SB 2500 and SB 2502 will be placed on the Special Order Calendar as soon as possible to be considered by the Senate on Wednesday, April 9, 2025.

THE DEADLINE FOR FILING AMENDMENTS TO SB 2500 AND SB 2502 IS 1:00 P.M., MONDAY, APRIL 7, 2025. (SUITE 201, THE CAPITOL)
