In addition, a production of USB Student/Teacher resource on Holocaust Education will be developed.

d. What are the direct services to be provided to citizens by the appropriations project?

The Holocaust Documentation & Education Center, Inc. offers our Educational Outreach programs to all members of the community, with a special focus on students and educators. All programs are in compliance with s. 1003.42, F.S., mandating Holocaust Education which states: "The history of the Holocaust (1933-1945), the systematic, planned annihilation of European Jews and other groups by Nazi Germany, a watershed event in the history of humanity, to be taught in a manner that leads to the investigation of human behavior, an understanding of the ramifications of prejudice, racism, and stereotyping, and an examination of what it means to be a responsible and respectful person, for the purposes of encouraging tolerance and diversity in a pluralistic society and for nurturing and protecting democratic values and institutions."

e. Who is the target population served by this project? How many individuals are expected to be served?

These unique programs educate the future generation about the dangers of hatred, terror, and the threats against our democratic values and freedoms. By relating to the tragic, personal stories of Holocaust Survivors, students begin to understand that no one is immune to the evil and discrimination bestowed upon them by others and our students learn to take a stand and become more vigilant and aware in their daily lives. Above all, our goal is for all students to realize that targeting one group targets all. 18,000 individuals are expected to be served through Holocaust Documentation and Education Center programs in 2017-2018.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The Holocaust Documentation & Education Center seeks to combat prejudice and bullying in our multicultural, ethnically diversified community by educating the students and alerting them to the dangers of prejudice.

Because our mission is to provide educational resources and information regarding the authentic memory of the Holocaust. All of our educational outreach programs are a vehicle to this end. Our South Florida High School students at each program learn the dangers of bullying, racism, hatred, and bigotry through videos, lectures, and roundtable discussions with Survivors of the Holocaust. High school students from local public, private, and parochial schools in Miami-Dade, Broward, Monroe, Palm Beach, Martin, and Okeechobee counties are invited to attend. Since we have been providing these programs for the past thirty-four years, the administrators and teachers are familiar with these significant educational experiences and encourage participation among their students.
