The campus will be on a 26-acre parcel of land in northwest Miami-Dade County that the Florida Department of Children and Families leased to Citrus Health Network (CHN) for a period of 50 years to develop and provide such rehabilitative and therapeutic programs. ### d. What are the direct services to be provided to citizens by the appropriations project?

<u>SIPP services will be provided in a licensed and locked residential facility where youth receive intensive</u> behavioral health, primary care, and educational services particular to their needs. Services will include: psychiatric evaluations; medication management; primary care and OB/GYN services; individual psychotherapy; family therapy; group therapy with a focus on subjects relevant to the CSEC population such as substance abuse, sexual behavior, and interpersonal relationships; substance abuse prevention and treatment; individualized education plans; and equine, pet and art therapy.

#### e. Who is the target population served by this project? How many individuals are expected to be served?

Commercially Sexually Exploited Children (CSEC), ages 12-18, who are victims of human trafficking

# f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

<u>The Citrus Helping Adolescents Negatively affected by Commercial Exploitation (CHANCE) Program has served</u> more than 200 children since it originated in 2013. Preliminary program & youth outcome data indicates successes from the interventions offered in this treatment program. CSEC victims benefit from integrated care and a full continuum of treatment options. CHN has developed a specialized treatment program within the existing SIPP program to meet the unique needs of this population. The treatment needs of commercially sexually exploited youth differ from the needs of traditional SIPP clients. These youth would benefit from a separate and distinct facility specifically designed to address their treatment needs. In order to reduce



recidivism, the youth would benefit from step-down services from this high level of care into a lower level of care on the same campus. This step-down would offer the opportunity for the continuity of treatment that CSEC youth require to be successful.
