- 4. Project/Program Description:

ONU was created in Jacksonville for the purposes of assisting veterans after military service find meaningful careers through classroom training, one-on-one career coaching, networking, leading to careers. - The current issue: Approximately 40 more veterans are applying for each cohort than ONU has the resources to serve. - ONU currently has a 96% employment rate for veterans who complete the program. A typical class has 10 veterans. Average salary for an ONU veteran is currently \$63,000. - ONU is located in Duval county, but has received students from 5 main counties: Baker, Clay, Duval, Nassau, St. Johns. - The appropriations request will fund expansion in the Jacksonville market (100 veterans to be served), expansion of resume services (100 veterans to be served), and expansion into Tampa (at least 20 veterans to be served). - With an investment of \$791,700, at least 220 veterans will be served at an average cost of \$3598. - All funds from this grant will go towards programmatic cos

#### 11. Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

ONU is requesting \$791,700 from the state of Florida to increase it's programmatic offerings. With this funding ONU is prepared to serve at least 100 veterans in Jacksonville and expand to serve at least 20 veterans in Tampa. With these funds, ONU is also prepared to offer resume services to 100 otherwise unserved veterans. By supporting these programs, the state of Florida would be assisting approximately 220 veterans gain confidence, and ultimately careers.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The Finding the Uniform program provides classroom training to veterans who are unemployed or significantly underemployed. Here, they learn methods used by those in the business community to market themselves and begin growing their network. After learning the attitudes and skills needed to obtain a career, our veterans move into the Enhancing the Uniform program to put their new knowledge to work. Our team holds each veteran accountable for using the techniques they've learned in career resource groups, job fairs, and other professional settings. They utilize new networking and interview skills to obtain fulfilling careers. With these two programs combined, we invest an average of 66 hours of training and coaching into empowering each veteran to find their dream career and have maintained a success rate of greater than 90%. 100 additional veterans will be provided with professional resumes written by a specialist through this grant, totaling in 220 veterans in Florida being served.

#### d. What are the direct services to be provided to citizens by the appropriations project?

<u>Through ONU's Finding the Uniform and Enhancing the Uniform programs, we give veterans classroom</u> <u>training, skills, and the confidence to find careers after military service. We also have developed a community</u> of business professionals, into which these veterans are able to network and practice their new skills. These programs ultimately end with 90% or more of ONU veterans obtaining high-skill careers. An extra 100 veterans will be provided with resumes created by a specialist.

#### e. Who is the target population served by this project? How many individuals are expected to be served?

<u>Veterans with honorable discharge are selected for our programs. 70% of these veterans have a service-</u> <u>connected disability. 18% of the veterans served are female and 45% or more are minorities.</u>

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

<u>90% or more of the veterans served through the Finding the Uniform program and the Enhancing the Uniform program will obtain careers. These careers will average no less than \$50,000/year. These statistics will be gathered through employers and self-reporting opportunities.</u>
