<u>This recreation facility is heavily used today for sanctioned soccer programs. There is a demand to accommodate additional sanctioned sports such as Lacrosse. The existing building and parking facilities struggle to meet existing needs and simply will not be capable of meeting planned future needs.</u>

Any City of Plantation citizen that plays on soccer and/or lacrosse leagues and the 40,000 regional, national and international athletes who participate in tournaments held on field such as those found within Pine Island Park and 115,000 spectators attend these events.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Once the renovations of Pine Island Park are complete, an increase of several thousand participants and spectators are expected. With improved drainage, maintenance and turnaround time for field preparation will decrease which will allow several more months for games and practices. With additional participants and events, the City and the surrounding restaurants, hotels and other attractions within the region will enjoy an increase of local community revenue impact of approximately \$2 million dollars.
