4. Project/Program Description:

The Town of Sewall's Point requests \$950,000 or 49% of a \$1,937,000 project to raise the elevation of South Sewall's Point Road, a one-mile road that connects to S.R. A1A as the only hurricane evacuation route for 1,823 residents evacuating 730 homes. During the evacuation order and after both Hurricane Irma and Matthew, the road remained flooded by 24-36 inches of rainfall. The Town will construct stormwater treatment rain and detention ponds to remove 80% of nutrients before reaching the Indian River Lagoon. Regionally it will provide 150 jobs. Statewide it will generate \$285,000 in sales tax revenues.

Raise elevation and reconstruct South Sewall's Point Road, the only hurricane evacuation route for 1,823 residents from 730 homes, to eliminate 24-36 inches of flood waters from Hurricane Irma and Matthew making it impassable for safe evacuation.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Bid the flood control, road construction project to raise and reconstruct South Sewall's Point Road to eliminate severe road flooding and treat all stormwater eliminating nitrogen and phosphorus from entering the Indian River Lagoon, monitor and report on the pollution and flood control improvements, and educate the public about benefits of these improvements.

d. What are the direct services to be provided to citizens by the appropriations project?

Raise roadway elevation to eliminate heavy, impassable flood water from a major hurricane evacuation route for 1,823 residents from 730 homes; remove 80% of noxious pollutants and harmful nitrogen and phosphorus; reduce residents' concerns about being trapped in their homes during major storms with their hurricane evacuation route flooded by 48 inches of water; restore designed bike trail; remove and treat 80% of stormwater pollutants, regionally; generate \$285,000 in sales tax revenue; and statewide add 150 jobs with project construction. Applied for a DEM Hazard Mitigation Grant, on Aug 11, 2017, for \$963,750.

- e. Who is the target population served by this project? How many individuals are expected to be served?

 Martin County region. 3,000-5,000 residents and visitors.
- f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - Before and after construction measurements of flood water to allow clear vehicular passage for hurricanes and water quality testing for measuring stormwater pollutant removal
