This project involves the retrofitting and equipping of existing vocational sites to create vocational classrooms and workshops suitable for instruction in welding, pipefitting and fabrication. Wewahitchka High School has a facility once used to teach carpentry. This facility would be renovated and equipped with welding machines and equipment. Port St. Joe High School currently has a welding classroom that has been in existence for more than 25 years. This classroom would be updated and modernized. With the facilities prepared and trained instructors provided, high school students and adults in the community could obtain industry certification in welding and training to make them employable in any number of industries including shipbuilding. Recently obtained long-term contracts by Eastern Shipbuilding and the plans to install a deepwater port in Port St. Joe has created a significant demand for such skills.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The primary goal of the program is to produce high school graduates with industry certification in welding. Plans are underway for the construction of a state-designed deepwater port in the sheltered waters of St. Joseph Bay that will offer direct access to the U. S. Gulf Intracoastal Waterway. It will be adjacent to more than 5,000 acres of undeveloped land ripe for the development of maritime-related businesses not available at land-constrained ports. This port as well as the growing shipbuilding industry in nearby Bay County bodes well for graduates with welding certification and skills. Deseret Cattle & Timber recently acquired large tracts of land in Gulf County and placed job postings for Mechanic/Welder positions. After school hours the facility will be used

to offer training to the public so that individuals can increase their employability by learning welding basics or honing existing skills. Tuition would be kept a minimum and used only to cover the costs of operation.
