It is proven year after year that After School, Summer and extra curricular activities are critical to developing soft skills in the work place as we help to make our young people and communities well rounded as a community. We have proven results in Helping to Improve our graduation rate in our schools through our Future Leaders United After School Mentoring Program. Help with Feeding Programs, Community Family Appreciation Days, Counseling Programs, Mental Health Counseling Programs, Educational Programs.

e. Who is the target population served by this project? How many individuals are expected to be served?

Pine Hills has a population of 72,000 residents. We are looking to serve Approximately 1/3 of the population - 24,000 if not more for 2018. We are determined to empower our community one family at a time. We have fed and served over 5,000 to date, however, we have grown by leaps and bounds. We have been successful In working with OCSO to help reduce crime In Pine Hills by 33%. Help to grow our graduation rate from 48% to 88%. Our overwhelming growth in solutions driven programs are due in part to numerous coverage on news 13, WFTV NEWS, the pine hills Press, 94.5FM, The wire 98.5 FM, 32805, WOKB 1680 AM, Caribbean American Passport Newsmagazine, just to name a few.

UFCF - Future Leaders United After School Mentoring Program has grown from 7 students to 60 students. 24 children have graduated from the Program, and over \$11,000.00 in scholarship dollars has been awarded to students attending College for the first time. We have over 30 students graduating this year. There are 14 Programs that are inconjuction with the program and to date we have served over 5,000 families. With this funding we are looking to serve over 24,000 as we empower them to become productive members of this community, educate them about our community, facilitate skills training and hiring fairs, as well as help to get them off the streets. These programs are namely, Freshman Success, Team Mentoring, Early Learning, Ms. Orlando Caribbean Pageant Grooming Program for Girls, Taste of Pine Hills, Family Community Appreciation Day, Honoring our Heroes, College Scholarship Program, College Tours, Summer Program, Pine Hills Community Council Youth Advisory Committee, Mental Health
