In one year, this pilot program will increase the literacy rate of incarcerated youth and adults by three years and three grade levels. The goal for this USF St Petersburg program is to help increase the number of incarcerated individuals who have the literacy skills and strategies needed to succeed once they are released. This pilot program can offer prisoners, who qualify, an opportunity to earn a diploma, possibly a GED or comparable from USFSP.

#### d. What are the direct services to be provided to citizens by the appropriations project?

Incarcerated individuals' literacy strategies and skills will increase, and participants will be able to function better as a member of society. This education can lead to a GED, diploma or comparable from USFSP. This could have a significant economic and community impact as many individuals will remain in the surrounding areas after their release.

#### e. Who is the target population served by this project? How many individuals are expected to be served?

Current incarcerated individuals. The goal of this program is to reach several hundred inmates. In the first year of the pilot a selected group would begin the literacy program and each year more inmates would be added. An estimated 50 prisoners would participate in the pilot cohort the first year.

## f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Florida houses the third largest number of prisoners in the country and nearly 80 percent of prisoners read below a ninth grade literacy level, and most will eventually be released. Research has shown that prisoners who participate in prison based education have higher post-release earnings and higher employment rates, while reducing recidivism. Effective education programs increase prisoners' literacy rates, artistic development and techniques to deal with emotions and toxic stress. Prisoners who earn a diploma return to prison custody at almost half the rate of those prisoners who did not earn a degree. Literacy skills in incarcerated programs with
