4. Project/Program Description:

An appropriations request is being made for the Museum's expansion within Little Haiti that involves the development of a mixed use museum facility that contributes to Miami's economic initiatives relating to Transit Oriented Development (T.O.D.) of mixed use neighborhoods such as Little Haiti, that are adjacent to proposed major transit corridors. The proposed project within the heart of downtown Little Haiti is an innovative Cultural Business Incubator and Entrepreneurial Learning Center focused on engaging the local community with global opportunities in cultural tourism and related businesses. The project is centered around three key program elements: 1) A Museum exhibition and multipurpose space for community events; 2) A Creative Industries Business Incubator dedicated to promoting entrepreneurship opportunities in both the Creative Industries and Tourism sectors; and 3) Retail space to promote local pop-up retail activity for local entrepreneurs.

a. What is the specific purpose or goal that will be achieved by the funds requested?

Requested funding will be used for the design and pre-development of the Museum's T.O.D. mixed use Creative Industries Business Incubator. The purpose of the proposed transit oriented development mixed use project is to serve as a neighborhood anchor that fosters innovation and entreprenuership that contributes to the sustainability of the community and long term economic development, while also contributing to the broader regional economic impact and tourism for the state of Florida.

The Haitian Heritage Museum's mixed use Creative Industries business Incubator will create immediate jobs during the initial design and construction phases of the project.
