 Create drainage system to control flow of ground and storm water.

 - Construction of a pipe network (drainage system) to work in conjunction with the City's master stormwater plan.

 - Improved drainage of ground and stormwater. Preservation of transportation infrastructure and reduction of flooding to private property. Enhance use of travel lanes and improved egress and ingress to and from local businesses. Stormwater analysis provides for a reduction in flood state for a mean annual event. Analysis of the basis shows a reduction in flooding to the transportation infrastructure, commercial businesses and neighborhoods.
