High School students will receive hands on training through classroom labs and work projects. They will receive content delivery via textbooks and virtual practice. Students will attend field trips to industry and hear guest speakers to acquaint them with the jobs available in their community. Students will hone their skills and gain recognition through SkillsUSA competitions and conferences. Through potential partnerships with Habitat for Humanity, students can build a house in their own community, participating in all phases of the home construction. Through partnerships with local business and the Academy of Construction Technologies, students will participate in internships, mentor ships and direct job placement.

c. What are the direct services to be provided to citizens by the appropriations project?

The academy will fill an area of high need by producing a highly trained workforce with industry certification, skills and experiences through practical experiences and apprenticeships whom are employable directly out of high school. This will fill the skilled trade gap in our state, promote economic growth, and establish a higher standard of living for Lake County and for the state of Florida.

d. Who is the target population served by this project? How many individuals are expected to be served?

The construction academy has capacity for 140 students each year. Any Lake County student enrolled in grades 9-12 are eligible for the program. Special recruitment and consideration will focus on non-traditional students, students on free and reduced lunch, students in rural communities, at risk students, and hands on learners interested in Science and Technology fields.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

An increase in high school students with post-secondary certifications. Increased employment rates. Decreased trade gaps in the construction industry. Decreased high school drop out rates. Essential jobs filled for community growth.
