- 1. Title of Project: Gateways Beautification Plan

- 4. Project/Program Description:

\$3.4 million is requested for development of conceptual and design plans for landscape beautification and monument signage at key gateways into Pasco County, including north and south county borders on US 19 (Gulf Coast Highway), and secondary gateways from US 19 to major road intersections (SR 54, Moog Road, Little Road, Embassy Boulevard, Aripeka Road, and Hudson Avenue). Funding request includes funding for landscape beautification and monument signage on major gateways to Land O'Lakes Blvd., SR 54, SR 52, and US 301. A detailed Highway Gateway Conceptual Design Plan with detailed cost estimates for the recommended plans for each gateway is needed. Gateways are traffic calming measures that are strategically placed to establish a collective vision to support local businesses and will serve to attract new and diverse business along these gateway corridors. Funding will complement current landscape plans for US 19 and proposed redevelopment plan for Land O'Lakes Blvd.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Gateways are traffic calming measures that are strategically placed as drivers enter these corridors into Pasco County. Monuments serve as wayfinding measures for residents and tourists. Gateway beautification and monument signage is planned for the north and south county lines on US 19 (Gulf Coast Highway) and at secondary gateways from US 19 to major road intersections, including S.R. 54, Moog Road, Little Road, Embassy Boulevard, Aripeka Road, and Hudson Avenue as well as S.R. 54, S.R. 52, Land O' Lakes Boulevard, and US 301 corridor into Pasco County. Landscaping at these gateway locations need to be enhanced, with monument welcome signage and lighting provided.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Funds will be utilized to hire a consulting firm through a competitive bid process to develop a landscape design concept plan for each roadway, and designs for landscaping and gateway monument signage, engineerings, land acquisition planning, land acquisition, landscaping, maintenance of traffic and construction bid document preparation, and FDOT approved plans along these roadways.

c. What are the direct services to be provided to citizens by the appropriations project?

The project will: 1) enrich cultural experiences along the roadways and provide for improved park attendance as evidenced by park visitation logs; 2) protect the general public from harm through improved wayfinding for residents and tourists to public community assets; 3) improve transportation conditions by providing traffic calming for vehicular and pedestrian traffic as measured by crash data.



d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes the general population, including county residents, tourists, motorists, and non-vehicular travelers (pedestrians, bicyclists, wheelchair bound individuals).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improvement to physical health is measured by pedestrian, bicycle, and vehicular crash data. Enrichment of cultural experience is measured by improved park attendance via park visitation logs. The improvement of transportation conditions for vehicular and pedestrian traffic will be measured by crash data pre and post construction. The increase in economic activity will be measured by increased sales and private investments along the roadways.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Standard contract penalties.
