4. Project/Program Description:

The Town currently hauls liquid biosolids (sludge) from their wastewater treatment facility after it is treated to meet FDEP requirements. This method is cost prohibitive since the liquid biosolids contain 98 to 99% water. The Town would like to increase the solids concentration through a biosolids dewatering system that is cost effective when compared to other alternatives such as belt filter press or centrifuge. The Town is requesting funding to pay for the design, permitting and construction of gravity dewatering box and accessories to decrease their ongoing biosolids disposal costs.
