4. Project/Program Description:

The Kosher Senior Meals Program at the David Posnack Jewish Community Center (DPJCC) serves a well-balanced and nutritious kosher lunch to area residents 60+. Through a partnership with Meals on Wheels South Florida, meals from the grant are also served at the Daniel Cantor Senior Center and Daniel Cantor Adult Day Care/Alzheimer’s Respite Program. The program provides a pleasant atmosphere where seniors can come together for services and activities that enhance dignity, support their independence, and encourage their involvement in and with their community. The LSP strives to meet the needs of the elder community so they can maintain an acceptable quality of life in their own homes and avoid or delay nursing home placement. The DPJCC has the facilities to promote healthy living and has specific classes designed to engage the 60+ community. Classes and support groups have been developed to encourage social interaction.

a. **What is the specific purpose or goal that will be achieved by the funds requested?**

Participants will receive a Kosher meal at the DPJCC and the Daniel Cantor Senior Center and the Daniel Cantor Adult Day Care/Alzheimer's program.

b. **What are the activities and services that will be provided to meet the intended purpose of these funds?**

Participants receive a nutritious Kosher meal five days a week (Monday through Friday), excluding holidays. Classes, support groups, topical speakers, live entertainment, and volunteer opportunities are provided with these funds.

c. **What are the direct services to be provided to citizens by the appropriations project?**

Participants receive one Kosher nutritious meal five days per week (Monday through Friday), excluding holidays.

d. **Who is the target population served by this project? How many individuals are expected to be served?**

Services will be provided to elderly individuals 60 years of age or older.

e. **What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?**

The outcome is that 66% of the program participants improve their nutritional status as measured by the Nutrition Score portion of the Uniform Client Assessment.
