4. Project/Program Description:

Project Liberty in Orange County, is a victim-centered, trauma-informed, and multi-prong service center for Human Trafficked (HT) individuals between the ages of 12-21 residing in the Central Florida area. Project Liberty facilitates strength-based choices while building autonomy, self-esteem, and wholeness so that every individual may become productive members of society. Project Liberty is the only facility of its kind in Central Florida that works directly with Law Enforcement to provide a temporary and safe place of refuge for minors and young adults whose crime may be that of victimization and not warrant incarceration. Law Enforcement can bring identified victims to the gated drop-in center 24 hours a day for intake, therapeutic counseling, case management, care coordination services, education and intervention services, social support services, referrals, and for short-term respite care (up to 23 hrs of stay).

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

To provide a safe place of temporary refuge for youth human trafficking victims (HT); so they can remove themselves from a commercial sexual exploitation situation as an alternative to incarceration. Our goal is to service up to 150 youth/citizens. Youth who are identified by law enforcement, DCF, or other governmental entities as HT shall be enrolled. In addition, workshops, conferences and trainings will be conducted tri-county wide on HT prevention and intervention strategies to the community (i.e. parents, law enforcement, government, schools, private and public sectors).

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Project Liberty will expand its services with these funds and will provide additional case managers, therapists, and a crisis intervention specialist to support the demand for the following services: Case Management and care coordination, mental health services, social support services, family support, and community education/training for parents, teachers, etc.

c. What are the direct services to be provided to citizens by the appropriations project?

Citizens who seek services with Project Liberty will receive the following direct services: Access to respite services up to 23 hrs; Intensive case management including assessment of needs and individualized service plans; Mental Health evaluations and therapeutic counseling; Life skills; Clothing, food and basic necessities; Documentation assistance (i.e. birth certificate, ID); Crisis intervention support/mentoring; Care coordination for housing, medical, dental, and legal referrals; Family support and reunification; and Prevention education workshops and strategic training for parents, schools, government, public and private sectors.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes the youth and young adults between the ages of 12-21 who are victims of crime, may have poor mental or physical health, homeless, low-income; and the general community (i.e. parents, teachers, public and private entities, government, law enforcement, faith-based organizations, etc.). We anticipate serving 150 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit or outcome of this project is to: increase community safety by providing a safe place for victims of crime or at-risk youth who have been identified as human trafficking (HT) victims a temporary place of refuge; to increase early access to mental &health services such as substance abuse treatment rather than incarceration when it is not in the victim's best interest; and increase community awareness of prevention and intervention strategies to reduce the incidences of HT among youth/young adults. By projects end, 80% of project participants will have successfully accessed and participated in services (i.e. mental health); increased in self-efficacy; and increased in knowledge about HT and reduction strategies; Outcomes will be measured by pre and post surveys, interviews, referrals forms, and surveillance data.
