Lee County's government communication network, a land mobile radio system supporting more than 8,000 users, is in need of replacement and migration to a new digital radio network. The radio network replacement will expand capacity, improve reliability, and integrate with other local and state emergency providers by using new equipment and system design strategies, making it more resilient during disasters and large-scale emergencies. The existing system can no longer be supported by technical support and equipment replacements.

Replacement of the county's existing analog radio network with a new digital radio system, including design features to expand capacity and improve resiliency during disasters.

Replacement of the existing analog hardware with new equipment, as well as improvements to data back-haul and redundancy at remote tower sites.

Those individuals that require emergency assistance, which includes the county's resident population of more than 700,000, plus more than 4 million visitors each year.
