Health Center). Improved mental health because of participation in on-going treatment as determined in the Psycho-social Evaluation and outlined in the Treatment Plan. Creates immediate job opportunities and vocational services for youth 16 and older who are not enrolled in school and are actively seeking employment. Also reduces recidivism by providing services to these children and ultimately diverts these children from the criminal/juvenile justice system.
