4. Project/Program Description:

The City of Lake Butler operates a Wastewater Treatment Facility (WWTF) that is located at the Florida Department of Correction's Reception and Medical Center (RMC) in the southwest part of town. Currently, the City of Lake Butler produces an average of 225,000 GPD of wastewater, and FDC pumps an average of 500,000 GPD of wastewater to the City's plant. With normal wastewater treatment demands, this volume of influent puts the plant at its treatment capacity and causes capacity exceedance when heavy rains occur. The existing WWTF property has sufficient adjacent land for the construction of a new WWTF.

A new WWTF would be constructed adjacent to the existing WWTF, and to the extent possible, parts of the old plant's tankage would be re-purposed and incorporated into the design of the new treatment process for flow equalization, sludge thickening and sludge digestion. The new WWTF would also be designed with the capability of expansion.

a. What is the specific purpose or goal that will be achieved by the funds requested?

The current WWTF serves both the City of Lake Butler and RMC Correctional Facility is at and often over capacity,. the funds will be used for planning, design & permitting for the construction of a new 1 MGD Wastewater Treatment Facility (WWTF) with Advanced Waste Treatment (AWT). The new WWTF with AWT will reduce nitrogen and phosphorus content in treated effluent discharged to surface and ground water resources and make reuse water available to the adjacent prison.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Planning, design & permitting for construction of a publicly owned 1.0 MGD wastewater treatment facility with Advanced waste treatment to serve the City of Lake Butler and the RMC Correctional Facility

c. What are the direct services to be provided to citizens by the appropriations project?

The existing WWTF is operating at full permitted capacity. Recurring backups and overflows are becoming more frequent and the existing WWTF has difficulty managing peak influent flows. Additionally, the lack of capacity is placing a severe restriction on attracting economic development opportunity to the City.

d. Who is the target population served by this project? How many individuals are expected to be served?

The citizens and businesses of Lake Butler as well as RMC inmates and staff. The City serves more than 2,000 residents within and just beyond the city limits. The WWTF services the City residents and more than 3,000

incarcerated individuals at the Reception and Medical Center (RMC) that also employees approximately 900 staff.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project seeks to improve surface and aquifer water quality by meeting AWT standards. The advanced waste treatment and the elimination of overflows will reduce the potential for groundwater contamination and protect the public from water borne contaminants in private potable water wells.
