1. Title of Project: Pompano Beach - Fire Station 52 Replacement Project

4. Project/Program Description:

Replacement of 41-year old fire station servicing Palm Aire and Collier City. Fire station services the SW area of Pompano Beach, a densely populated area with a mix of African American, Latino and elder population. Facility has inadequate ADA accessibility to firefighters. There are no separate quarters for male and female firefighters. Bathrooms are outdated. Building ventilation does not meet current standards. Plumbing is inadequate and frequent sewage overflow is found in the showers. Layout is inadequate to provide first class service. Pompano Beach's Fire Department is ISO Class 1 certified. Only 0.5% of the Fire Departments in the country have that distinction yet facilities like Station 61 are obsolete. Department responds to over 31,000 calls every year.
