11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal of the funds is to build a new facility for our health education programs that will replace an old and outdated facility which will soon exceed its life expectancy. This \$56 million project will greatly impact our ability to provide quality programs and to also increase and expand those programs especially those with extremely limited capacity. We are requesting \$11 million this year and will subsequently return for funding for the next two years for \$11 million for a total of \$33 million out of \$56 million from the Legislature.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Dental Hygiene Services and Funeral Services (via Pinellas County Medical Examiner's Office) will be offered on site. The Dental Hygiene Clinic program will serve approx 11,000 community members each year. Additionally, the Funeral Services program will perform embalming and coordinate crematory services for Pinellas County indigent populations. Simulation Center and library services will be available for health and medical professionals in our community to advance their clinical skills.

c. What are the direct services to be provided to citizens by the appropriations project?

The Health Education Center serves as a centralized campus for all-inclusive healthcare training and education for citizens interested in pursuing the industry for high-wage careers. The SPC Funeral Services Department coordinates activities to work with deceased citizens to embalm/cremate. Dental Hygiene serves up to 60 patients per day with discounted cleaning services, X-Rays, Patient Education,& referral services. All clinical health programs have community component to engage in community.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is vast and includes: elderly, mentally ill, unemployed, economically disadvantaged, high school students, university and college students.
