**1. Title of Project:** Gulf World Marine Institute - Marine Animal Rehabilitation and Necropsy Facility

**4. Project/Program Description:**

Gulf World Marine Institute, Inc. (GWMI) is a 501c3 non-profit organization that is permitted by National Marine Fisheries Service and Florida Fish and Wildlife Conservation Commission to perform stranding response work. GWMI rescues, rehabilitates, and releases stranded, sick, or injured marine mammals and sea turtles along the Florida Panhandle coast. This project has two goals: (1) to replace our 30 year old facility in order to enhance and expand existing response and rehabilitation capabilities, as well as add a much needed necropsy building and (2) to create space for new public information and research programs for stranded marine animals in the Bay County and northern Gulf of Mexico area.

This will include one building for sample processing, veterinary procedures, public and school education programs, research and administrative activities, and an additional building to serve as a sorely needed separate necropsy lab.	700,000

#### 11. Program Performance:

##### a. What is the specific purpose or goal that will be achieved by the funds requested?

(1) Replace our current 30 year old building by constructing a new 4,400 sq ft facility and adding a separate 1,100 sq ft necropsy lab. (2) Create space to disseminate new public and school information and provide additional space for research programs related to the stranded marine animals in Bay County and the northern Gulf of Mexico. These goals will provide new capabilities to accomplish our missions of stranded marine animal

rescue, rehabilitation and release, and education. Our conservation research will be shared with networks partners, including research facilities, NMFS and FWC.

**b. What are the activities and services that will be provided to meet the intended purpose of these funds?**

The new facilities will be designed, constructed and equipped with the necessary tools for our work. We will also implement a new research program that will allow us to gather important and beneficial dolphin behavioral and habitat information that will be provided to appropriate governmental and research agencies.

**c. What are the direct services to be provided to citizens by the appropriations project?**

Gulf World Marine Institute will fulfill our authorized responsibilities through the response, rehabilitation, and release of stranded marine mammals and sea turtles, and through the dissemination of information via educational programs for our public schools and the general public with regards to conservation. Finally, this project will allow us to expand our response capacity. All of the data from our programs will be shared with the conservation research community as a whole.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

The target audiences of this project include researchers interested in our data collected from local marine animal populations; we will be able to provide space for visiting researchers that was not previously available. Local public school groups and other organizations interested in learning more about our work will be able to visit the new facility. This is an important outreach opportunity that has been requested in the past, but has not been available. Finally, we will target the audience of conservation-minded people, especially those interested in the protection and preservation of endangered species.

**e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?**

The implementation of this project will result in the increase of GWMI's capacities to fulfill our responsibilities towards the missions of stranded marine animal rescue, public education and conservation research. We will actively document the number of individuals impacted by each event, including stranding responses, releases, and scheduled educational events, and compare those values over time. The project will be deemed successful with increasing numbers of people that we have influenced. Every piece of invaluable data we collect improves our knowledge and ability to protect these animals in their natural environment. Additionally, GWMI is reviewed annually by FWC and NMFS, and their continued feedback will document our effectiveness and success as a program.
