4. Project/Program Description:

A priority of the City, this funding would provide for construction of a 24,000sq. Ft. public safety complex to allow for localized police services in our historic district. The city is physically 14 miles long and 2 miles wide. Currently there are police stations in the center and West end of the city. The facility will be constructed specifically to provide enhanced access to public safety services for the community at large. The substation will provide direct services designed to benefit the community such as enhanced police presence in an area suffering from crime rates higher than other parts of the city, and enhanced access to police personnel for those who may experience transportation issues in accessing farther police department locations. Additionally, the project would include a community room specifically designed to promote community engagement for civic groups such as neighborhood watch.

a. What is the specific purpose or goal that will be achieved by the funds requested?

Funding will provide for the construction of a 24,000sq. Ft. public safety complex to allow for localized police services on the East side of the city, in our historic district. The city is physically 14 miles long and 2 miles wide. Currently there are police stations in the center and West end of the city. The facility will be constructed specifically to provide enhanced access to public safety services for the community at large.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Funding will provide for the construction of a 24,000sq. Ft. public safety complex to allow for localized police services on the East side of the city. In addition to all police work, the department's Preventing Repeat Incarcerations through Monitoring and Enforcement (PRIME) Unit will be housed in this new facility. This will allow families from this neighborhood to have increased access to the PRIME officers and allow the department to express its investment in the families in this particular area of the city.

The substation will provide direct services designed to benefit the community such as enhanced police presence in an area suffering from crime rates higher than other parts of the city, and enhanced access to police personnel for those who may experience transportation issues in accessing farther police department locations. Additionally, the project would include a community room specifically designed to promote community engagement for civic groups such as neighborhood watch.
